Box 37 Sterling, MA 01564 (508) 499-6292 ROBERT PICKLE, PRO SE 1354 County Highway 21 Halstad, MN 56548 (218) 456-2568 This Court's August 19, 2009, order set forth Defendants' obligation to inform this Court every sixty days of the status of motions below that impede the progress of Defendants' appeals here. Defendants therefore file this status report.

On December 9, 2009, Defendants moved the lower court to forward to this Court documents produced by MidCountry Bank ("MidCountry") ("MidCountry records"). (Record on Appeal Docket Entry ("RA") 204). The MidCountry records had been filed in the lower court by order of the District of Minnesota. (RA 63-36 p. 2¹; RA 231 p. 7). Also on December 9, 2009, Defendants moved this Court to "hold in abeyance … Defendants' appeals until this Court receives a certified supplemental record from the district court consisting of a copy of the MidCountry records."

After being informed by the clerk of the lower court that the court no longer possessed copies of the MidCountry records, and after being informed by Plaintiffs' counsel that Plaintiffs were in possession of those records and would not return them, Defendants moved the lower court to compel Plaintiffs to return those records to the lower court, and to stay the lower court's yet unexecuted order to return those records to MidCountry. (RA 210; RA 141 p. 13).

Defendants' motions below were referred to the magistrate judge who, on January 29, 2010, denied those motions without comment. Defendants

subsequently filed objections to those orders on February 3, 2010. (RA 229).

Defendants' objections to the magistrate judge's orders are still pending in the lower court.

Defendants continue to request that this Court hold Defendants' appeals in abeyance until the MidCountry records are forwarded to this Court as part of the record on appeal, properly certified pursuant to the Federal Rules of Evidence.
