perjury, based on his own personal knowledge and information:

- 1. Attached hereto as **Exhibit A** is the letter the clerk of court sent Defendants regarding Defendants' complaint about court staff misconduct. Since that letter had been cc'ed to three judges (p. 3), one being the judge newly assigned to the lower court case, my reply to the clerk was also cc'ed to the very same three judges. (Lower Court Docket Entry # ("Doc.") 244 p. 2).
- 2. We frankly prefer that these letters not be part of the visible public record, since the judicial system appears to prefer that such complaints be kept confidential. However, a clerk for the newly assigned judge docketed our reply to the clerk of court. (Doc. 244). Upon our immediate inquiry, we were told that we had to file a motion to seal in order to make that now-public reply non-public.
- 3. In Plaintiffs' response to the instant motions, Plaintiffs for the first time refer to our reply to the clerk of court as being "an *ex parte* letter to the District Court indicating that they had now accused the courthouse staff," a letter "delivered" on "March 18, 2010." (p. 6). The existence of such a complaint by Defendants had been a matter of record since February 3, 2010. (Doc. 230 p. 1). To prove that Defendants were merely cc'ing the very same judges the clerk of court had already cc'ed, Defendants now regretfully file Exhibit A.
