Re: Apparent Violations of Separation Agreement

Dear Linda,

It is with concern and regret that I write this letter, but your recent actions leave me with no real choice. As you know, your Separation Agreement with Three Angels specifies that neither you, nor your agents, nor your close friends would make public statements critical of Three Angels or its employees. We believe that this commitment has been violated in a number of ways. These include

- 1. Your letter on your web-page indicates that your separation from Three Angels was a time filled with "untruths," "accusations and condemnation." The only persons referenced in the letter are your husband, "one close to" you, and by implication the Three Angels leadership and board. Taken together, these statements are an obvious criticism of the way your case was handled by Three Angels leadership. This is a clear violation of your separation agreement.
- 2. A recent article published by Adventist Today contained information and claims that could have only come from you and/or those immediately around you. References to a "coup" at Three Angels, and a detailed report of your denials and justifications could have only originated with yourself. We ẫalso have information that you gave AT an in-depth interview, so you were very aware of the stories that AT would be running. This is in violation of your Separation Agreement.

- 3. Johann Thorvald continues to circulate letters which gives highly misleading accounts of events at Three Angels. You are close to Johann, and we will hold you liable for what he continues to send out, as we believe that you could request him to cease. His failure to do so constitutes another breach of the Agreement.
- 4. We have very good reason to believe that you have obtained and are using a copy of some or all of Three Angels' mailing list. This list is proprietary information of Three Angels, and it is illegal for third parties to appropriate and/or to use it. We believe we know who perpetrated the theft of this list, and we will pursue all available remedies against that person. But you should also know that the use of that list is a violation of the laws, even if you did not steal it. We hereby request that you stop using it for mailing your letters and e-mails.

Linda, we would like to honor the Separation Agreement. Unless, however, you cease and desist from all of the above actions, we will not be able to follow through on the remainder of the payments. At the next board meeting in January, I will be presenting the above issues to the Board. Unless there is a decided change in all these areas, I am quite sure that the Board will vote not to make any fu rther payments to you. This would represent a loss of \$150,000 to yourself.

I do not enjoy writing these things to you, but your insistence on defending yourself in the court of public opinion leaves me no choice. You had every opportunity to defend yourself to the fact-finding committee and the board, but you chose not to.
