Well with that type of logic you would have to say that Mr. Duffy's letter to Mr. Joy was blackmail. After all, it demanded that Mr. Joy cease posting on save3abn.

[NOTE: It is not my position that Mr. Duffy attempted to blackmail Mr. Joy. I am simply pointing out your logic.]

Rather than blackmail, I see it as Mr. Joy agreeing to the demand of Mr. Duffy. In essence, Mr. Joy has said: O.K. We will stop posting as you ask, if in return you do That is not blackmail. that is negotiation.

Is negotiation blackmail? Well, look into the legal history of the law firm that Mr. Duffy represents. You will find that the firm that Mr. Duffy represents has over its history negotiated a lot of settlements that were never taken litigated to a decision by a judge (Of course the negotiated agreement may have been entered by the judge as a decision.). You will also find that his firm has a reputation in the legal community of negotiating settlements, at least when certain of its lawyers are the lead attorney in a case. (This is not true for every one.) That reputation is seen as a positive one for the firm, as it reaches a settlement, while saving the client legal fees.

On another note of interest: A statement that a law firm has never lost a case can only be made by a firm that negotiates a fair amount of settlements. Any law firm with a fair amount of cases, and that has been in business for some time, will lose some cases eventually, unless they negotiate. Negotiation is seen in the legal community as being reasonable.

FYI: Folks, for people who know how to obtain the information, a lot of information is available regarding lawyers and law firms as to how they conduct their business and/or litigate. That knowledge is always helpful to people on the other side. That information does not always come from Martindale.

NOTE: For the record, the legal community considers the firm Mr. Duffy represents to be ethical. As an ethical legal firm, it would not engage in blackmail, or in any other unethical (or illegal) practice. As would be expected for a firm of it's size, it has greater competence is some areas of it's practice than it does in others.

After comments made by a poster in another thread regarding the State of Illinois tax exemption case, I decided it was time to read it for myself.

There were a couple points that I think were of interest to some of the above discussions which for some reason neither of my browsers will let me quote at the moment.

First. In the decision, the ALJ stated at the bottom of page 7 (item 16) that "Danny Shelton founded applicant in 1984". No such comment is made regarding Linda in the next item at the top of the next page. The decision refers to transcript pages of what must have been a hearing. I do not know if this was an accurate statement of the facts presented or was a point made at hearing.

It is also correct that 4 people signed the incorporation documents and were listed as directors (which would have been to comply with the law regarding creating the legal entity). However, this would not be synonymous with the concept of "founder" as used above.

I also thought it was most interesting that the ALJ made the following statements:

"This case is not about applicant's beliefs, contrary to what was asserted consistently at the hearing....."

and

"The case is also not about whether or not what the applicant is doing is good for people. "

Reading the case and how the ALJ viewed the "religious" activities of 3abn as contrast to how the typical SDA may view the same activities was enlightening.

Sorry, but I respectfully disagree. There most certainly does not "have to be" a budget. I don't think you are understanding the true meaning of the term "budget":

budg·et /□b□d□□t/ Pronunciation Key - Show Spelled Pronunciation[buhj-it] -noun

- 1. an estimate, often itemized, of expected income and expense for a given period in the future.
- 2. a plan of operations based on such an estimate.

An individual, a family unit, a church, a corporation can easily have money coming in and going out without any type of logical plan for the use of the resources. A budget process assesses what is expected to come in over a given period of time and what is expected to be spent, AND ON WHAT, over that same period of time. A budgeting process is a carefully determined plan as to how resources are to be used. When a true budget is prepared and implemented, what actually happens is then compared to what was budgeted. This is a basic internal control.

Well, not sure where your're from, but here, with the several multi-multi-multi-million dollar municipal organizations I work for, the first thing the auditor asks for is the minutes of all financial board-approved transactions. Then They ask for the budget. They "study" both of these. Then they ask for the reciepts, bank statements, checks, payrolls, etc. etc., including contacting venders at the other end. Our organizations are required by law to have a balanced budget. Everything has to square up, sometimes every line item--if so earmarked. At the end of the audit, certain officers meet with the auditors and we listen to their final reports and recommendations.

Like I said, I'm not sure what rules apply to NFP organizations like 3abn, but, I can't imagine the state wasn't the lead agency in the audit report referred to in the PDF file noahswife linked. Could be wrong though. This was a challenge to state and federal laws that regulate the organization. Auditors can be anyone from anywhere though--independent, working for gov't by contract, or actual gov't employees. Our team of independent auditors are always accompanied by a state rep that oversees the process.

But, you're right. It's all beside the point. I was just responding to your general statement that budgets don't get audited. They do here!

You'll have to forgive our good attorney, Lee Boothby, an experienced litigation and appellate court lawyer, who wrote that *Liberty* article in 2003, the year before the judgement was handed down to 3abn. The Case Law he cites obviously was rejected, and in all fairness, he never got a chance to read Judge Barbara Rowe's Recommendation for Disposition, and the *even more* pertinent Case Law cited at the hearing. I think Rowe summarized it best in 2004 by saying...

"Were I to recommend a grant of tax exemption for the majority of the property at issue, which is clearly a commercial enterprise, it would give applicant an unfair commercial advantage over other commercially owned and operated radio and television stations."
