### An Open Letter from Carol Shelton

Like my husband, I have been reluctant to tell my side of this "sad story" as your pastor called it as he expressed "his opinion" of our lives and our hearts in the open letter to you a few weeks ago. My husband did not ask me to write this, nor did he give me the words to say—I have a mind of my own-though some may think I'm manipulated and deceived. I am speaking now mainly because of the extensive damage this whole situation has done to innocent people all over the world; to 3ABN, to the whole Shelton family and because of the confusion and pain many of you are going through. I have written to your pastor expressing my concern for how he has handled our lives and our hearts. More in regards to that letter will follow. I also write this because I live with Tommy and know he has always had a heart to serve God, to show love to others and would never intentionally harm anyone. I write this for myself only because what has been inferred about me will no doubt harm my Christian influence for years to come. I want a restoration and healing for everyone concerned in this "sad story"

Proverbs 18:17 says, "He who states his case first seems right until his rival comes and cross examines him." Then, Prov.18:13 says, "He who answers a matter before he hears the facts, it is folly and shame to him (to give judgments before hearing the whole case and express an opinion)." Amplified Version.

So, I state my case in "my sad story" and Tommy will state his case through his letter. Since we weren't the first to state our case and you didn't get all the correct facts, I hope you will love us enough to listen to "our side of the story." I would hope that you would listen with an open mind and heart—I know those of you who really love us will.

First, let me say that Tommy nor I have the mind-set or heart to have an attitude of wanting to "make him pay" toward Bro. Glenn, though he has hurt us and our family immensurably. The Lord said," Vengeance is mine, I will repay". I'm sure all of us could give the testimony that God has been true to His Word concerning any disobedience in our lives. He has His own special way of correcting us, but I believe He usually does it with as much compassion as possible for everyone who will be affected. Humiliating and shaming a person can never cause a true repentance but tends to drive them further into themselves to deal with their own alongness. And the shame digs deepest when it's our own people who reject us and shame us because they feel shamed by us. Grace is the gift God gave us so that we could give it to others; grace says you are accepted before you become acceptable. Unconditional love and mercy draws us to God and each other. A spiritual person will seek to restore a person they feel has fallen, a religious one will destroy, whether intentional or not. Galatians 6:1 says:" Brethren, if any person is overtaken in misconduct or sin of any sort, you who are spiritual (who are responsive to and controlled by the Spirit) should set him right and restore and reinstate him: without any sense of superiority, and with all gentleness, keeping an attentive eye on yourself, lest you should be tempted also." Amplified version.

In response to Tommy's open letter, one man replied he hopes Tommy will handle everything with grace and dignity. We feel that we both have responded to Bro.Glenn's lack of gentleness and desire for restoration and reinstatement with grace and dignity, but he's the one in need of both qualities toward us. Since he and others feel we're both such horrible sinners, why has he never come to us to offer a helping hand? He won't even respond to my questions I sent him in an e-mail. I feel like David must have felt

when he said, "I would rather fall into the hands of an augry God than into the hands of man." Our whole family has fallen into the hands of a mob-like spirit whose apparent goal is to destroy us in one way or another.

Whoever wrote that book Bro. Glenn quoted from could have no real comprehension of God's love or grace. To say, "we must dignify someone by making him pay for the evil actions he commits and we show him respect by making him accountable" in no way sounds like someone who is giving us "grace and peace" as Bro. Glenn professed to you that he desired for us. His lack of compassion toward us has never lined up with his words expressed to you of how he loves us and requests prayer for us. At least, these are our feelings and our oplnion, and I'll base some of it on what I continue to say.

As some of the board members can tell you, I have recently written a seven page e-mail to Bro. Glenn asking him some questions concerning his conduct toward me personally, and toward Tommy. I believe I wrote him with respect, love and grace, sincerely requesting a reply to many things I didn't understand. I was hoping for healing through some sort of dialogue, since he has never contacted us to talk with us personally in any effort toward restoration concerning the accusations against us. I told him I didn't consider us enemies and believed the real enemy is the devi l. He's the one who wants to "kill, steal and destroy" and wants to use us against each other for his purposes. In my letter, I also said that nothing I had to say was said in judgment or condemnation, but felt God would have me express to him what I saw in him—ways that I felt Satan was deceiving him to destroy his ministry as well as ours. I asked him to try to put himself in our shoes and try to feel what we were feeling, in other words, "do unto others as you would have them do to you." I asked to hear from his side of the story, and asked him twice to feel free to tell me if I had in any way offended him, because it's only by seeing the truth about ourselves that changes us into the image of Christ.

In about five days, Bro. Gleon sent me a nice card, with these words hand-written to me: "Dear Sister Carol, I did receive your letter e-mailed yesterday. I will not be replying further to it. We continue to hold up you and your family in our prayers. Brother Gleon.."

My feelings were that I would rather he respect me by answering my sincere, heart-felt questions than say he was praying for me. So, since he didn't answer them, I am sending some of them on to you, so that you might possibly see a little more clearly my side of this "sad story." Also, I was told that some of you had a few of the same questions. Here is what I asked him:

1. Why wasn't Tommy given a personal invitation to take part in the Woods' anniversary celebration there? We felt he was slighted, largely because of what you must have said. Is that true? And if so, why?

I didn't tell Bro. Glenn this, but Tommy was deeply hurt, as he had only received a general invitation like anyone else would have—with no special respect like a former pastor should have had, (in our opinion) Possibly, no hurt was intended, or he had nothing to do with it, but why no explanation or response?

- 2. Why was our names omitted in the 2002 church directory, while the names of every other pastor associated with the Dunn Loring church were published? Was that also because of your opinion of us? It appears to us that someone didn't want anyone from there calling us or loving us. Was it you? If not true then, it appears to be true now.
- 3. Remember when a young couple from your congregation in Ezra called Tommy

for counseling while we were at Dunn Loring? You apparently were offended at them and Tommy, because you called Tommy and told him not to counsel with them anymore. Would you rather they not get help with their problems than to call on us? God did use us to help them both, so, at least God didn't see the wrong in what any of us had done, and pleasing God is what matters the most.

- 4. I will shorten this question from the original letter I wrote him, but this is the essence of the hurt experienced. Brad, Valerie and I visited his church at Ezra shortly after we moved to KY. He didn't acknowledge that we were there, until during the prayer request time when I raised my hand, then he welcomed us. I felt since I had been the pastor's wife for 18 years at that church, he should have at least shown me the respect he would have shown any pastor's wife who came there. Also, while there, an older lady whom I had loved dearly refused to hug me when I attempted to hug her. But, after Bro. Glenn left that church, she sent us a Christmas card, and seemed her old, friendly self. I wanted to know why that would be? But still no response.
- A very big hurt to me was when Sis. Lucy went to him upset because he had sent the tape of accusations from Ezra to many churches (in 2001) She asked him why he didn't at least speak with me first, he said, "because, in my opinion and estimation, Sis.Carol's words are not credible concerning her husband's situation." Sis Lucy and I felt like he was calling me a liar, because that's what not credible means, my words aren't believable. I wrote Bro.Glenn a letter this past December asking him, "Whatever gave you the right to make that judgment of me?" Then I said. "It had to be from listening to what others had to say; people who had no idea what I was going through in my mind, heart and soul. It was a time in my life when I was dealing with the accusations against Tommy, the hurt of friends forsaking me, the confusion, my chronic depression, along with my own insecurities and hurts from my own childhood wounds. Yet, all through the situation. I didn't lie to anyone." This was Bro.Glenn's reply to my expression of the pain he caused me by judging me: "Sister Judy and I met with Pastor Tedrick at her request. During the course of our time together, she asked a question which elicited my estimation of your credibility. With hesitation I responded to Paster Tedrick that I had reason to question your credibility as it relates to matters involving your husband. I did not call you a liar nor did my sentiments then nor do they now permit the use of such strong language. I regret the pain you have suffered as a consequence of this miscommunication. In our Lord's service, Brother Glenn."

In this recent seven page letter to him, I said, "I know you replied to my letter I wrote you in December, but felt like there was no use to say any more, because I felt you skirted the whole issue. It seemed you blamed Sis. Lucy for having the meeting, asking the question, and misrepresenting your statement. The regret for the pain I suffered as a consequence of the miscommunication didn't seem like any kind of an apology for what you had done, but what she had done. My pain was from you saying my words weren't credible without asking me anything about the situation—everyone's words were true and believable, except mine. Since Bro. Keith is Chairman of the CAB, I sent him my letter to you, along with your response, hoping that he could give me some insight into what else you might be saying, because sometimes it takes another party looking

on to see more clearly."

I had many more questions for Bro.Glenn that were still left unanswered, but they were more of a personal nature, so I won't write them here. Maybe someday he will at least show me the respect to try to answer them.

At this point I would like to share what I believe Jesus' attitude was about sin. The sinner was always confronted in love, not shamed, and told to "go and sin no more." His unconditional love changed the woman caught in the "very act" of adultery. The law said to stone her, and many took up stones to do so, but Jesus said, "You who are without sin, cast the first stone." Man tends to categorize sin into "little sins" and "big sins", but in Scripture, I don't believe Jesus was any more upset with the "big sins' in our eyes, than He was at the "little sins" of judgmentalism and the attitude of most of the Pharisees who said in their hearts, "I thank God I'm not as other men." If we would all be honest, we could all probably admit to that attitude at some time in our life when people have hurt us. We can't comprehend them doing it, because we never would, but it's only because we don't have that particular weakness. We so convince ourselves of that fact, that we can't see the sin in our own life and how we have hurt, maybe even that person we're condemning, with things we have done.

Any of you ladies who came to my meetings where I shared what I had learned concerning emotional healing, may remember what I taught. I said that God had taught me through a very hurtful experience that "if I were that person, I would do exactly as they have done to me, because I would be that person. I would have their same parents who had not met all of their needs, as no parent can; I would have their same life experiences, and I would have their personality weaknesses." God showed me what real, unconditional love and grace was when He quietly spoke that truth to my heart when I was experiencing anger and judgmentalism toward someone who had hurt me. That was in 1990, and because of God's grace to me, He has enabled me to give that same grace to everyone who has hurt me since that time, (including Bro.Glenn). It never excuses anyone's sin, or the need for loving confrontation, but it takes away the condemning, self-righteous spirit that can so easily be found in all of us.

The counselor also told me one of the most important truths concerning relationships with others that I've ever learned. I was so angry at how people had treated me, all I could see was they needed help. The counselor said, "the truth is, the only one you can fix is yourself through allowing God's love to change you inside, when you do that, your Christian attitude will begin to change others." It's only unconditional love that will draw others to Christ. I have found there is victory, comfort, and peace in knowing people don't have the power over me to make me hate them; it's my choice and my responsibility alone, no-one can do it for me. Yes, people have made me angry when I see them hurting those I love, but grace has enabled me to "not let the sun go down on my anger", nor even expect them to apologize before I will love them.

God has protected me from what most churches believe to be the "big sins". I've never smoked, drank alcohol, nor committed fornication or adultery; but I have committed a big sin in God's eyes because he said if we hate, it is as if we have murdered. Because I hated myself I couldn't have God's love or acceptance toward others. Before I had counseling, my attitude of selfishness, pride, anger, criticism, and judgmentalism, and my chronic depression caused me to hurt those I loved the

most and everyone around me. I had a deep heart's desire to love God; I wasn't "living in sin"—I was going to church, paying tithe, reading my Bible, even fasting, but those "feelings" were still inside if someone didn't act the way I wanted them to or hurt me in some way. The Bible says, "My people are destroyed for lack of knowledge". I was almost completely destroyed, but God delivered me!!

It just occurred to me that this whole scene of those who are trying to prove to church people all over the world that the whole Shelton family are the "biggest sinners" of all is really funny. Because, as for myself, I agree with them, because I agree with Paul who said "I am the chief of sinners", and I've never heard any of the Shelton's say they have never sinned, nor have I seen a haughty attitude about how "good" they were. If we have the attitude of Paul, we won't have to prove to anyone that someone else is worse, because we are the chief of sinners. If everyone else is the little Indian, they don't bother the chief. God isn't surprised that we're the chief of sinners, He told us we all were to consider ourselves in that way. The problem is—that too many seem to have the Pharisee's attitude and "thank God they are not as other men." I think we might all be in the same boat. I don't take sin lightly or the damage it does to others, because I totally see the damage my "little sins" have done to everyone around me, and so also to the cause of Christ.

If someone decides I'm like the scum of the earth that judgement of me doesn't make it so, because they don't know where my heart is with God. That's their problem not mine, and only God can fix it as they allow it. And if that person decides they no longer want fellowship with me, then they can let Satan steal their joy of having one less person in their life to love — but as for me, I will love them anyway. I don't love and accept to the point that I don't have the courage to confront someone who is hurting themselves and others.

Your pastor has accused my husband of being at the present time "a sexually immoral individual". That's a pretty judgmental statement for any one to make about someone they haven't spoken with except for a two minute phone conversation in the past six years. And that conversation was because Tommy called him begging him to listen to what he had to say, but Bro. Glenn refused to listen, except on his terms before his board at Ezra. I'm sorry, but I can only feel that he's out to hurt us because of his lack of compassion. It doesn't mean he hasn't shown compassion to others, I'm just saying—to us, he has not shown compassion.

Bro.Glenn said on the tape that "someone who has been victimized is a likely candidate for continuing the victimization." I wonder if he has ever asked the accusers if they have ever had counseling? And, did he consider it long enough? Is he just as concerned about them being in the will of God and making sure they have the opportunity to repent if they're not living according to Biblical standards? I believe we've all been victimized in one way or another. It's our own responsibility to get the help we need and not blame others for our pain. I took my responsibility over 17 years ago, on my own, with no help from anyone, and I continue to take it, most of the time feeling only God understands me—I know that only He can help me. No one is at peace with God with anger and revenge consuming them. Apologies won't change their hearts—only true repentance for their own sins will comfort them.

Most Christian counselor's would advise the angry person to write a letter

expressing their anger to the one who has hurt them in order to get the anger out, but not send the letter. Then later, write another letter expressing your hurt, and mail it to the person. I would extend that invitation to any one who has anything against me, instead of writing on the internet what they feel I have done, without speaking to me first. However, the truth still stands: my sincere apology for any hurt will not take away their anger, unforgiveness, or pain—only giving it to God will heal anything. We all attempt to change the past by our actions, but it will never work

I'd like to ask Bro. Glenn where he thinks all of my family will ever get the apology's due them for all the slander all over the world? Are we not expected to just let it go and forget about it as though it never happened? We'll have to, won't we? because we'll never meet the thousands who believe the worst of us, because they're just like he in judging our life and our heart.

I feel that's what Bro. Glenn did to me when he pointed every one of you to the website. (Save 3ABN.) where the "broken-hearted mother" said that Tommy had molested her son. She said that she held me just as accountable, because I guess she felt I knew all about it---if it happened, I did not know. All I know is that thousands of people all over the world now judge me guilty of something I didn't do. I've heard since she wrote, that other women, who used to be my friends, have been on that web-site expressing their opinions of what they felt I knew. There's no way all of them could know all that I knew without speaking to me and knowing what my perceptions were at the times they were reforring to. All they can express honestly are their own perceptions and feelings, of which I believe they did. I don't believe they are women who would lie, nor am I, but we all have our own perceptions. I know that I have wanted to be their friends, but apparently they don't think I'm worthy of their friendship. When I'm a friend to someone, I stay a friend even when I don't like or agree with what they're doing, even if I think it's sin and something I wouldn't do. When a friend of mine was divorcing her husband and had no grounds of adultery, I went to her and told her I felt it was wrong and she needed to consider her kids and Christian witness, but she didn't listen, and remarried. It didn't change my love and acceptance of her, even though I still think it was wrong-but since divorce is more "acceptable" in the church now-it seems alright to most. It also seems I've lost her friendship now, too, since she hasn't contacted me and no doubt knows what is going on. I guess some just think I'm too deceived or sinful to be hurt.

It's unbelievable to me that men Tommy counseled with while at Dunn Loring who had sexual sin in their life, men who he prayed with and loved un-conditionally when no one else would, that these same men would now condemn him and offer no words of comfort to him or to me or my family(nor have their wives). Men who he encouraged and never told anyone else about their failures, men he confided in and then they told others what he said that hurt him deeply. In my opinion, they have no comprehension of the grace of God, yet they can "preach the Word" and not be "made to pay" because only Tommy and I know their sin. These attitudes are the hardest things for me to deal with. And where are the apology's of these "men of God"? I guess we don't deserve any.

Yet Bro. Glean felt for some reason that he "was commissioned by God as a watchman to bring us to repentance and make us pay." It sure didn't work, because I can't repent of something I wasn't guilty of and since Bro. Glean has had basically no

contact with Tommy in over six years, how would he know what he is doing now or where his heart is with God? And if I were considered a liar 20 years ago, does that make me one today? My feeling was that he had to prove that I was a liar, since I and Sis.Lucy denied his opinion. I really can't comprehend treating anyone as he has us I get angry at him for awhile, but then, my heart goes out to him because I feel so strongly that Satan is trying to destroy him and your church, as well as 3ABN and us.

Each one of us has their own "sad story" because Satan has tried to get us all and he uses people to do it. Even Bro. Glenn has his own" sad story" of his own personal life, that I'm sure he wouldn't want plastered all over the internet. I read recently: "Satan wants us to stop fighting as soldiers of the cross, and begin fighting as soldiers of our own opinions. For then, the war turns inward, and we begin to destroy one another, instead of fighting against Satan, our real enemy." What really matters is what God's Word says about how we should behave, not what our opinions are.

The devil wants to keep us all stuck in our anger and revenge instead of allowing our pain to drive us to God. If Satan can keep us angry at each other, we can't comfort one another and be the true church His Son died for.

Now, I would like to comment on the Scriptures Bro. Glenn referred to in his open letter to you concerning Matthew 18:15-17. Of course, he said the Matthew 18;6 Scripture should be applied to Tommy. It says:" But whose shall offend one of these little ones, which believe in me, it were better for him that a millstone were hanged about his neck, and that he were drowned in the depth of the sea." My first thought was," Is Bro. Glenn referring everyone here because he wants them to think as he does that Tommy deserves a rope around his neck and drowned in the depth of the sea because little children aren't safe around him?" If he doesn't feel that—he still has been a part of the mob-like remarks going around on the internet to "stone him " and judging him as being content with his "homosexual lifestyle" They've also demanded "proof" that he has ever had a heart attack or really has high blood pressure. I'd like to know how anyone could "fake" a heart attack or high blood pressure. Someone who wants to believe something on anyone will believe it no matter how much proof you give them.

Anyway, it's my assertion that this Scripture does not apply to my husband. Bro. Glenn never explained his assertion, he just made it, and apparently expected everyone to take it as fact because he said it and felt it applied. I found in Clarke's Commentary the real reason for Jesus calling a little child to Him. It was to remind His disciples that their attitude must be that of a little child in order to enter heaven. They were wondering which of them would be the greatest in the temporal kingdom they thought Christ was setting up on earth. Jesus said their attitude needed to change to humility, and lack of prejudice; He was saying they couldn't enter the spiritual kingdom if they didn't have the mind of a child; not having a lust for power, worldly ambition, not acting superior—not seeking to be a ruler over another. And a little child is also known for their forgiving attitude and trust. Christ was saying that a child is an emblem of a genuine disciple. He said, any act of kindness done a disciple, He would consider as done to Himself. Also, whoever would act the part of the devil and put a stumbling-block in a disciples way by tempting them to sin would meet with extreme punishment (usually reserved for those committing parricide—

murder of a close relative). Verse 7 says," it must needs be that offences come; but woe to that man by whom the offence cometh!" The commentary says, "offences are referring to scandals, stumbling-blocks, and persecutions. Such is the wickedness of men that they will not come to Christ that they might have life, but desperately continue deceiving and being deceived. In such a state of things, offences, stumbling-blocks, and persecutions are unavoidable. Woe to that man—he who gives the offence and he who receives it, are both exposed to rain."

It's my assertion from this reading that this Scripture passage more clearly alludes to Bro.Glenn's problem of being involved with a group of people who are persecuting and telling lies about a world-wide ministry dedicated to mending broken people, much more than it would apply to my husband's situation. The majority of the people at 3ABN are dedicated disciples of Christ, but are being treated with hostility by those who are "deceiving and being deceived". It also goes along with what I told Bro.Glenn in feeling Satan was trying to destroy his ministry as well as ours and 3ABN. He's the real enemy.

It's also interesting to me that the next Scripture passages go right into talking about how Jesus came to seek and save those who were lost and gives the parable of the one lost sheep. My recommendation to your pastor would be( if he thinks my husband "is a sexually immoral individual,") that he move on as well into the realm of the mind of Christ and go after that "one lost sheep". There's a lot of lost sheep in the world he should be going after, instead of trying to make anyone pay for their sins. As I said, my anger comes and goes with every statement made against my husband and his family, since I live with them and feel their spirit. Hopefully, my feelings are understandable to some of you—if not—you should walk in my shoes for just one day.

I would also recommend to your pastor that he re-consider Matthew 18:15-17 as the best course of action in any other dealings with "sinners among the church". I would recommend that he allow those offended to take their own responsibility and let Jesus be their Savior and Guide and Restorer. As the Good Shepherd, he is to watch over, not be a watchman over and control his sheep and take their responsibility. I believe that had Bro.Glenn listened to my husband over three years ago when he called to talk, and followed this scripture admonition, "to go and tell your brother his fault, between thee and him alone" none of us would be experiencing all the pain, confusion, and heartache we are now. But then, he said on the tape, "My loyalty is not to a fellow minister, but to God and toward healing and helping these scattered young men." I totally understand his desire to help anyone hurting who came to him, but does that excuse his total lack of compassion toward Tommy? Why shouldn't he have had at least enough loyalty to a fellow minister to just listen to him? I can't comprehend it.

Again, Satan has been at work, he has meant it for evil, but God wants to turn it around for good to any who will allow it. All things do work together for good to those who love God and to those who are called according to His purpose. I believe He loves us all equally—no-one is any better or any worse than another in His eyes.

Disproblem is, we don't look through His eyes at each other, if we did, we'd understand, accept and love as He does. I believe, as I'm sure most of you do, that your pastor and my husband were called and anointed of God and He has used them

In counselling, one of the things that a counselor does is to confront people with how they present themselves, or to put it another way, with how they come across to others.

I may say to X: You come across to me as very angry. You may not be angry, but that is how you appear to me. I wonder of others might see you as angry, and relate to you as if you were angry. Do you want to present your self as an angry person?

Folks, many of the comments made here about people are essentially stating how someone has come across to them. It is likely that some of these people have only intended to give feedback, or to tell others how someone presented themself. It is not a judgement of a person to share how that person came across to them

It is also probable that some have intended to state that X was actually Y. So? Doing so is not necessarily sinful, and may not be a statement that X is sinful. If I were to say that X is an angry person, would I be accusing him of sn? I do not think so. Anger is an emotion. God created us with an emotional component to our very being. If I am angry, that is not sin, in my understanding of life. Now, I may act on my anger in a manner that is sinful. But, it is that act that is sinful. It is not the anger itself. God has given me the power, under the Holy Spirit, to chose not to act on my anger in a manner that is sinful.

I have refrained up to now from commenting on Carol's letter, if that is what it is. My comment now will be brief:

As I read it, I felt a lot of sorrow.

One element of my sorrow was for her, as a person, and the issues that she has had to face.

Another element of my sorrow was in how she appears, if that is her letter, to be facing those issues.

I feel compasion for her in several ways. One aspect of that is that she is a victim.

In another aspect, I would not criticize her for issues of what she knew, and when. In the impersonality of the Internet, and with no face to face interaction, I do not feel that such speculation is either productive or helpful.

In my thinking, those questions may be valid, but are better raised in a different venue than this Internet forum.

Our focus on primary individuals does not, in my thinking, require that we, at this time, attempt to cast the net in a manner to cover an area broad enough to entangle every fish that may have been entangled with a lessor degree of culpability.

To be specific, as I see things:

Focus on Danny, if you wish, but Brandy is not the major issue.


Focus on Tommy, if you wish, but his wife is not the major issue.
