That cry is in response to what they believe is the call of God, and not a response to a lynch mob.

The person who asked that question of me, simply does not understand the issues, what is going on, and what is happening behind the scenes.

But, sooner or later, as I have stated, this will wind up in litigation. It is going to get much worse before it gets better. Litigation should not be taken lightly. It will not be fun for the involved people.

I clearly believe that sooner or later a lawsuit will be filed. The first may be the one against GAJ in regard to the use of the 3ABN trademark? But, if that is so, I do not believe that it will be the last.

] Psychopathy Checklist-Revised (PCL-R)

This is a clinical rating scale with 20 items, in which both case histories and semi-structured interviews are used. Each of the items in the PCL-R is scored on a three-point $(0,\,1,\,2)$ scale according to two factors. A value of 0 is assigned if the item does not apply, 1 if it applies somewhat, and 2 if it fully applies. The two factors are: emotional detachment and lifestyle. Factor One looks for a selfish, remorseless, individual with inflated self-esteem who exploits others. Factor Two describes a lifestyle that is chaotic, antisocial and/or criminal, marked by impulsiveness, a lack of responsibility and reactive anger . According to Hare, a psychopath will score high on both factors, whereas someone with Antisocial Personality Disorder will score high only on factor two.[3]

The items are as follows:
1. Glibness/superficial charm
2. Grandiose sense of self-worth
3. Need for stimulation/proneness to boredom
4. Pathological lying
5. Cunning/manipulative
6. Lack of remorse or guilt
7. Shallow affect
8. Callous/lack of empathy

11. Promiscuous sexual behavior
12. Early behavioral problems
13. Lack of realistic, long-term goals
14. Impulsivity
15. Irresponsibility

The items are then summed in order to obtain a total score. The cutoff for psychopathy is 30 points
or greater (25 in some studies).
