Please be advised that I am one of the attorneys representing Tommy Shelton and Three Angels Broadcasting Network, Inc. The purpose of this letter is to: 1) advise the board of actions of its pastor Glenn Dryden; 2) to place the board and each individual member on notice that the actions of your pastor will not be tolerated any further; and 3) to inform the board and its individual members that all will be named as defendants in a lawsuit should the actions of your pastor continue.

I am aware of the slander and libel that your pastor is engaged in and of his efforts to encourage others in attacking Tommy, Danny, and 3ABN. Such actions are far beneath the level of Christian behavior and are legally libelous. Your pastor has used the internet to spread scandalous allegations against my clients in an attempt to harm them personally and to affect the on-going ministry of 3ABN. My clients have exercised great restraint up to this moment as others so defamed would have already sought legal redress of the situation.

Their patience is gone. Though they do not relish the thought of filing a lawsuit against the church, your pastor and all the members of the Board of Directors individually, that will be the next step. They have had enough.

Let me be perfectly clear about this. You and the rest of the board are the leaders of your church and in my legal opinion have been placed in legal jeopardy by the actions of your pastor and your willful consent thereto. Therefore, consider this a demand that you discuss the situation with your pastor and direct him to immediately cease all actions directed toward my clients. Should that not happen, the only remaining recourse for my clients is to file a lawsuit. As you know, lawsuits are costly both financially and emotionally for those individuals involved. The status quo, namely continued efforts by your pastor to undermine and defame my clients with the board members having full knowledge of his actions, will not be tolerated. It is time for the board to realize the jeopardy that exists and to direct the pastor to cease; otherwise the church and individual board members will be ensnared by the tentacles of the lawsuit.

The auditors found that 3ABN does not follow these principals. Every business should use these principals as a safe guard and a security measure. 3ABN is a corporation that has passed its 20th birthday. There is NO excuse for not following these guidelines.

NOT following GAAP should send up red flags for all to see.

GAAP

Generally Accepted Accounting Principles (GAAP) is the standard framework of guidelines for financial accounting. It includes the standards, conventions, and rules accountants follow in recording and summarizing transactions, and in the preparation of financial statements.

# Overview

Financial accounting information must be assembled and reported objectively. Third-parties who must rely on such information have a right to be assured that the data are free from bias and inconsistency, whether deliberate or not. For this reason, financial accounting relies on certain standards or guides that are called "General Accepted Accounting Principles" (GAAP).

Principles also derive from tradition, such as the concept of matching. In any report of financial statements (audit, compilation, review, etc.), the preparer/auditor/CPA must indicate to the reader whether or not the information contained within the statements complies with GAAP.

Principle of regularity

Regularity can be defined as conformity to enforced rules and laws.

Principle of sincerity

According to this principle, the accounting unit should reflect in good faith the reality of the company's financial status.

Principle of the permanence of methods

This principle aims at allowing the coherence and comparison of the financial information published by the company.

### Principle of non-compensation

One should show the full details of the financial information and not seek to compensate a debt with an asset, a revenue with an expense, etc.

# Principle of prudence

This principle aims at showing the reality "as is": one should not try to make things look prettier than they are. Typically, a revenue should be recorded only when it is certain and a provision should be entered for an expense which is probable.

### Principle of continuity

When stating financial information, one should assume that the business will not be interrupted. ### **GAAP**

Generally Accepted Accounting Principles (GAAP) is the standard framework of guidelines for financial accounting. It includes the standards, conventions, and rules accountants follow in recording and summarizing transactions, and in the preparation of financial statements.

### Overview

Financial accounting information must be assembled and reported objectively. Third-parties who must rely on such information have a right to be assured that the data are free from bias and inconsistency, whether deliberate or not. For this reason, financial accounting relies on certain standards or guides that are called "General Accepted Accounting Principles" (GAAP).

Principles also derive from tradition, such as the concept of matching. In any report of financial statements (audit, compilation, review, etc.), the preparer/auditor/CPA must indicate to the reader whether or not the information contained within the statements complies with GAAP.

Principle of regularity

Regularity can be defined as conformity to enforced rules and laws.

Principle of sincerity

According to this principle, the accounting unit should reflect in good faith the reality of the company's financial status.

Principle of the permanence of methods

This principle aims at allowing the coherence and comparison of the financial information published by the company.

Principle of non-compensation

One should show the full details of the financial information and not seek to compensate a debt with an asset, a revenue with an expense, etc.

Principle of prudence

This principle aims at showing the reality "as is": one should not try to make things look prettier than they are. Typically, a revenue should be recorded only when it is certain and a provision should be entered for an expense which is probable.

Principle of continuity

When stating financial information, one should assume that the business will not be interrupted. This principle is mitigating the previous one about prudence: assets do not have to be accounted at their disposable value, but it is accepted that they are at their historical value (see depreciation). is a consistent pattern. When things get too hot for him, if the person currently in his sights isn't dancing to his tune, he has assured them he will sue them for every penny they have. Has he done that, actually taken legal action? Yes and no, though for our purposes here, the specific, nuanced answer doesn't matter. What matters is the pattern of threats.

Obviously, ordinary people cannot win megabuck battles. Danny made it clear to those he threatened thus that it didn't matter to him whether he won or not; bankrupting them would serve him just as well as winning in court. I'll not speak to his success rate in this note, except to say it depends on how you define success (and ethics and morality) ... and how far down the road you are looking. I'd like to believe that in the end however, the truth will out, despite the course so far.

The reason for glancing at history this way is to better assess where things stand today. This present threat to this pastor is another page out of the same play book, clearly meant by its deliverer to serve the same ends.

As for the literary/legal quality of the letter, either the guy is a dolt as a lawyer, or to put his best spin on it, he has completely removed his lawyer's cap before sitting down to write. Of course, as a piece of intimidation, it's quite a lu-lu. One could hardly get more obvious, or belligerent. In other words, completely consistent with the play book.

Now then, will Danny actually have him go forward with such a suit? Hard to say. As erratic and unstable as he's becoming of late (and those surrounding him as well it appears) and as deeply as he has dug himself into the hole he is in, who can say? Anything is possible at this point.

Personally, I do not think this particular world will follow T.S. Eliot's pattern: "Not with a bang but whimper." ... although, for what it's worth, there is also such a thing as a whimpering bang. This one (the 3ABN affair) is, in my view, not likely to go quietly into that dark night.

Hope for the best, expect the worst.



Erwhatzat? Ellen White, speaking of the Matthew 18 principle, which most certainly applies to this case, said:
"If thy brother shall trespass against thee, go and tell him his fault between thee and him alone: if he shall hear thee, thou hast gained thy brother" (Matt. 18:15). This is the way in which misunderstandings are to be settled. Speaking alone, and in the spirit of Christ to the one who is in fault, will often remove the difficulty. Show Christlike love for your brother by seeking to adjust the difficulty "between thee and him alone." Talk quietly together. Let no angry words escape your lips. Present the subject in a way that will appeal to his best judgment. And if he will hear you, you have gained him as a friend. {UL 106.2} Whatever the character of the offense may be, this does not change the plan God has made for the settlement of misunderstandings and personal injuries. Act out the spirit of Christ. Take the recipe God has provided, and carry it to the spiritually diseased [one]. Give him the remedy that will cure the disease of disaffection. Do your part to help him. Feel that it is a duty and privilege to do this, for the sake of the unity and peace of the church, which is very dear to the heart of Christ. He does not want any wound to remain unhealed on any member of His church. All heaven is interested in the interview between the injured member and the one who has been guilty of error. After settling the difficulty, pray together, and angels of God will come to you and bless you. There is music in heaven over this union. {UL 106.3}
As the erring one accepts the testimony borne, and gives evidence of true repentance, the sunshine of heaven fills his heart. Hearts are drawn together. The healing oil of love removes the disease and soreness of the wrong. The Holy Spirit binds heart to heart. {UL 106.4}
Those who have been united in Christian fellowship offer prayer to God, and pledge themselves to deal justly, to love mercy, and to walk humbly with God. If they have wronged others, they continue the <b>work of repentance, confession, and restitution;</b> and the disease is healed. They are fully set to do good to one another. This is the fulfilling of the law of Christ. {UL 106.5}
Repentance, confession, and restitution are all required. But these cannot atone for the sin, for God has been wronged in the person of His saints. The Lord Jesus alone is able to atone for sin, by the application of His blood, shed for the guilt of the sinner. His blood cleanses from all sinManuscript 47, April 2, 1902, "Lessons From the Eighteenth of Matthew." {UL 106.6}
Regarding the "works" of repentance, confession, restitution, and reformation there are over a hundred references to these (as works) in her writings. Perhaps the Bible uses the word "fruits" in place of "works" at times. And by their "fruits" we shall know them!
