Now the situation at 3ABN is totally different. FCC rules govern profanity (at least they used to enforce thistimes are changing). They do not dictate names, or even anything about credits at all. BMI and ASCAP have their own rules for music rights and anything else which is copyright might need to be properly disclosed, but there no requirement for the individuals on the program to be named, much less with their correct or real names.
