"The fresh scent of Glade..."

Working in a salaried position at 3ABN and wearing many "hats", requires the equilibrium of an acrobat combined with the patience of a saint. When this does not suffice, only comic relief can stave the imminent onslaught of certifiable insanity or a nervous breakdown.

Follow me back in time, as we ascend the stairway to the second floor above the *3ABN Presents* studio. On our immediate left is the office of Doug: head of graphics, he also doubles as an on air announcer, in addition to other numerous responsibilities. Glancing inside the open door, he is completely absorbed in his current project on the "state of the dead".

As we leave Doug's office directly on our right is the restroom and adjacent to that a combination conference room/dining area with a small kitchen attached for employees. Across the hall is a second graphic department office, and following that on our left are the two pastoral departments offices. The pastoral offices both have windows facing the interior hallway. The first of these two offices is "the scene of the crime". Working alone in the first office is the only female member of the pastoral team, Venita. She is the intended victim.

After remaining seated for a long stint on the prayer line, she takes a deep breath through her mouth and stretches. Picking up the box fan and placing it in the open doorway, carefully directing the stream of air from the hallway toward her desk, she reaches up and tucks a loose strand of curly black hair back into her neatly arranged hair. Seeing her reflection in the window, the sprinkling of gray hairs give evidence of approaching age. She was much younger when she and her husband Jan Marcussen first came to southern Illinois. He stops in midstride realizing it's fluttering whiz is coming from Venita's doorway. Instantaneously, a light bulb explodes in his head and it is as if the name GLADE has been etched upon his brain. In a pivot, worthy of a prima ballerina, he returns to the toilet, picks up the spray can, gives a brief squeeze of pressure to the button and the heavy fragrance of an indiscernible floral scent fills the room. As a smile curls his lips, stealthily he makes his way down the short distance that separates him from his intended victim...

Approaching Venita's office window he begins to crouch down, quickly turning his head in both directions, checking if the coast is clear. Soon he is on his knees, his chubby physique resembling a bear cub on his ways to stir up some mischief. Our standing for the right is often done in quite unremarkable ways: smiling at a rambunctious child, showing sensitivity to a coworker who is having a bad day, choosing carefully the jokes we laugh at, the TV programs we watch, the videos we pick up from the store without thinking that the clerk might

be taking mental note.

Only occasionally is someone put in a position where they have opportunity to stand as a hero and make a pronounced difference in the lives of people all around the globe. The rarity of the opportunity tends to magnify the tragedy when someone placed in that position chooses to aid evil rather than take a stand against it. We have no way of knowing the motivations of John Lomacang's heart. Is he driven merely by the desire for monetary and popularity benefits? Is he driven by fear of retaliation should he speak the truth? Is he living in fear that that some unknown to the world weakness of his will be exposed? Would it also expose him to dangers of which we have little knowledge? It would take real courage and character to step out at this point and have to confess his errancy for not doing so before. Does John Lomacang have that kind of courage and character?

One definition of a hero is one who can act for the right even in the face of his fears. Another way of saying this is that courage is not the absence of fear, but choosing to do the thing that needs to be done in spite of the fear, in spite of genuine danger.

Desmond Doss was that kind of hero.

Is John Lomacang able to be a hero?

Only time will tell.

It is true that the disappointment that we feel has actually little to do with Linda herself, it is the fact that so many battered and bashed are pushed into the corner because our 'base contributors' may be split. Last night I talked to a man from our church and I was telling him how I felt about Hope TV being afraid to take a stand in hiring the least, because they may lose a share of the supporters which they need at this time. The person that I was talking to is a very successful businessman himself and he assured me that if any entitiy is going to stand and be successful that they have to weigh the advantages and choose the larger group who could contribute more abundently. He told me that the church as a whole has to remember that in circumstances such as these that there is no right and wrong-there is only a division of opinions and that the group who offers the most will be the first to be considered. Suddenly I realized why the richest families in our church base are those chosen to be considered for positions which would place them on the church board. And I felt sad that many of my own family members are among them.

Most of us live out our lives in the small circles of our family, friends, and local contacts at work or church. While we each have a sphere of influence and each are called to "make a difference" in the struggle between good and evil that goes on all around us, that "difference" may be only in a very small and circumscribed circle.

Our standing for the right is often done in quite unremarkable ways: smiling at a rambunctious child, showing sensitivity to a coworker who is having a bad day, choosing carefully the jokes we laugh at, the TV programs we watch, the videos we pick up from the store without thinking that the clerk might be taking mental note.

Only occasionally is someone put in a position where they have opportunity to stand as a hero and make a pronounced difference in the lives of people all around the globe. The rarity of the opportunity tends to magnify the tragedy when someone placed in that position chooses to aid evil rather than take a stand against it. We have no way of knowing the motivations of John Lomacang's heart. Is he driven merely by the desire for monetary and popularity benefits? Is he driven by fear of retaliation should he speak the truth? Is he living in fear that that some unknown to the world weakness of his will be exposed? Would it also expose him to dangers of which we have little knowledge? It would take real courage and character to step out at this point and have to confess his errancy for not doing so before. Does John Lomacang have that kind of courage and character?

One definition of a hero is one who can act for the right even in the face of his fears. Another way of saying this is that courage is not the absence of fear, but choosing to do the thing that needs to be done in spite of the fear, in spite of genuine danger.



Doing something does not have to be placed in an "instead of" context. Talking to each other is important, especially in this venue which is open for any who come by to read. In addition to that, however, there is real value in not only talking about what can be done, but in actually doing some of the things suggested, or some that are inspired by something said here.

As far as placing an ad for BSDA, that would have to come from Calvin, I would assume, unless he wanted to delegate the responsibility to someone else.

When it comes to the Union papers, it is my understanding that they have their own requirements for accepting ads, as well as their own pricing schedules. This information, or contact information for finding the information, would be available on your Union website or possibly in the Union paper itself. And probably the request for an ad would only be looked at seriously if it came from someone within that specific Union. So this is not something that someone can do for all Unions. You could, however, send your suggestion to Polly's Place itself and find out if this is something they themselves can initiate.

You could also write to specific Adventist papers and tell them about your interest in Polly's Place, give them the url of the website and that you would very much like to see an article done on this organization. Women of Spirit is one that might be specifically interested in it. OTOH, they may have already run such an article and you may not have noticed it. Be aware that most magazines have a very long planning cycle. Adventist Review, for example, has their feature stories planned out for three years in advance. Only late breaking news type items can get into it in shorter notice. Be aware also that magazines are normally looking for articles to evaluate for publication rather than for ideas for articles for which they would have to devote staff time or find an author.

As for authority, anyone can initiate a request on only their own desire. The editorial or marketing department of the magazine (depending on whether it is for a story or a public request for funds) would have the final say on the decisions. In the case of Adventist Review, the advertising for the magazine is handled by the Review and Herald Publishing Assn. Marketing Department, not by the editorial staff.

It would be well to contact Mabel Dunbar to learn what her desires are in this area before contacting any magazine. While we know that she needs operating funds, we do not know that she needs more publicity. It may be that until she has funds, she has more opportunities now than what she has funds for.





Doing something does not have to be placed in an "instead of" context. Talking to each other is important, especially in this venue which is open for any who come by to read. In addition to that, however, there is real value in not only talking about what can be done, but in actually doing some of the things suggested, or some that are inspired by something said here.

As far as placing an ad for BSDA, that would have to come from Calvin, I would assume, unless he wanted to delegate the responsibility to someone else.

When it comes to the Union papers, it is my understanding that they have their own requirements for accepting ads, as well as their own pricing schedules. This information, or contact information for finding the information, would be available on your Union website or possibly in the Union paper itself. And probably the request for an ad would only be looked at seriously if it came from someone within that specific Union. So this is not something that someone can do for all Unions. You could, however, send your suggestion to Polly's Place itself and find out if this is something they

themselves can initiate.

You could also write to specific Adventist papers and tell them about your interest in Polly's Place, give them the url of the website and that you would very much like to see an article done on this organization. Women of Spirit is one that might be specifically interested in it. OTOH, they may have already run such an article and you may not have noticed it. Be aware that most magazines have a very long planning cycle. Adventist Review, for example, has their feature stories planned out for three years in advance. Only late breaking news type items can get into it in shorter notice. Be aware also that magazines are normally looking for articles to evaluate for publication rather than for ideas for articles for which they would have to devote staff time or find an author.

As for authority, anyone can initiate a request on only their own desire. The editorial or marketing department of the magazine (depending on whether it is for a story or a public request for funds) would have the final say on the decisions. In the case of Adventist Review, the advertising for the magazine is handled by the Review and Herald Publishing Assn. Marketing Department, not by the editorial staff.

It would be well to contact Mabel Dunbar to learn what her desires are in this area before contacting any magazine. While we know that she needs operating funds, we do not know that she needs more publicity. It may be that until she has funds, she has more opportunities now than what she has funds for.

Well, I wrote to Mabel Dunbar and just this morning I received a warm e-mail encouraging others to help "Polly's Place" and she assured me that her network is excited to be working with Linda and said that they will not let Danny or John affect their relationship with Linda or discredit her. For the 3ABN workers and the other impoverished residents of Franklin County, even a trip with your kids to the Dollar Store can be a rare treat. This emporium of astonishing merchandise, gathered from unknown locations, is a shopping paradise for the working poor.
