Regarding Danny's marriage

Dear Family and Friends of 3ABN,

Two years ago 3ABN was challenged by the most difficult battle the ministry has ever faced. It was a battle that threatened the very existence of the ministry and the work of preaching the end time message of the Three Angel's to the world. It is only because of the grace and power of God Almighty, and the faithful support of you, the 3ABN family, that the ministry has survived to preach another day. Today, the ministry is stronger than it has ever been and its reach into the world even broader and more powerful for the cause of truth.

As is always the case when in the public eye, questions arise, stories abound, and rumors spread. We thank God that you have trusted the leadership and board of 3ABN during this time and have stayed with us in ministry. More recently some of you have heard that Danny has found one to comfort him in his loneliness and sorrow. You may have also heard rumors about an allegedly illegal divorce occurring without Biblical grounds. This letter is an attempt to fill you in with the facts.

As chairman of the board I have been in the midst of this long and drawn out ordeal from the beginning. I was there when we counseled with Linda over and over again. I was present during the pleas and prayers, seeking to get her to give up her relationship with the doctor. I have seen and heard the evidence upon which the board has taken the action that it has taken. I have been one that has plead with Linda to keep her marriage and her ministry and offered to provide counseling for them. I have known Danny and Linda almost from the beginning of the ministry and have been in their home many times. They had a good marriage. It was not until this third party got in the middle did things begin to fall apart. It is also true that Danny really did want to get back together again, but when it became obvious that couldn't happen, he correctly had to close the door on that part of his history lest it destroy him and the ministry.

The divorce was a mutually agreed thing, even the choice to get it from Guam where there would be no long wait. Linda had originally planned to move to Las Vegas long enough to become a resident there so as to get a divorce there. They then discovered the possibility of a divorce from Guam, checked it out and found it to be legal, and decided to go that route. Though I believe Guam has now stopped the program, the legality of a Guam divorce had previously been taken to the U.S. Supreme Court where it was ruled legitimate. As chairman of the board, I did not try to influence the decision, but I will say that had they not obtained a quick divorce, the ministry would have been placed at much greater risk since the situation was causing so much dysfunction with leadership and staff. I believe time has verified the correctness of what was done then, both by Danny and by the board for the ministry.

Linda's web site recently stated that she and Danny were not divorced. She wrote this after the

judge made the decision in Danny's favor. She claims she did not know this when she wrote it. Her web site referred to an e-mail I sent to Johann Thorvaldson a year earlier saying that I had never accused her of adultery. I believe that exchange with him was in response to an accusation by him that we had fired her because of adultery. I was merely saying that she was not fired for adultery, but because she had defied the board in not discontinuing a relationship that was threatening to destroy the ministry. (I might add that the doctor also told me he would not break off the relationship, even though I pled with him to do so.) That letter to Johann was correct, and it is true that I have never directly accused her of adultery. That does not mean that I believe Linda is innocent. If by adultery one must be caught in bed with another person, I cannot prove Linda has committed adultery. If, on the other hand, hard evidence indicates that Linda was involved in an unacceptable relationship with another man qualifies for adultery, then there is no question about Danny's moral right to marry again. As a board, we have chosen not to make the details of the evidence available to the public. I believe Satan is the accuser of the brethern. We have chosen to take the "high road" in this whole situation and say nothing more than we have been forced to say to try to quell rumors. We care about Linda and have tried not to do anything to hurt her more than she has already been hurt. I can tell you that I personally spent a great deal of time at 3ABN during those months when this was all happening. I spoke with Linda and Danny on numerous occasions. A sub committee of the board met and prayed with Danny and Linda and pled with Linda to call off the relationship. Danny and Linda spent an 8 hour session with a pair of Christian counselors (non-Adventist in an attempt to avoid bias) who had no doubts about the nature of Linda's conduct. We offered to provide Linda with the opportunity to go away for counseling with a counselor agreeable to both she and us. She did not respond to that offer or request. Finally, the full board met, reviewed Linda's letter of explanation, and voted unanimously to remove her from the ministry and her seat on the board. Other church leaders who have been privy to some of the evidence we have are in full agreement with our decision.

The relationship Linda had with the Norwegian Dr. was not a normal doctor-patient relationship as she claims. It is true. Linda was very concerned about her son Nathan. He was the vehicle through which the Dr. reached Linda. Our evidence leaves no question that this became much more than a doctor-patient relationship. We know that the long hours on the phone together were not about Nathan and have hard evidence to support this knowledge - nor were times spent together on both sides of the Atlantic. Furthermore, she refused to break it off, even after weeks of pleading with her to do so. We, the board believe the evidence we have clearly justifies the divorce and gives Danny the moral and legal right to remarry. Those in church leadership with whom we have shared some of this evidence agree with us. Out of concern for Linda we have been reluctant to make details public.

No, Danny is not to blame for what has happened here. On the contrary, he has bent over backwards trying to make things work and meeting her requests. Yet, she has never acknowledged that it was wrong for her to have another "friend". The things I have stated here are accurate and correct. As far as the lady Danny has married is concerned, I can only say I believe his new wife is a very good person and will be a real asset to him as he carries on his heavy responsibilities. Just to clarify any rumor you may have heard, this relationship began long after the divorce. I was at 3ABN when this lady came from Florida looking for work. There was nothing going on before that time, and Danny definitely was not trying to "dump" Linda. I was with him during much of the time he agonized and mourned her loss. It is one thing to lose a loved one in death. It is much different to lose one to another lover - like cutting a dog's tail off one inch at a time! I have had an interesting thought this week that I will share with you. It is this. God lost one of his

closest companions when Lucifer went astray. More than that, myriads more angels left with him when he left heaven. Talk about grief or emotional pain. Experiences such as this with Linda, I think, help us to understand the pain of loss, and the reality of the war between God and Satan. Some have claimed it takes two to divorce. I don't think that is categorically true!

This has been a terrible injury that has hit 3abn and Danny, and yes, Linda too, but it is one that I believe God understands - and He continues to bless his servants.

We recognize that we live in a world at war, and are working with a ministry that the devil would like to see destroyed. The war is real, and as in any other war there are real casualties. War is never pleasant, and spiritual battles maybe some of the worst. Our hearts still ache for those who have been wounded. Our prayers continue to ascend on their behalf. Should acknowledgement of wrongdoing and penitence ever occur, we would be the first to forgive and forget. Unfortunately, that has not happened, and we must move on.

Some who have been aware of the growing relationship and the possibility of marriage have thought they should wait for a longer period of time before marrying. In discussions before the event, the 3ABN board reviewed the events of the past couple years and have agreed that there was no moral or legal reason precluding marriage. Realizing the heavy burdens resting on Danny and of his need for companionship, we, the board did not see any reason not to give our blessing to their union. We hope you, our 3ABN family, will agree too, and with us, welcome Brandy with open arms.

Please reread the comments on the Form 990 and then read the comments from the IL vs. 3ABN Tax Lawsuit.

This problem repeats itself.

There is a correction on the 990 for 2002 in the amount of \$1,705,916 as Split Interests (TRUSTS) well as an Adjustment of Cash Revocable Trusts in the amount of (- \$25,000 negative).

The 2003 Form 990 reports the there was a Change in the value of Split Interest Agreements in the amount of (-\$775,816 negative).

It is clear to see the problem is not what IS on the statements, but what is NOT on the statements. Discrepancies are usually found by honest auditors that are truly independent. However, how can auditors find things if all the source documents are hidden from the auditors?

This brings the Lake Region Conference to mind. It is clearly apparent that 3ABN needs some oversight and direction to establish accountability.

In discussions before the event, the 3ABN board reviewed the events of the past couple years and have agreed that there was no moral or legal reason precluding marriage. Realizing the heavy burdens resting on Danny and of his need for companionship, we, the board did not see any reason not to give our blessing to their union. We hope you, our 3ABN family, will agree too, and with us, welcome Brandy with open arms **Note 9**.

Should you have any questions that I might answer, please feel free to send them to me at 3ABN and I will do my best to try to answer them.

Now here are the footnoted comments of Gregory Matthews (an SDA chaplain by the way) to Thompson's public letter above:

Note 1: Those of us who may be considered critics are loyal supporters of the Seventh-day Adventist Church and of the work of God on planet Earth. We acknowledge that God led Danny and Linda Shelton to establish 3-ABN, a ministry that for many years has been led by God. We are thankful for what God has accomplished in the ministry of 3-ABN. To many people, 3-ABN is the face of the Seventh-day Adventist Church.

Now a scandal has tarred the face of that ministry. People are asking if God is still leading in the ministry of 3-ABN, and/or if God is using present leadership of 3-ABN to guide it in its ministry. These questions are sincere, and valid. Those who have supported 3-ABN in the past, have honest questions. We believe that God is still leading, not only in human life on

this planet, but in the ministry of those whom God has called to leadership. But, we are reminded of times in the history of our denomination when human leaders made mistakes. God intervened, and in some cases, but not all, removed those leaders, and allowed old ministries to be replaced by new ones that were more receptive to the leading of the Holy Spirit.

We are waiting to see how God leads in the ministry of 3-ABN. We do not know what God has in mind for 3-ABN. But, we do know that if its leadership fails to follow the leading of the Holy Spirit, God will act in whatever manner God knows is best.

Note 2: None of us who know the law, have ever challenged the right of Guam to issue a divorce to citizens of the United States. We were aware that the U.S. Supreme Court had previously ruled on that question. However, even when divorces are obtained in one of the States of the United States, they may be subject to challenge. Some felt that the Guam divorce was subject to challenge. An [Illinois] State Court has dismissed that challenge. The Guam divorce is legal.

As to the issue of Biblical grounds for Danny to divorce Linda, and then to remarry another, that is a much more complex question. Some of the more liberal SDAs believe in multiple grounds for divorce and remarriage. But, in general, those who are the strongest supporters of 3-ABN believe that divorce followed by remarriage is only Biblical when the other has committed physical adultery. When those people hear ([or] read) 3-ABN say [ing] that Danny had Biblical grounds, they understand that to mean that Linda physically committed adultery. They simply do not understand "Biblical grounds" for divorce and remarriage in any other way.

Note 3: I find the last sentence very interesting. Here it is said that Danny faced a decision between his marriage and his ministry and he chose his ministry. No ministry is dependent upon one person. The ministry of 3-ABN could go on without it present leadership. God is involved, and God will both remove and provide.

Note 4: One might say that the divorce was mutually agreed upon. That does not mean that both parties wanted the divorce. Often in a divorce, one party wants the divorce, the other agrees to it due to the fact that that party sees no option for reconciliation. I have found that one can often understand some of the dynamics that are going on in a divorce by looking at who it is that filed the action to divorce.

Note 5: Court rulings are complex. Sometimes non-lawyers misunderstand what a court has decided. There was a period of time where Linda and others were misinformed as to the ruling of the [Illinois] Court. All who did so regret that misunderstanding.

I am not aware of any time in which anyone has officially accused Linda of physical adultery. But when one talks about Biblical grounds, moral rights, and inappropriate relationships, many of the 3-ABN supporters will hear adultery. From the practical standpoint, 3-ABN might just as well have claimed that Linda committed such. In many ways, I believe that such [a] lack of focus as to what Linda did has hurt her more than an actual charge of adultery would have damaged her. One can rebut a specific charge. It is very hard to rebut a non-specific charge.

Note 6: Again, words and terms are used that communicate physical adultery to 3-ABN supporters. It is implied the Linda and the M.D. had a relationship that was more than professional. There is a clear implication that the 3-ABN Board has evidence that cannot be questioned. One of my questions regarding this is: to what extent was Linda allowed to present a defense? Accusations were made, and people testified before the Board. Was Linda allowed to present a defense in person? Was she allowed to bring witnesses to the Board to testify? If she was not granted all of the above, and more, the Board cannot say that they have evidence that cannot be questioned.

I raise these questions because of what has been circulated by others, to include supporters of 3-ABN. It has been said that the Board once heard evidence that the previous night Linda had spent the night with an adult male, not a relative that was married to another woman. It is also said that because Linda was not allowed to be present, and to present witnesses, that the Board never heard that the previous night the referenced male, and his wife[**], had spent the night with Linda, with both helping her to prepare her written defense, as she was not going to be allowed to be personally present.

Note 7: This entire situation is a tragedy. I have not, and do not intend to criticize Danny for his remarriage. But, that is probably because I may be more liberal than are many of the 3-ABN supporters. If the Board is wrong about the relationship that Linda had with that Dr., then the Board is wrong to tell people that Danny had Biblical grounds.

Note 8: I agree, so what if there is an age difference[?] Nothing should be made of that. Your second from the last sentence is interesting.

Note 9: Brandy should not be the focus of this. Regardless of right or wrong, the issues do not lie with her. The rights or wrongs lie with others. I join you in hoping that people on all sides of this issue will welcome her and the children that she brings to this marriage with both open arms, and with the love of the Lord Jesus Christ.

**Let me insert this clarification in Gregory's comment above: Elder Johann Thorvaldsson, the former European liason for 3ABN, has publicly identified himself as this person, stating that he and his late wife were in fact the very persons in question here. -- Norm

I find Gregory's comments eye-opening. It is easy to get lost within a long document and lose one's overall perspective. Comments like these help one regain that perspective. If ever there were a need for seeing the big picture, this is such an instance.

We saw the reaction of the 3ABN board to this document earlier in one of sister's history vignettes. But unless I missed something (and I do try to pay attention) the substance of this agreement has neither been posted or discussed. But seeing the documents for ouselves might give us more comprehension as to what is meant by "contol" in the 3ABN context.

While it is true that specific church leaders can be faulted for continuing to support and utilize 3ABN after they had ample opportunity to learn of the perfidous things that were going on there, that does not mean that the church as a legal entity had any legal ability to intervene in 3ABN affairs. So, with their hands securely tied not only legally but also by knowledge of the kinds of tactics that had been and were being used on those who did not bow at the Danny altar (as Beartrap and others have described), if they make every attempt to deny complicity that will be fairly close to being factual. (One can only hope that they will take this position rather than entering any legal battle that is involved on the side of support for 3ABN.)

That does not mean that I think they should not have made greater attempts that they did. But the history of the relationship between independent ministries (which used to be called "self-supporting" ministries) and what they call disparagingly the "organized work" is long and contorted and has resulted in the situations that we see today, of which 3ABN is only one example.

3ABN Board Rejects Agreement: I am deeply disappointed to report that the Board of Directors of Three Angels Broadcasting Network voted not to sign an

agreement with the General Conference for a mutually supportive global distribution of satellite programming. The April 7 edition of "From the G.C. President" reported that the General Conference has been in dialogue with Three Angels Broadcasting Network attempting to document a working relationship. The draft agreement (recommended for approval by almost all of the 3ABN Board members on March 20), neither presumed or proposed change in 3ABNs governance or programming and it specifically excluded General Conference "control." But it did provide the members in each country a voice if they felt the programming distributed by 3ABN in their territory was detrimental to the work of the church. Even that "voice" was not unilateral. It proposed a five-step issues-resolution process which culminated with a three-person binding arbitration panel (one from 3ABN and one

from the division involved plus a third party agreed upon by those two).

In addition to utilizing satellite technology to fulfill the task our Lord assigned to His church and to do so without duplicating expenses, another reason to reach an agreement with 3ABN was that several divisions voted that an agreement was vital to building a long-term relationship with 3ABN.

One division appealed "to the General Conference to facilitate future initiatives that will help each congregation fulfill their soul-winning and soul-retaining responsibility. Given the willingness and interest of Three Angels Broadcasting Network to support and expand a television ministry within the territory of the ____ Division, ... we request the General Conference to take such steps as may be necessary leading to formalizing and documenting the relationship between the General Conference (and) Three Angels Broadcasting Network ... in order to ensure that through the normal denominational representative process, the voice, interests, and ultimately the authority, of the members of our respective ... constituencies are protected, for of course, absent an approved record of such understandings we must reluctantly decline to accept, or otherwise participate in ..., the generous offers which have been or may be extended."

In addition to disappointment, I admit to some confusion. The tone of the 3ABN Board action was gracious and affirmed its support for "the work of the church" and "continued loyalty to the cause of the church" yet the stated reason for the rejection was that "3ABN, its staff, its board, and many of its viewers and supporters perceive a serious potential threat to the continuing effectiveness and operation of the ministry of 3ABN by entering into any type of contractual agreement with the church."

While denying the constituent authority of members in each country the right to be heard in an activity which directly affects their ability to fulfill the mission for which they are responsible, 3ABN affirms the "authority of its president," yet expresses its concern about the exercise of "kingly power" in the church.

While I am a confirmed optimist and pray the 3ABN Board may reconsider their decision, there are so many major evangelistic events already scheduled and we are

committed to moving rapidly toward the objective of global coverage, that the General Conference has no option but to proceed to establish a global satellite delivery system and pray that 3ABN will subsequently agree to join the church in this initiative.

INTERNATIONAL SATELLITE DISTRIBUTION AGREEMENT

This Satellite Distribution Agreement (Agreement) is made between the General Conference of Seventh-day Adventists (GC), 12501 Old Columbia Pike, Silver Spring, Maryland 20904-6600, and Three Angels Broadcasting Network, Inc. (3ABN), RR#3, Box 176A, Thompsonville, IL 62890.

1. PURPOSE:

This Agreement recognizes 3ABN as a non-exclusive interdivision satellite distributor of television programming produced by the GC and its affiliated entities and as a non-exclusive producer of television programming contracted for by the GC and affiliated entities, and setting forth the respective duties, obligations, and responsibilities of the parties. Nothing in this Agreement precludes 3ABN from producing and distributing by satellite other programs that do not otherwise violate the terms of this Agreement. Any additional cooperative communication initiatives will be the subject of future negotiations and written agreements.

2. RELATIONSHIP BETWEEN PARTIES:

A. The relationship between the parties shall be one of mutual cooperation in utilizing satellite distribution of television programming to proclaim the Gospel of our Lord to the whole world. The GC shall not be considered the agent or representative of 3ABN, and 3ABN shall not be considered the agent or representative of the GC, and neither shall hold itself out or otherwise represent itself as being the agent or representative of the other. Neither party shall have the right to bind the other contractually in any respect whatsoever.

- B. In their promotional efforts, both 3ABN and GC will recognize the contributions of the other.
- C. Financial appeals (other than regularly aired promotional programs and/or

on-screen phone numbers) targeted for viewers outside of the North American Division, shall be undertaken only after consultation with the church governing bodies within the affected territory.

D. Any financial relationship between a Church entity and 3ABN for distribution of programming will be documented by written agreement and approved beforehand by the designated GC body.

3. PROGRAMMING:

- A. Program production by Church: Church membership on all levels of the Church, through its elected representatives, may both provide programming to 3ABN for satellite distribution and may contract with 3ABN to produce programming for satellite distribution.
- B. Program continuation: Church membership, through its elected representatives, may request through the Issues Resolution Procedure of this Agreement the discontinuation of programming that is distributed by satellite by 3ABN to the territory they represent and which the membership considers detrimental to the work of the Church.
- C. Planning or other issues: All program production issues will be addressed by bodies designated by the General Conference Administrative Committee and which will include representatives of the affected world divisions, 3ABN, and the GC.

4. BROADCASTING AND DISTRIBUTION:

- A. So that 3ABN's services can optimally support the worldwide mission of the Church, committees or boards appointed by the General Conference Administrative Committee will be the channel for interaction between 3ABN and the world field for developing and distributing television programming by satellite and addressing technical, equipment, financial, distribution, and other related issues affecting those territories.
- B. Local or regional broadcast, cable, or other distribution systems for programs received from the 3ABN interdivision satellite distribution system will be either owned or contracted for as determined by the Church governing body in that territory or region. Should the Church governing body make no decision, 3ABN may initiate such contracts after receiving authorization by the church governing body, a request which shall not be unreasonably withheld. If the Church governing body refuses to respond to such a request 3ABN may initiate the issues resolution process.

5. ISSUES RESOLUTION:

Both GC and 3ABN agree that no civil court has jurisdiction over this Agreement and that any issue, controversy, disagreement, or claim arising out of or relating to the breach of this Agreement shall be settled by using this issues resolution procedure. Wherever an issue arises, GC and 3ABN agree to resolve the issue as follows through their designated representatives:

A. (Step 1) GC and 3ABN will communicate informally and attempt to resolve the issue.

- B. (Step 2) If informal communication does not resolve an issue and if the issue is not of an urgent nature, then it shall be placed on the agenda for review by an annual consultation, chaired by a designee of GC, and including representatives of 3ABN, the GC, and the world territories using 3ABN satellite distribution services, to review 3ABN programming and distribution services and unresolved issues.
- C. (Step 3) If informal communication and the annual meeting do not resolve an issue or if it is of an urgent nature, then the GC shall appoint and chair a special Issue Resolution Committee which shall include designated representatives of 3ABN and GC, and the affected territory or territories to consider and resolve the issue.
- D. (Step 4) If Steps 1, 2 and 3 do not resolve the issue, the chairman of the board of 3ABN and the GC by mutual agreement shall select a mediator who shall work with the parties to resolve the issue. (This step may come earlier in the process if the parties agree).
- E. (Step 5) If Steps 1 through 4 do not resolve the issue, the issue shall be referred to a three-member Binding Arbitration Committee (BAC) appointed by the General Conference Administrative Committee to review the issue and make a final determination. The General Conference Administrative Committee shall select members of the BAC as follows: (1) It shall request 3ABN and the affected division each to submit a list of three candidates for the BAC; (2) GC Administrative Committee will ask 3ABN to choose one name from the list of three submitted by the affected division and will ask the affected division to choose one name from the list of three submitted by 3ABN; (3) the two members thus selected will then choose any individual to be the third member of the BAC. The three members will choose the chairperson. Both parties agree to abide by the determination of the BAC.

6. TERM OF AGREEMENT:

It is intended that this Agreement serve as a long term agreement. Therefore, this Agreement shall remain in effect until terminated by either party as provided for in this Agreement. Each party has the right to terminate this Agreement without cause by written notice given to the other party no less than ninety (90) days prior to the effective date of the notice. Either 3ABN or GC may terminate this Agreement, either in its totality or as it affects satellite distribution in a specific territory, effective immediately, by written notice given to the other party in any of the following events:

- A. if either party fails to fulfil or perform any one or more of the duties, obligations, or responsibilities it has undertaken under this Agreement;
- B. if either party assigns or attempts to assign any interest in this Agreement without the other party's written consent;
- C. if there is any transfer or relinquishment, voluntary or involuntary, by operation of law or otherwise of any material interest in the direct or indirect control or any change in management of 3ABN that the GC considers adverse to the interests of the Seventh-day Adventist Church or if 3ABN or any of its public personages or its board members become engaged in matters which the GC Administrative Committee considers adversely affects the interests or good name and good will or reputation of the Church.

Upon termination of this Agreement in its totality, 3ABN shall cease to be an authorized broadcaster, distributor, and producer of programming for the GC and will discontinue all services represented to be affiliated with or on behalf of the Church, and neither party shall be responsible to the other for any damages growing out of the termination of this Agreement for any reason whatsoever, including any claim for lost or anticipated income, expenditures, or any other damages. In addition, upon termination of this Agreement, both parties agree to immediately discontinue the use of the names, trademarks, sign, stationery, advertising, or anything else that might make it appear that they are still operating under this Agreement.

7. TRADEMARKS, COPYRIGHTS, AND ORGANIZATIONAL IDENTITY:

- A. Both GC and 3ABN agree to refrain from any activity that leads to confusion, uncertainty, or misrepresentation regarding the use of their respective trademarks and trade names.
- B. Both the GC and 3ABN will respect the legal bounds that separate the GC from the independent 3ABN ministry. Nothing in this Agreement should be held to mean that the GC has assumed any corporate control of 3ABN and its independent programming or that 3ABN has assumed corporate control of the television programming of the Seventh-day Adventist Church.
- C. Copyrights of all 3ABN independent programming will continue to be owned and registered in the name of 3ABN, and copyrights of all programming produced by or for the GC and its affiliated entities will be owned and registered in the name of the GC and/or its affiliated entities.

8. UNCONTROLLABLE INTERFERENCE:

Neither party shall be liable to the other for failure to perform its obligations under this Agreement due to fire, flood, earthquakes, disturbances, accidents, war, or other causes beyond the reasonable control of the parties.

9. NO ASSIGNMENT:

Neither party of this Agreement may assign any right or interest in this Agreement without the prior written consent of the other party.

10. BINDING EFFECT & SEVERABILITY:

This Agreement shall benefit and be binding upon the successors and assigns of the parties. If any part of this Agreement is void, voidable, invalid, or unenforceable, for any reason, this Agreement shall then be considered divisible as to such part with the remainder of this Agreement remaining a valid and binding.

11. COMPLETE UNDERSTANDING:

This Agreement terminates and supersedes all prior agreements between the parties, if any. This Agreement sets forth the entire Agreement between the parties. This Agreement may be changed, altered, or amended only in writing

A Letter From William J. Hulsey

April 16, 1997

To: The Board of Directors of 3ABN

Fellow Board Members,

The topic of signing an agreement with the General Conference has held top priority for many of us over a considerable period of time and has engaged us in seemingly endless hours of thought and discussion and prayer. Yet I respectfully request your audience once more by way of a few personal thoughts.

First I need to say that I have an abiding sense of loyalty to the Seventh-day Adventist church.

Secondly, I have tremendous respect for Elder Bob Folkenberg who has been commissioned with the heavy responsibilities of leadership of the world-wide Church.

Thirdly, as a member of the 3ABN Board for eleven years, I have witnessed the origins, the struggles, the victories and the unprecedented growth of this dedicated ministry, and I'm persuaded that God had His Hand in these affairs also that they might reflect His Glory. At this crucial point in time, I'm reminded of Mordecai's challenge to Queen Esther, "Who Knoweth whether though art come to the kingdom for such a time as this?" God has a plan for us and the consequences are of such gravity that no effort is too great to find assurance that we are aligned with His Will.

Elder Folkenberg has accorded distinct honor to 3ABN with an invitation to join hands with the world Church for the purpose of reaching the masses more expeditiously and we acknowledge the gesture with humility and gratitude. This is certainly a worthy common objective and one which 3ABN has devoted its every effort toward.

For years we have wrestled with matters involving how best to direct our programming so as to remain true to Church and Biblical principles while retaining our position as a supporting ministry. Our Board is composed of individuals from a variety of professional backgrounds, but we all agreed and were determined to see that such a course be outlined and followed. We have felt that the Lord has honored that commitment by granting success as measured by listener acceptance. We want to assure Elder Folkenberg and his colleagues that this determination has not moderated.

My thoughts revert to the beginning of 3ABN when Ellsworth McKee and I responded to the invitation to become charter Board members. We had no previous experience with television broadcasting. Danny & Linda and the Shelton family were enthusiastically engaged in planning and personal involvement with the project but they too were as inexperienced as we. We saw miracle after miracle as funds were directed to us from unexpected sources and the concept materialized step by step. The Lord has taken this amateurish beginning and used it to His glory. As we watch 3ABN now, as I do almost daily, I see a great variety of programs encouraging people to live more healthfully and positively. All of them are done tastefully and without sham or pretense. Danny & Linda present an image that depicts how Christianity is lived out in the home atmosphere. Viewers can easily relate to this concept of Christianity. In addition to the variety programs we air a number of very fine SDA ministers, including those of the Media Center, all of who present the special truths identified with the work of the Three Angels.

For several weeks I have struggled with the concern of how these unique qualities of 3ABN programming could be preserved while at the same time laboring under a formal agreement to place priorities on needs and programming of the Church entity. My fear is that we would be placing our present ministry under great risk by accepting this additional responsibility. I have prayed earnestly for the power of the Holy Spirit to give us insight so that we could feel confident in a united course of action.

I sense that our 3ABN board officers and staff were gratified with our joint effort in broadcasting NET 96. The Church appealed to 3ABN for utilization of our signal in order to project the series into Europe and it was sheer joy to participate in this unprecedented evangelistic thrust. There was no formal contractual agreement, and in spite of limited time restraints, there was beautiful coordination and the churches successfully received the messages. It seems that it was that measure of success that gives impetus to the practicality of plans for future advances. 3ABN can do that type thing well, and we would welcome similar opportunities in the future.

It would therefore seem wise that 3ABN continue to follow the course that we have found to be successful. We dare not abandon the scores of viewers who have testified that our appeal is to the churched and unchurched, the discouraged, those without hope, those searching for Truth. We point them to the Church, the earthly repository of Truth, that they may be nurtured and fulfilled. Where baptisms result, the Church is benefited and strengthened.

If these thoughts have merit, the board action of April 14 would need to be modified somewhat. I would like to see our Board reaffirm our devotion to our Lord, restate our loyalty to the Seventh-day Adventist Church, reconfirm our sense of respect and support for Elder Folkenberg and his fellow officers at the helm, and redouble our efforts to do better that which the Lord has signally blessed thus far. Further we would pledge to assist in any way possible the program and projects of the Corporate Church Body, motivated simply by the premise that God's Will is their Will and our Will. The tie that binds us together is love, respect and common beliefs and objectives.

Thanks for your interest. While Beartrap would be the only one (that I know of) who is posting here that could give you an "insiders" (at that time) view of the rationale given around 3ABN itself, I can give background information on the underlying reasons for the rejection of the contract.

In the packet of information sent out at the time from 3ABN, there was also a copy of an evaluation of the contract that was done by a 3ABN lawyer. I don't think I understand the legaleze enough to even be real sure as to what it said. It's lengthy, but I can post it here if anyone is interested in examining it. But that is of little value, since the real reasons they rejected the contract do not lie with the specific items, but with the idea of having a formal "signed contract" of any kind.

In partial "defense" of the rejection it is only fair to point out that at the time this came up, not only independent ministries, but official church institutions, especially educational institutions of higher learning, were also concerned about Folkenberg's efforts to get everyone in line with his thinking, even to the extent of trying to require "loyalty oaths" on key points of practice and doctrine. So from one angle 3ABN could be excused for resisting a contract on this basis.

However, that is not the whole story, nor does that account for 3ABN's resistance from the beginning to taking any guidance or to having any lines of accountability to the church they claimed to be serving. That the "reasons" do not lie in the specific stipulations of the contract itself, but in something much more basic than that, can be seen by a careful reading of the letter from Bill Hulsey, which I posted yesterday. If you will notice, he makes no complaints about specific language or requirements in the proposed contract. His objections are to the very notion of having any contract at all.

This may not be seen as significant by those not acquainted with the attitudes held in the old "self-supporting work" which are held as models for many (though not all) "Independent Ministries" today. The primary one being a deep distrust of what they call the "organized work", that is to say the Conference structures. The phrase "kingly powers", when applied to church leaders, comes straight from these sources. And the condemnation and fear of control by the "organized church" which this phrase indicates, follows recognized psychological functions of betraying their own desire for control, as can be clearly seen as one examines this type of Independent Ministry.

If you combine this with the principles (almost doctrines) held by these groups--that of the function of the "prophet, priest, and king" God assigned roles, then you have the solid, unshakable ground for resistance to any "signed contract" which deprives (or even limits) the power, control, and even leadership (of the church itself) function of the Independent Ministry. Thus the very idea of having a "signed contract" is anathema to them, as the letter from Hulsey indicates.



It is difficult for the wife, children, and not least his aged, widowed mother. It is also a difficult time for the Bible school, sanitarium, health food store and bakery, all institutions he established and tried to finance by workings as a family physician from 7 AM to 10 PM certain days of the week.

According to the latest media reports of last week he got a very mild punishment, seemingly because he confessed and cooperated fully with the police. Only a fine of 25,000 Norwegian Crowns - or 50 days in prison. His offense was having sex with a young woman without her consent, according to the local paper. It stated that she was receiving psycological aid, and that she had to move away from the community.

55 years ago I stayed with his grandparents while canvassing. I recall that while Arvid was a medical

student he told me of his high ideals of following the EGW blueprints for the healt instituions he planned, and I recall he got a group of enthusiastic young SDA to help him lay the foundation for these institutions.

Arvid must have seen what the president got away with. Could that have lowered his resistance against temptation?

INTERNATIONAL SATELLITE DISTRIBUTION AGREEMENT

This Satellite Distribution Agreement (Agreement) is made between the General Conference of Seventh-day Adventists (GC), 12501 Old Columbia Pike, Silver Spring, Maryland 20904-6600, and Three Angels Broadcasting Network, Inc. (3ABN), RR#3, Box 176A, Thompsonville, IL 62890.

1. PURPOSE:

This Agreement recognizes 3ABN as a non-exclusive interdivision satellite distributor of television programming produced by the GC and its affiliated entities and as a non-exclusive producer of television programming

contracted for by the GC and affiliated entities, and setting forth the respective duties, obligations, and responsibilities of the parties. Nothing in this Agreement precludes 3ABN from producing and distributing by satellite other programs that do not otherwise violate the terms of this Agreement. Any additional cooperative communication initiatives will be the subject of future negotiations and written agreements.

- 2. RELATIONSHIP BETWEEN PARTIES:
- A. The relationship between the parties shall be one of mutual cooperation in utilizing satellite distribution of television programming to proclaim the Gospel of our Lord to the whole world. The GC shall not be considered the agent or representative of 3ABN, and 3ABN shall not be considered the agent or representative of the GC, and neither shall hold itself out or otherwise represent itself as being the agent or representative of the other. Neither party shall have the right to bind the other contractually in any respect whatsoever.
- B. In their promotional efforts, both 3ABN and GC will recognize the contributions of the other.
- C. Financial appeals (other than regularly aired promotional programs and/or on-screen phone numbers) targeted for viewers outside of the North American Division, shall be undertaken only after consultation with the church governing bodies within the affected territory.
- D. Any financial relationship between a Church entity and 3ABN for distribution of programming will be documented by written agreement and approved beforehand by the designated GC body.
- 3. PROGRAMMING:
- A. Program production by Church: Church membership on all levels of the Church, through its elected representatives, may both provide programming to 3ABN for satellite distribution and may contract with 3ABN to produce programming for satellite distribution.
- B. Program continuation: Church membership, through its elected representatives, may request through the Issues Resolution Procedure of this Agreement the discontinuation of programming that is distributed by satellite by 3ABN to the territory they represent and which the membership considers detrimental to the work of the Church.
- C. Planning or other issues: All program production issues will be addressed by bodies designated by the General Conference Administrative Committee and which will include representatives of the affected world divisions, 3ABN, and the GC.
- 4. BROADCASTING AND DISTRIBUTION:
- A. So that 3ABN's services can optimally support the worldwide mission of the Church, committees or boards appointed by the General Conference Administrative Committee will be the channel for interaction between 3ABN and the world field for developing and distributing television programming by satellite and addressing technical, equipment, financial, distribution, and other related issues affecting those territories.
- B. Local or regional broadcast, cable, or other distribution systems for programs received from the 3ABN interdivision satellite distribution system will be either owned or contracted for as determined by the Church governing body in that territory or region. Should the Church governing body make no decision, 3ABN may initiate such contracts after receiving authorization by

the church governing body, a request which shall not be unreasonably withheld. If the Church governing body refuses to respond to such a request 3ABN may initiate the issues resolution process.

5. ISSUES RESOLUTION:

Both GC and 3ABN agree that no civil court has jurisdiction over this Agreement and that any issue, controversy, disagreement, or claim arising out of or relating to the breach of this Agreement shall be settled by using this issues resolution procedure. Wherever an issue arises, GC and 3ABN agree to resolve the issue as follows through their designated representatives:

- A. (Step 1) GC and 3ABN will communicate informally and attempt to resolve the issue.
- B. (Step 2) If informal communication does not resolve an issue and if the issue is not of an urgent nature, then it shall be placed on the agenda for review by an annual consultation, chaired by a designee of GC, and including representatives of 3ABN, the GC, and the world territories using 3ABN satellite distribution services, to review 3ABN programming and distribution services and unresolved issues.
- C. (Step 3) If informal communication and the annual meeting do not resolve an issue or if it is of an urgent nature, then the GC shall appoint and chair a special Issue Resolution Committee which shall include designated representatives of 3ABN and GC, and the affected territory or territories to consider and resolve the issue.
- D. (Step 4) If Steps 1, 2 and 3 do not resolve the issue, the chairman of the board of 3ABN and the GC by mutual agreement shall select a mediator who shall work with the parties to resolve the issue. (This step may come earlier in the process if the parties agree).
- E. (Step 5) If Steps 1 through 4 do not resolve the issue, the issue shall be referred to a three-member Binding Arbitration Committee (BAC) appointed by the General Conference Administrative Committee to review the issue and make a final determination. The General Conference Administrative Committee shall select members of the BAC as follows: (1) It shall request 3ABN and the affected division each to submit a list of three candidates for the BAC; (2) GC Administrative Committee will ask 3ABN to choose one name from the list of three submitted by the affected division and will ask the affected division to choose one name from the list of three submitted by 3ABN; (3) the two members thus selected will then choose any individual to be the third member of the BAC. The three members will choose the chairperson. Both parties agree to abide by the determination of the BAC.

It is intended that this Agreement serve as a long term agreement. Therefore, this Agreement shall remain in effect until terminated by either party as provided for in this Agreement. Each party has the right to terminate this Agreement without cause by written notice given to the other party no less than ninety (90) days prior to the effective date of the notice. Either 3ABN or GC may terminate this Agreement, either in its totality or as it affects satellite distribution in a specific territory, effective immediately, by written notice given to the other party in any of the following events:

A. if either party fails to fulfil or perform any one or more of the duties, obligations, or responsibilities it has undertaken under this Agreement;

- B. if either party assigns or attempts to assign any interest in this Agreement without the other party's written consent;
- C. if there is any transfer or relinquishment, voluntary or involuntary, by operation of law or otherwise of any material interest in the direct or indirect control or any change in management of 3ABN that the GC considers adverse to the interests of the Seventh-day Adventist Church or if 3ABN or any of its public personages or its board members become engaged in matters which the GC Administrative Committee considers adversely affects the interests or good name and good will or reputation of the Church. Upon termination of this Agreement in its totality, 3ABN shall cease to be an authorized broadcaster, distributor, and producer of programming for the GC and will discontinue all services represented to be affiliated with or on behalf of the Church, and neither party shall be responsible to the other for any damages growing out of the termination of this Agreement for any reason whatsoever, including any claim for lost or anticipated income, expenditures, or any other damages. In addition, upon termination of this Agreement, both parties agree to immediately discontinue the use of the names, trademarks, sign, stationery, advertising, or anything else that might make it appear that they are still operating under this Agreement. 7. TRADEMARKS, COPYRIGHTS, AND ORGANIZATIONAL IDENTITY:
- A. Both GC and 3ABN agree to refrain from any activity that leads to confusion, uncertainty, or misrepresentation regarding the use of their respective trademarks and trade names.
- B. Both the GC and 3ABN will respect the legal bounds that separate the GC from the independent 3ABN ministry. Nothing in this Agreement should be held to mean that the GC has assumed any corporate control of 3ABN and its independent programming or that 3ABN has assumed corporate control of the television programming of the Seventh-day Adventist Church.
- C. Copyrights of all 3ABN independent programming will continue to be owned and registered in the name of 3ABN, and copyrights of all programming produced by or for the GC and its affiliated entities will be owned and registered in the name of the GC and/or its affiliated entities.

 8. UNCONTROLLABLE INTERFERENCE:

Neither party shall be liable to the other for failure to perform its obligations under this Agreement due to fire, flood, earthquakes, disturbances, accidents, war, or other causes beyond the reasonable control of the parties.

9. NO ASSIGNMENT:

Neither party of this Agreement may assign any right or interest in this Agreement without the prior written consent of the other party.

10. BINDING EFFECT & SEVERABILITY:

This Agreement shall benefit and be binding upon the successors and assigns of the parties. If any part of this Agreement is void, voidable, invalid, or unenforceable, for any reason, this Agreement shall then be considered divisible as to such part with the remainder of this Agreement remaining a valid and binding.

11. COMPLETE UNDERSTANDING:

This Agreement terminates and supersedes all prior agreements between the parties, if any. This Agreement sets forth the entire Agreement between the parties. This Agreement may be changed, altered, or amended only in writing

signed by an authorized representative of each party.

Re: International Satellite Distribution Agreement

This memorandum summarizes the duties and obligations imposed by the proposed agreement between 3ABN and the General Conference of Seventh Day Adventist ("G.C."). Each numbered paragraph refers to the same numbered paragraph in the agreement:

- 1. Purpose- Although this prefatory paragraph does not affirmatively impose any obligations on either party, it recognizes 3ABN as a non-exclusive distributor of television programming "produced by the GC and its affiliated entities," and further recognizes 3ABN as a "producer of television programming contracted for by the GC and affiliated entities. . . . " This paragraph also states that the Agreement sets for the "respective duties, obligations, and responsibilities of the parties." Although 3ABN is free to produce and distribute other satellite programming, such programming must "not otherwise violate the terms of this Agreement."
- 2. Relationship Between Parties--
- A. A standard contract clause.
- B. This provisions obligates both parties to "recognize the contributions of the other" in promotional efforts.
- C. This provision states that "financial appeals . . . targeted for viewers outside of the North American Division, shall be undertaken only after consultation with the Church governing bodies within the affected territory." While this does not give the GC approval over financial appeals, the obligation to consult with Church governing bodies would require 3ABN to disclose fundraising plans to them.
- D. This paragraph states outright that "any financial relationship between a church entity and 3ABN for distribution of programming will be documented by written agreement and approved beforehand by the designated GC body." In other words, both written agreements and GC approval are required prior to any "financial relationship" for distribution of programming. This paragraph does not state the applicable geographic area, nor is a "financial relationship" defined.
- 3. Programing--

A. No obligations imposed.

- B. This paragraph permits "Church membership" to request discontinuation of 3ABN programming "to the territory they [the Church membership] represent and which the membership considers detrimental to the work of the Church." It is unclear who the "Church membership" would be in any particular territory, but it is clear that the sole decision in terms of what is considered "detrimental to the work of the Church" would be up to that membership. This paragraph also introduces use of the "issues resolution procedure of this agreement."
- C. This paragraph requires "all program production issues [to] be addressed by bodies designated by the" GC administrative committee, which will include 3ABN representatives. Again, it is unclear what would be considered a "program production issue," but that language is so broad as to conceivably include all decision about what programming to produce. Thus, 3ABN would be bound by this paragraph to abide by the "General Conference administrative committee" in making any program production decision.

4 Broadcasting & Distribution ---

- A. This paragraph requires 3ABN to utilize "committees or boards appointed by the General Conference administrative committee" as a "channel" for "developing and distributing television programming by satellite and addressing technical, equipment, financial, distribution and other related issues affecting these territories." This paragraph clearly prevents 3ABN from developing or distributing any television programming without going through the General Conference administrative committee first.
- B. This is another affirmative obligation, providing that "broadcast, cable or other distribution systems for programs received from the 3ABN interdivision satellite distribution system will be either owned or contracted for as determined by the Church governing body in that territory or region." In other words, the LPTV, cable or other distribution system by which 3ABN programming is distributed will either be owned by the Church governing body or the ownership will be determined by the Church governing body in that territory or region. 3ABN may "initiate such contracts" only if the Church governing body makes no decision and affirmatively authorizes 3ABN to make contracts. It is unclear what "contracts" this paragraph is referring to, although it would appear to relate to contracts for ownership of the LPTV or other distribution systems. If the Church governing body does not respond to 3ABN's request, 3ABN sole alternative is to "initiate the issues resolution process."
- 5. Issues Resolution-- The introductory paragraph states that the only forum for determining any dispute under this Agreement is the "issues resolution procedure," as no court is permitted to have jurisdiction over the agreement.
- A. Informal communications are the first step.
- B. If informal communications do not work, the matter is reviewed by "an annual consultation, chaired by the designee of GC," which will include representatives of 3ABN, the GC "and the world territories using 3ABN's satellite distribution services." This appears to indicate that most issues can be reviewed only on an "annual" basis by a committee "chaired" by a GC designee and which includes representatives of all "world territories using 3ABN's satellite distribution services," not matter how limited the problem might be.

- C. If the matter cannot wait until the annual meeting referred to above, a special issue resolution committee will be appointed and chaired by the GC, made up of representatives of 3ABN, the GC "and the affected territory or territories." However, it should be noted that this committee is appointed and chaired by the GC.
- D. If the issue resolution committee cannot resolve the problem, then 3ABN and GC may jointly select a mediator.
- E. If the mediator cannot resolve the issue, a binding arbitration committee ("BAC") will be appointed. Although this paragraph states that the BAC will be "appointed by the General Conference administrative committee," it appears that the GC administrative committee and 3ABN each get to choose an arbitrator and the two arbitrators select a third arbitrator to reach a binding decision.

Binding arbitration, as described above, is often not the best choice for dispute resolution--the arbitrators' incentive is to compromise, which the parties could do themselves, if it were the right result. In addition, these provision have been written in such a say that the GC has "stacked the deck"--at each step there will be a larger number of persons who would have reason to favor the GC.

- 6. Term of Agreement—The agreement may be terminated without cause by either party on 90 days written notice. Under certain conditions, the Agreement may be terminated within a specific territory without having to wait 90 days. Upon termination of the Agreement, however, 3ABN shall no longer be considered "an authorized broadcaster, distributor, and producer of programming for the GC and will discontinue all services represented to be affiliated with or on behalf of the Church " Thus, it appears that termination of the Agreement in its totality would, in essence, sever all ties between 3ABN and "the Church." It is unclear to me under what authority the GC can require such separation.
- 7. Trademarks, Copyright & Organizational Identity-- 3ABN continues to own copyright to all of its "independent programming." However, this paragraph contains an unusual statement that both parties "will respect the legal bounds that separate the GC from the independent 3ABN ministry." It is unclear why such statement would need to be made, unless the GC does not usually respect such bounds--or is planning to disregard them in stances covered by this agreement.
- 8. Uncontrollable Interference-- This is known in most contracts as "force majeure," and is nothing out of the ordinary.
- 9. No Assignment-- No assignment is permitted without the prior written consent of the other party. It is unlikely that either party would want to assign its rights to a third party in any event.
- 10. Binding Effect & Severability-- A standard contract clause.
- 11. Complete Understanding-- This is also a standard contract clause and provides that this written agreement represents the entire agreement between the parties and "terminates and supersedes all prior agreement."
- I did not receive any pages after page 3 and cannot speak to any provisions that might have appeared on later pages of the Agreement. I hope this is of some use and would urge you to contact me if you have any questions

concerning this matter or if you would like any assistance in either revising this Agreement or drafting a new one.

The two documents immediately above in this thread are part of a group of documents from the Spring of 1997 most of which are posted beginning with post #12 of this thread and continuing through about post #21.

They are not all in exact order, so to really make sense of them it would be helpful for you to print them out so you can line them up and compare them and put them in their correct order. The reason I reprinted one of these above was because the document giving the 3abn attorney comments on the proposed contract was never posted with the rest of the group when they were put up last spring.

If you make this "time line" you will see that at the end of it, the correspondence ended with 3abn refusing to sign the contract offered by Folkenburg, in fact one of the letters is from Bill Hulsey, at that time board member, who stated that they would not consider any kind of "contract" with the GC. And instead they sent a general statement of 3abn support for the church.

That was the last document that I had in my possession from the 1997 time frame.

However, just recently Panama Pete posted a document from later that year.... dated November, 4, 1997. which is called "Joint Declaration of Commitment by the General Conference of Seventh-day Adventists and Three Angels Broadcasting Network". This is post #20, in the thread "3abn?, Left Out", and it can be found at http://www.blacksda.com/forums/index.php? s=&showtopic=11339&view=findpost&p=158460 followed by additional discussion of the document, including comments on how Danny has used this through the years.

In reading this through carefully several times, I am struck with the onesidedness of it.... and the very limited areas in which there was agreement to have some kind of arbitration and that was ONLY in programming.... and could only be initiated by a very high level group. Seemingly no individual or even any media center person could appeal directly to the GC to set the arbitration process in motion. Here is the wording of that paragraph.....

"In the event of a disagreement between 3ABN and a duly authorized Executive Committee of a world Division of the Seventh-day Adventist Church regarding programming which the the Division Executive Committee believes is detrimental to the mission of the Church, "

Frankly, I cannot help but wonder what it was that caused Folkenberg to agree to these stipulations.... assuming of course that he did agree to them, for I don't know of anyone so far that has seen a signed copy..... which gives all of the advantages to 3abn and leaves the GC with no authority to have anything to say about the operations or choices of programming other than this one

vague and very limited clause.

We have had multiple people testify to the way Danny uses various kinds of coersion to get what he wants. Isn't the most logical explanation that the GC persons who saw and signed this did so under some kind of duress?
