This thread has wandered far away from the original comment of the thread and from what seemed to be the direction the creator of the thread wanted to go, as indicated by his subheading, "Fact vs. Fiction".

First a comment on the subhead......

As I have mentioned before, the phrase "The truth is stranger than fiction" has often been affixed to the various stories coming out of 3ABN. I would like to add to that, that FACT is not only "stranger than fiction" but it is very often a great deal more unpleasant ... even downright revolting. If one is writing fiction, one is free to paint rosy pictures, to make everything come out right at the end, to make sure the "good guys" always wear white hats, and the "bad guys" always wear black ones. When one is dealing with real life and with facts rather than fiction, this is not so. The worst kinds of evil can come "garbed in garments of light". The pleasant smooth things are often the worst falsehoods, and the harshest and most repulsive facts are often the truth

Most likely DrRe' based her comment on what has been previously learned here on BSDA about the "true beginning of 3ABN".... in contrast to the "first miracle stories" which have been told about it. But I would say that actually, Melodie's response was the only one that could reasonably be made, given what she knew about that "first miracle story".

I seem to recall it being discussed in more than one thread, but the main one that I could find, was the thread entitled "Danny Marries again"

In deference to the rule that posts cannot be copied from one thread to another, I will only bring three brief excerpts from the discussion there, and give the url of these posts so you can go to that thread to read the whole discussion.

On Apr 11 2006, 08:05 AM ... Post #194 of the above named thread, Sister included this paragraph in a post that dealt with a number of things other than this.

"Any man who begins his ministry founded on "a first miracle" that can be easily proven to be nothing more than a lie, should be suspect. When two of the current top people in his ministry are the ones, Molly and Hal Steenson, who suggested the "miracle" and were willing to forge documents to

substanciate it and over the years both they and Danny have continued to sell it to the people---there is a lot more going on "in the name of God" at 3ABN than you can imagine." See the context and read the discussion at:

Later that day, in Post #200, Clay asked ... "what is this "first miracle" some have referred to that started 3ABN? What have I missed?"

And in Post #203 Sister gave a more complete explanation of the facts behind the "story", with this passage being the basic facts.

"Before 3ABN started, Danny met with the Steensons when they were charismatic pastors and they offered to put on paper that they were donating around \$100,000.00 worth of television equipment to him. That was the first "miracle" story that started the money rolling in. No equipment was ever donated by the Steensons, other than an SM-58 microphone that didn't work. To this day that story is told as the miracle that started 3ABN, but it is false. The first camera equipment at 3ABN came from Joe Crews at Amazing Facts and was purchased on a barter deal for air time."

As to the question of "throwing out the baby with the bathwater" it simply does not apply in this situation.		
As far as what effect our letters on either side of the issue with DISH would have at this time at best they will be completely ignored and ineffective, and at worst they could worsen the situtation for the future. Or to put it another way the present is already fixed. We can stop trying to affect what already is. We need to wait until the future comes to see what will be appropriate action in view of whatever that "future" looks like when it becomes the present.		
There are plenty of other places where those who wish to be activists can be of real help. Contact your friends and church leaders and direct them to BSDA to learn what we are saying about 3ABN. Contact other places like Palm Springs who already have "rallys" scheduled express your disappointment in their plans direct them to BSDA where they can learn more about why you are disappointed in them. I am still an activist. There is only this one item of activism that I had previously recommended, but when I checked to find out whether it was advisable or not, I found that it was not. But other than that, KEEP ON KEEPING ON with spreading the word in whatever venues you have opportunity.
