I know of 2 different families with the last name of Schneider who attended WA in the latter 60's and early 70's. The 2 families I knew were not related. Steve Scheider who died in the Waco fire had 2 sisters, one in the class of 1969 and the other in the class of 1970. They were community students and Danny was a dorm student at that time. Steve S. graduated in 1968. Danny attended WA during the school year of 1967-68 and was in the junior class at the time, which was the class of '69. From my recollection (also a student at the time), DS did not stay at WA for that entire school year, leaving before second semester began and did not return for his senior year the following fall. So he may or may not have even known SS during his short stint at WA....especially since the juniors and seniors did not attend classes at the same time of the day. 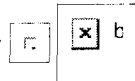

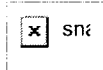

We also have large metal fire doors at strategic points throughout the building. In the event of a fire the doors, held open by electromagnets, close as the magnets electrical current is cut. Likewise, the

locks requiring the fobs are deactivated rendering the building fully escapable. To manipulate the system and insure that people would be trapped takes a very high level of expertise and experience with the system. With only the smidgen of information provided, and no follow up to more accurately define the system (installed at 3ABN) to point out its potential hazards, I am going to assume that the system is much like the one I experience every day at work. After talking with our building manager and maintenance man i discovered there are many safety fall backs built into the system to insure that no one gets locked in during an emergency. It seems to me that a similar system has been put in place at 3ABN and is completely safe for all of the employees.

The second quote was the first of many that attempts to weave together comments to paint a picture connecting Danny with a David Koresh follower. This whole discussion is thinner than tissue paper. 



(Don't know if it's Hal, but definitely from 3ABN!) 

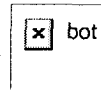


To respond to FHBS request for info - just read his post. Amazingly enough, that's the way it works.

 1926.34(a)

General." In every building or structure exits shall be so arranged and maintained as to provide free and unobstructed egress from all parts of the building or structure at all times when it is occupied. No lock or fastening to prevent free escape from the inside of any building shall be installed except in mental, penal, or corrective institutions where supervisory personnel is continually on duty and effective provisions are made to remove occupants in case of fire or other emergency.

1926.34(b) 

Exit marking." Exits shall be marked by a readily visible sign. Access to exits shall be marked by readily visible signs in all cases where the exit or way to reach it is not immediately visible to the occupants.

1926.34(c)

Maintenance and workmanship." Means of egress shall be continually maintained free of all obstructions or impediments to full instant use in the case of fire or other emergency.
