That depends on whether enough of them had gotten together so as to feel somewhat safe in speaking out. The very first conversation that I had with someone who had worked at 3ABN for years started out with that person saying ..... this is NOT about Linda. The financial "irregularities" (to put it as kindly as possible) were an ongoing thing before Danny ever made his first move against Linda. His CFO had resigned because of what she described as "illegal" things she was being asked to do long pefore the "Danny vs Linda" battles began. The immoralities of those prominent in the ministry have a nuch longer history than merely the past two years. The problems caused by Directors of 3ABN who aught and encouraged Danny in his claims to being a special mouthpiece of God .... all of these existed prior to, and continue on to this very day, with these basic beliefs showing up ever more platantly on TV as time goes on rather than being more or less confined to the 3ABN "compound".

All of these .... including the extensive moral abberations need to be fully known to the public. Otherwise, those that are coming to the point of recognizing that there must be a "Housecleaning" of major proportions at 3ABN will be all to liable to think that they will have done their job if they only sidline Danny and force him to stop speaking against Linda.

Yes, I would have. The IL vs. 3ABN Property Tax Lawsuit came out **BEFORE the divorce**. It clearly states that financial dealing of 3ABN were not honest. How can a Corporation 20 years old, explain that they do not follow GAAP?

It says that the valuing of Trust funds was questionable. Their value was determined by 3ABN. They were never appraised by qualified people. Example: A non-cash gift is given to 3ABN. It would have appraised for say \$500,000. Yet, 3ABN assess the value at say \$20,000 and sells it to family or friends.

Many of their assets were never found! They were not reporting Lease/Rental income from the entities that are not 3ABN. Like Subway, a barber shop.........

It's important to know that Danny Shelton does **all** hiring and firing. He chooses who works at 3ABN and who does not.

Danny has been:

- (1) hiring more of his relatives and has been featuring more of them on the network more often.
- (2) the Shelton relatives that are appearing on TV are mentioned in the first-hand accounts. And there are **two more** first-hand accounts than there were in June.
- a. Arild Abrahamsen's account made available to us about July 20.
- b. Barbara Kerr's account made available to us within the last few days.

<u>Tommy Shelton</u> is mentioned in the Barbara Kerr letter as being in charge of programmming and telling Barbara that she wouldn't be needed any more.

<u>Melody Shelton</u> is mentioned in the Abrahamsen letter as being acceptable to appear on the network when Linda was not.

3ABN uses the phrase "Your 3ABN Family" over and over as a form of conditioning.

Subconsciously, some may feel that Kay Kuzma, Brenda Walsh, and John Lomacang are somehow members of that extended "3ABN Family" when such is not the case. As a result, the "expansion" into the rest of the "family" may seem bigger than it is. For an example of the non-related **3ABN Family**, Kay Kuzma is mentioned as not including Barbara Kerr in the recent book.

To understand what is in the "pinned" letters, you would have to understand who the "on-air" network employees are and who comprises this extended **3ABN Family**.

I do understand that as the story unfolds in any book, the characters get fleshed out chapter by chapter. It's part of the normal course of events in any story. At the beginning of every book there is a section journalists call the exposition. We're forced to add to our own exposition as more and more people gather the courage to come forward. That's why is seems like an expansion.

I would expect, however, that these first-hand accounts by Barbara Kerr and Arild Abrahamsen have resulted in outside "pressure" by the same people who were pressuring Stan Jensen at ClubAdventist. Would that be fair to say?

In reality, it's the people who hired the private investigators who have been doing the real "hunting." Our "expansion" has been, more often than not, a response to some event precipitated by those hunters.

The first step in healing after sexual molestation is to recognize the abuse. It is traumatic, to be sure, but it is also freeing and the beginning of healing. (I have witnessed more than one occasion of such a point of recognition of abuse long sealed off in the mind, and the trauma can hardly be underestimated.)

In the daughter's case what adds to the confusion is that she would surely like to be a singer, and the father is enabling that dream. Even if she is beginning to realize the wrong that has been done to her, how can a young woman whose self-image has been so distorted by molestation take the step to freedom without outside help? Add to that the fact that the abuser is likely the source of significant financial support.

Next to Dan Shelton's heartfelt confession and repentance, the best thing that could happen to Dan Shelton's daugher is that he be exposed for what he is. Then she will need a **lot** of support. We can only hope that the Mr. Firestone she married is a decent and stable man who can give her some of that support. I sure hope that he's not working for 3ABN!
