Word Network exec leads flashy life, court records show

TV chief owns three homes, despite bankruptcy filing.

The co-founder of the world's largest black gospel channel - Southfield-based **The Word Network** - still is living large even while trying to convince a bankruptcy judge that he's broke.

According to documents released Tuesday in U.S. District Court in Fort Myers, Fla., Kevin Adell owns three homes; drives a Bentley, Hummer and Porsche; purchased \$15,000 worth of jewelry for his wife; and spends \$14,000 a month.

The spending shows Kevin Adell, 37, should not be eligible for Chapter 11 bankruptcy protection, claims his largest creditor, John Richards Home Building Co. of Bingham Farms. The home builder also is claiming that Adell is attempting to shield his assets through The Word Network and other broadcast companies owned by his father, Frank Adell.

U.S. District Court Judge Alexander Paskay in Florida is expected to rule on Kevin Adell's bankruptcy petition in the coming weeks. He also will decide if a Michigan court can go after assets of the Adell Broadcasting and Satellite Television Network.

Frank Adell owns Mount Clemens-based WADL-TV, Adell Broadcasting Corp. and Satellite Television Network Inc. Kevin Adell is president of The Word Network and STN and vice president of WADL-TV, Channel 38.

A spokesperson for Kevin Adell and The Word Network disputed claims that any assets have been hidden. "The Word and STN are separate and distinct ... and have absolutely nothing to do with Mr. Adell's bankruptcy trial," Sam Riddle said. "We don't comment on (Kevin) Adell's lifestyle. But I remind you that Donald Trump has gone bankrupt before."

Four years ago, Kevin Adell co-founded The Word, which grew into one of the nation's most successful religious broadcast companies by beaming African-American church services to 34 million households.

But a bitter legal dispute between Kevin Adell and John Richards Home caused Adell to move to Florida and seek bankruptcy protection. The dispute arose over a \$3 million home, owned by John Shekerjian, that John Richards was building for Adell. After the two sides disagreed on progress of construction of the home, Adell sued the home builder and later attempted to force him into involuntary bankruptcy. Adell also hired a public relations firm to publicize the bankruptcy claim, which the home builder claims devastated his reputation. A federal judge ordered Adell to pay \$6.4 million, including \$2 million in punitive damages.

In May 2003, shortly after the judgment, Adell took steps to protect his wealth. He cashed in \$1.7 million in U.S. Treasury bills and sold 12 vehicles in one day - including a **Porsche, two Bentleys, a Ferrari and a Lamborghini** - according to court documents. Adell then moved to Florida, paying **\$2.8 million in cash for a home** in Naples, where state laws make it difficult for creditors to seize a person's house.

A Network's Tactic For Getting on Air: Protest Politics

Religious Channel Called In Prominent Blacks for Help;

White Family Benefited

On a rainy morning in March 2002, three buses of African-American protesters emptied in front of the headquarters of Charter Communications Inc., a cable-TV operator, in suburban St. Louis. Soon a limousine pulled up, and the Rev. Al Sharpton stepped out to lead the demonstrators in chants of "No Justice, No Peace."

Within a few weeks, Charter met the protest organizers' main demand: that the company begin carrying the Word Network, a three-year-old cable and satellite channel whose programming consists mainly of African-American church services.

Thanks to such tactics, the Word Network has become one of the nation's top five religious networks, beamed by satellite or cable operators into 32 million households, mostly in the U.S., according to Word officials. Some of the country's most-prominent black leaders -- including the Rev. Jesse Jackson, Dick Gregory, Martin Luther King III and Johnnie Cochran Jr. -- have interceded on Word's behalf.

In return, many of the organizations run by the activists have received donations from backers of Word, according to Rev. Sharpton, Rev. Jackson and other participants. Rev. Sharpton and Rev. Jackson declined to say how much they've received. Others familiar with the matter say that their customary fee was about \$10,000 plus expenses per event. "It is not unusual for people that we help to help the organization," Rev. Jackson says. "That does not affect our integrity at all. It's the way we survive."

But Word is an unusual cause for African-American activists. The network, a nonprofit organization, is controlled by Kevin Adell and his father, Frank Adell, members of a white Detroit-area family that made a fortune in the auto and broadcasting businesses. A substantial portion of the network's revenue, which was \$7.6 million in the year that ended May 31, 2002, has gone to pay other Adell companies for rent, satellite transmission and other services, according to court documents reviewed by The Wall Street Journal.

Neither Kevin, 37 years old, nor Frank Adell, 75, who serve as president and chief executive of the Word Network, responded to repeated requests for an interview.

African-American leaders have been using confrontational tactics with U.S. businesses for more than 20 years to increase minority hiring, funnel business to black vendors and cease discriminatory practices. Facing boycotts, lawsuits and protests, numerous large corporations have made concessions, including Texaco Inc., Coca-Cola Co. and the Denny's restaurant chain. For black leaders, the tactics were justified to overcome years of racism.

In the case of Word, backers say playing hardball was necessary to make up for the television industry's history of discrimination and negative portrayal of blacks in programming. "We were not in the shakedown business," says Sam Riddle, one of the protest's lead organizers. "We were in the shakeup business."

The Adells also have a history of receiving the support of African-American activists for business and personal legal battles with a tenuous connection to Word. But in recent years, they have met increasing skepticism. Four black clergymen who were involved in the initial discussions about the Word Network sued the Adells shortly after Word was formed, charging that they were not given the ownership stakes and other participation they were promised. That case was settled out of court for undisclosed terms.

Meanwhile Kevin Adell's personal legal battles, such as an effort to force a homebuilder into involuntary bankruptcy, have caused other black leaders, including Rev. Sharpton, to distance themselves from the family. "Does Kevin pimp racism for his own personal ends?" asks Mr. Riddle. "It could certainly be perceived that way."

#### Building a Fortune

Frank Adell and his brothers, Robert and Marvin, built the family fortune in the 1960s and 1970s. Their company, Adell Industries Inc., made the stainless-steel moldings that fit over the edge of car doors, a feature that Robert patented. The brothers had a falling out in the late 1980s and eventually went to court over the breakup of the company. Today Marvin, 68, still runs the enterprise and says he doesn't speak to Frank anymore. (Robert is deceased.)

In the early 1980s, Frank Adell became interested in broadcasting and aligned himself with a group of prominent African-Americans in the Detroit area to bid on Channel 38, the last full-time commercial television license available in the region. The group, which formed Adell Broadcasting Corp., eventually included Horace Sheffield Jr., a prominent labor and civil-rights organizer, who died in 1995. His son, the Rev. Horace Sheffield III, is head of the Detroit chapter of Rev. Sharpton's National Action Network.

James Panagos, who was Adell Broadcasting's original programming manager, says the Federal Communications Commission granted Adell the license partly because its stockholders included minorities. An FCC spokeswoman says that the agency used to weigh minority ownership when making licensing decisions but stopped the practice more than 10 years ago in response to court challenges.

Adell Broadcasting tailored much of Channel 38's programming to the Detroit region's large African-American audience. The station began selling time to black ministers, charging about \$500 to \$600 per half hour, Mr. Panagos says. Infomercials were a staple of the station's schedule, he says.

In 1999, the Adells devised a plan for a national network focusing on gospel music and black church services. They organized a group of five African-American clergymen in the Detroit area to travel to El Segundo, Calif., to meet with executives of DirecTV, the country's largest satellite-television company. Rev. Jackson also attended the meeting, which was intended to persuade DirecTV to carry the new Word Network.

The day before they met with DirecTV, the clergymen asked for a stake in the new network at a meeting with the Adells, according to Denise Johnson, a broker of religious media who helped the Adells arrange the participation of the five clergymen. She says the Adells agreed to give each clergyman a 3% stake.

DirecTV executives agreed to carry Word partly because officials believed that the ministers were owners and active participants, according to people with knowledge of the situation. As the launch date approached in early 2000, however, four of the clergymen had a falling out with the Adells and eventually filed a lawsuit alleging that the Adells weren't honoring their

commitments. (Bishop Charles Ellis III, the fifth clergyman, is the only African-American serving on Word's board, according to its most recent tax filing.)

In legal papers responding to the four ministers' lawsuit, the Adells denied that they had promised to make the ministers partners in Word.

#### Fee Structure

Word's revenue comes primarily from the fees ministers pay to have their services carried, currently about \$2,500 per half hour, according to Lewis Gibbs, the network's head of operations. The ministers typically earn a portion of that revenue back by using their programs to sell tapes, CDs and other material.

Much of Word's revenue is pumped back into other Adell companies. The Adells own Word's headquarters building in suburban Detroit. And in a 1999 document obtained by a division of Hughes Electronics Corp. in a separate Adell legal battle, Word agreed to pay an Adell entity called Satellite Television Network Inc. a fee equal to 95% of Word's net programming revenue or STN's costs, whichever is lower. The fee covers STN's legal fees, payments to contractors, supplies, and salaries and overhead expenses related to its transmission of Word's signal to DirecTV.

To sell time to ministers, the Word had to persuade other cable and satellite operators besides DirecTV to carry the network. It hired Betsy Kellman, a veteran cable executive, who began to pitch Word to the heads of programming of numerous operators. But heavy competition for available channels made Word a tough sell.

"When [Word] took a traditional approach, the result was zip," Mr. Riddle says. "When we started kicking down the door, carriage zoomed."

In the spring of 2000, Kevin Adell and Rev. Sharpton showed up unannounced at the headquarters of what was then AT&T Corp.'s cable operation. AT&T Broadband had been talking to Word about a possible deal, but nothing had been finalized.

Allan Singer, the No. 2 executive in charge of programming, ushered the two visitors into a conference room, and Rev. Sharpton soon began yelling at him, accusing the company of discrimination, according to someone familiar with the situation. Almost immediately after the meeting, AT&T Broadband agreed to carry Word. Rev. Sharpton says he doesn't recall the meeting. AT&T Broadband has since been sold to Comcast Corp., which declined to comment on the internal meetings of the prior owner.

At about that same time, Mr. Riddle says he began working on behalf of Word. Mr. Riddle, 57, has been a well-known activist since 1972, when he led a civil-rights demonstration that shut down a Big 10 basketball game between Michigan State University and the University of Iowa. "My history is one of confronting and then exacting concessions," he says.

Mr. Riddle, who lives in the Detroit area and makes his living as a political and media consultant, says he planned most of the demonstrations with Rev. Sheffield, keeping Kevin Adell apprised. When they targeted a cable or satellite company, they typically would first reach out to local civil-rights organizations to get them involved. In some cases, Mr. Riddle gathered protesters from homeless shelters, fed them breakfast and gave them about \$50 each. "I like to refer to it as 'rent a demonstration,' " he says.

The pressure tactics wouldn't have been necessary if cable and satellite companies offered more positive programming about African-Americans, says Mr. Riddle, who argues that too many of the blacks seen on television are involved in sex, drugs or violence. "We gained carriage because we were right," he says.

Rev. Sharpton or other representatives of the National Action Network and its chapters attended protests at the headquarters of EchoStar Communications Corp., Charter, Mediacom Communications Corp., in Middletown, N.Y., and XM Satellite Radio, in Washington. Protesters called the homes of

executives of Charter, EchoStar and Mediacom. A few also showed up at the home of EchoStar's chief executive, Charlie Ergen, and at a high-school basketball game in which his daughter was playing.

Rev. Sharpton, who is running for president, says his work for Word was limited to consulting and attending meetings with cable and satellite executives on the network's behalf. When he participated in demonstrations at cable and satellite companies, he says, it was only to protest hiring or other discriminatory practices. "It had nothing to do with whether they carried the Word," he says.

Mr. Riddle, who says he helped arrange for Rev. Sharpton to attend the protests and occasionally paid him, says the main purpose of the protests was to force the operator to carry Word. "The objective was to open up the satellite and cable industry to value positive programming like the Word, and Sharpton was a key player," he says.

Word initially approached Charter in 2000 soon after the network was launched. Ms. Kellman pitched the network to Patty McCaskill, who was then Charter's vice president of programming. Ms. McCaskill replied that Charter carried other religious networks that included black clergymen and that it would be prohibitively expensive for Charter to add the equipment necessary to pick up the Word's signal, according to people familiar with the situation

About nine months later, Mr. Adell visited Charter to try again. Ms. McCaskill told him the same thing. He responded by noting that Word has a lot of support in the African-American community, these people say.

A month or so later, Charter got a phone call from a National Action Network chapter saying that representatives wanted to meet to resolve a number of issues. When they came in a few weeks later with Mr. Adell, they began by raising concerns about Charter's minority-hiring practices and use of African-American vendors. Only after that did they bring up Word. They also maintained that they were operating independently of Word, people familiar with the situation say. A Charter spokesman declines to comment on the meeting. A spokesperson for Ms. McCaskill, who left Charter earlier this year, also declines to comment.

Once Charter agreed to carry Word, the protesters' demands for action on hiring practices and the use of minority suppliers virtually ceased, according to people familiar with the situation.

Soon after the Charter protest, African-American organizations came to Mr. Adell's help in a personal dispute: a legal fight over a \$3.1 million home he was trying to build in Bloomfield Hills, a Detroit suburb. Mr. Adell filed suits accusing John Richards Homes Building Co., Birmingham, Mich., and a unit of Charter One Financial Inc., of conspiring to inflate the value of the land, among other things.

As the lawsuits were being filed, groups including the Michigan chapter of the National Action Network issued a news release accusing Charter One of discriminatory lending practices and other abuses, and organized several demonstrations in front of the bank's Cleveland headquarters. At a meeting with bank officials and Mr. Adell, protesters brought up Mr. Adell's lawsuit, alleging he was being treated unfairly because of his association with Word, according to people who were there.

Mr. Adell later tried to force John Richards into involuntary bankruptcy. A U.S. bankruptcy court quickly dismissed that effort and earlier this year awarded John Richards \$6.4 million in damages, one of the largest judgments ever assessed against someone for a wrongful involuntary bankruptcy filing, bankruptcy attorneys say. "Adell's conduct was reprehensible and must be deterred and punished," wrote U.S. bankruptcy Judge Steven Rhodes in his ruling.

Partly because of the John Richards case, which is under appeal, **Rev. Sharpton is rethinking his association with Mr. Adell**. "My whole relationship with his organization is something I'm reviewing," he says.

John Richards principals have had a difficult time collecting because Mr. Adell has taken steps to shield his assets, including moving to Florida. There, he bought a **\$2.8 million home** to take advantage of that state's homestead law, which makes it very difficult for creditors to seize residences. When marshals arrived to seize the contents of Mr. Adell's suburban Detroit home, the

only thing left inside was a picture of a monkey with a note from Mr. Adell saying it should be saved for John Richards's lawyer, Norman Ankers.

In recent months, the protests on Word's behalf have slowed. Mr. Adell has been fighting to hold onto his home in Florida. In September, Judge Rhodes ruled that he can't use the state's homestead law to shelter the home from his creditors, partly because he failed to demonstrate that he intended to live in Florida permanently. On Nov. 14, three days before Mr. Adell's deadline for selling the house passed, Mr. Adell filed a petition in Florida seeking bankruptcy protection.

Meanwhile, Mr. Adell also has been busy trying to start a new network in Florida, Cubana One Network, which he also structured as a tax-exempt organization that is to feature programming targeted at Florida's large Cuban population.

In August, Cubana One issued a press release criticizing Bright House Networks, a major Florida cable operator, for not meeting with Mr. Adell and another network executive. It quotes Hilda Luisa Diaz, of the Jose Marti Educational Foundation Inc., as saying: "If there is space for six porno channels, there should be at least one channel available to disseminate ... uplifting family entertainment."

Soon after, Bright House executives agreed to meet, but a company spokeswoman says it has no plans to add the network at this time.

"Bearing False Witness... Part 2"

As of now, only briefly have I alluded to Linda Shelton in this story of the history of 3ABN. Perhaps

Linda smiles as her mind is briefly drawn by the carefree sound of her children's laughter and the healing that God continues to bring in their lives, to make moments like these possible. Again her thoughts return to the eternal promises she is reading on the pages before her. Another smile lights up her face, this time it is the knowledge that her hope and future do not lay in the grasp of an earthly tyrant, but in the assurances she receives from her loving Savior. It is He that will remove the shame that the falsehoods of her accusers have heaped upon her and cover her with his robe of righteousness. Here in His Word is found the peace of mind and the safety for which she longs. This time the rack is not a bloodstained wood structure, and the executioner doesn't wear a black hood. This time it is not the victim's body that is ripped apart; it is the soul. This time it is not the Inquisition who accuses, convicts, and executes the victim, but a televangelist. This time there is a different church."

Although no names are ever revealed, the apparent intent of the author shouts out to me, riveted, I continue to read on in a far too familiar story. Pausing for comparison between fact and "fiction", I pick up my bottle of mineral water. Unscrewing the cap and setting it next to me, I pick up the bottle only to lay it down again, my thirst forgotten. The name of a member of BSDA flashes into my mind: Summertime. What I am now reading has the same savor as an experience she had in corresponding with Danny. Remembering the open water bottle, I watch the bubbles slowing escaping to the surface, taking a sip and screwing the cap on the bottle, I reread the last two paragraphs:

"The televangelist gets up and goes to his computer. The monitor casts a bluish glow on the face of the man who just switched on its power. The reflection in the monitor reveals a middle aged face peering intently over a pair of reading glasses. Opening up his email, the televangelist reads an email accusing him of wrong-doing. Thanks for your interest. While Beartrap would be the only one (that I know of) who is posting here that could give you an "insiders" (at that time) view of the rationale given around 3ABN itself, I can give background information on the underlying reasons for the rejection of the contract.

In the packet of information sent out at the time from 3ABN, there was also a copy of an evaluation of the contract that was done by a 3ABN lawyer. I don't think I understand the legaleze enough to even be real sure as to what it said. It's lengthy, but I can post it here if anyone is interested in examining it. But that is of little value, since the real reasons they rejected the contract do not lie with the specific items, but with the idea of having a formal "signed contract" of any kind.

In partial "defense" of the rejection it is only fair to point out that at the time this came up, not only independent ministries, but official church institutions, especially educational institutions of higher learning, were also concerned about Folkenberg's efforts to get everyone in line with his thinking, even to the extent of trying to require "loyalty oaths" on key points of practice and doctrine. So from one angle 3ABN could be excused for resisting a contract on this basis.

However, that is not the whole story, nor does that account for 3ABN's resistance from the beginning to taking any guidance or to having any lines of accountability to the church they claimed to be serving. That the "reasons" do not lie in the specific stipulations of the contract itself, but in something much more basic than that, can be seen by a careful reading of the letter from Bill Hulsey, which I posted yesterday. If you will notice, he makes no complaints about specific language or requirements in the proposed contract. His objections are to the very notion of having any contract at all.

This may not be seen as significant by those not acquainted with the attitudes held in the old "self-supporting work" which are held as models for many (though not all) "Independent Ministries" today. The primary one being a deep distrust of what they call the "organized work", that is to say the Conference structures. The phrase "kingly powers", when applied to church leaders, comes straight from these sources. And the condemnation and fear of control by the "organized church" which this phrase indicates, follows recognized psychological functions of betraying their own desire for control, as can be clearly seen as one examines this type of Independent Ministry.

If you combine this with the principles (almost doctrines) held by these groups--that of the function of the "prophet, priest, and king" God assigned roles, then you have the solid, unshakable ground for resistance to any "signed contract" which deprives (or even limits) the power, control, and even leadership (of the church itself) function of the Independent Ministry. **Quiz: Is Your Boss a Psychopath?** The standard clinical test for psychopathy, Robert Hare's PCL-R, evaluates 20 personality traits overall, but a subset of eight traits defines what he calls the "corporate psychopath" -- the nonviolent person prone to the "selfish, callous, and remorseless use of others." Does your boss fit the profile? Here's our do-it-yourself quiz drawing on the test manual and Hare's book Without Conscience. (Disclaimer: If you're not a psychologist or psychiatrist, this will be a strictly amateur exercise.)

For each question, score two points for "yes," one point for "somewhat" or "maybe,"

and zero points for "no."

## [1] Is he glib and superficially charming?

Is he a likable personality and a terrific talker — entertaining, persuasive, but maybe a bit too smooth and slick? Can he pass himself off as a supposed expert even though he really doesn't know much about the topic? Is he a flatterer? Seductive, but insincere? Does he tell amusing but unlikely anecdotes celebrating his own past? Can he persuade his colleagues to support a certain position this week — and then argue with equal conviction and persuasiveness for the opposite position next week? Can he appear on TV and somehow get away without saying anything truly substantive?

"Is Your Boss a Psychopath?"...

The following quiz, edited for length and application, appeared in issue 96 of Fast Company, a business magazine. Perhaps Johann, Beartrap, Brother Sam, PaperTigers and others would like to take the quiz and comment on it's applicability to the history of 3ABN...

**Quiz: Is Your Boss a Psychopath?** The standard clinical test for psychopathy, Robert Hare's PCL-R, evaluates 20 personality traits overall, but a subset of eight traits defines what he calls the "corporate psychopath" -- the nonviolent person prone to the "selfish, callous, and remorseless use of others." Does your boss fit the profile? Here's our do-it-yourself quiz drawing on the test manual and Hare's book Without Conscience. (Disclaimer: If you're not a psychologist or psychiatrist, this will be a strictly amateur exercise.)

For each question, score two points for "yes," one point for "somewhat" or "maybe," and zero points for "no."

## [1] Is he glib and superficially charming?

Is he a likable personality and a terrific talker — entertaining, persuasive, but maybe a bit too smooth and slick? Can he pass himself off as a supposed expert even though he really doesn't know much about the topic? Is he a flatterer? Seductive, but insincere? Does he tell amusing but unlikely anecdotes celebrating his own past? Can he persuade his colleagues to support a certain position this week — and then argue with equal conviction and persuasiveness for the opposite position next week? Can he appear on TV and somehow get away without saying anything truly substantive?

## [2] Does he have a grandiose sense of self-worth?

Does he brag? Is he arrogant? Superior? Domineering? Does he feel he's above the rules that apply to "little people"? Does he act as though everything revolves around him? Does he downplay his legal, financial, or personal problems, say they're just temporary, or blame them on others?

## [3] Is he a pathological liar?

Has he reinvented his own past in a more positive light? Does he lie habitually even though he can easily be found out? When he's exposed, does he still act unconcerned because he thinks he can weasel out of it? Does he enjoy lying? Is he proud of his knack for deceit? Is it hard to tell whether he knows he's a liar or whether he deceives himself and believes his own bull?

# [4] Is he a con artist or master manipulator?

Does he use his skill at lying to cheat or manipulate other people in his quest for money, power, status, and sex? Does he "use" people brilliantly? Does he engage in dishonest schemes such as

cooking the books?

[5] When he harms other people, does he feel a lack of remorse or guilt?  Is he concerned about himself rather than the wreckage he inflicts on others or society at large?  Does he say he feels bad but act as though he really doesn't? Does he blame others for the trouble he causes?  SCORE
[6] Does he have a shallow affect?  Does he make brief, dramatic displays of emotion that are nothing more than putting on a theatrical mask and playacting for effect?  SCORE
[7] Is he callous and lacking in empathy?  Does he not give a d about the feelings or well-being of other people? Is he profoundly selfish?  Does he cruelly mock others? Is he emotionally or verbally abusive toward employees, "friends," and family members? Can he fire employees without concern for how they'll get by without the job?  Can he profit from embezzlement without concern for the harm he's doing?  SCORE
[8] Does he fail to accept responsibility for his own actions?  Does he always cook up some excuse? Does he blame others for what he's done? If he's under investigation for a corporate crime, like deceitful accounting, does he refuse to acknowledge wrongdoing even when the hard evidence is stacked against him?  SCORE

Since August 2005 Danny Shelton has regularly featured his brother, Kenny Shelton (anti-Seventh Day Adventist dissident) on 3ABN. As of October 15, 2005 Kenny Shelton is representing 3ABN at Rallies in Seventh-day Adventist Churches, and at the Ten Commandments event. In the October 2005 issue of Land Marks, John Grosboll's radical anti-Adventist magazine, Kenny Shelton is a featured author encouraging the readers to leave the Seventh-day Adventist Church because it is not God's true church.

Not many years ago, Kenny was pastoring a Seventh-day Adventist Church in Herrin, Illinois. He partnered with several dissident former-Adventist leaders such as John and Marshall Grosboll, and

Dr.Ralph Larson. Kenny was ordained by Dr. Larson in a ceremony that was not recognized by the Church, and was publicly condemned by the General Conference President.

As a result of Kenny's actions as part of the separationist "Historic Adventist" movement, he was disfellowshipped. Most of his congregation left the Seventh-day Adventist Church with him.

Kenny Shelton now runs his own offshoot anti-Adventist organization called Behold The Lamb Ministries. Also, for over a decade, Kenny has been very actively associated with John Grossbol of Steps To Life Ministries, and with Dr. Larson. Kenny is a featured speaker at their campmeetings, as well as a variety of other offshoot campmeetings. He is also a featured author in the Steps To Life Magazine, Land Marks.

In the February 1997 issue of Land Marks, Kenny Shelton encourages members to leave their churches, form "home churches," and not look back. He says, "Error is never harmless. Testimonies, vol. 5, 292. Therefore, because of so much error and apostasy, many have found it necessary to establish separate worship services apart from the structure."

"We must not return to Egypt. We must not return to a structure that is deep in apostasy, for God's counsel is always the same, in every situation, structure or independent. Separate from sin!"

"Who would have thought that in Adventism the apostasy would become so great that in many places it would become spiritually dangerous to even attend the local Seventh- day Adventist Church because error was being "forced home to the people."

In the May 1997 Issue, Kenny carefully lays a foundation demonstrating the Church is teaching error, and then he writes, "a warning is given to separate from those "which cause divisions and offenses contrary to the doctrine."

"Now, let me ask you a question. Is it not right for an individual (you) to choose to support or work with, or not to support and work with certain ministries? Each individual makes their decision based upon the teaching of each ministry. If their teaching does not line up with what you believe the truth is, you withdraw your support."

"That is the way it should be conducted. But what is the difference when we, the ministries, must withdraw from another ministry because of differences of doctrine? I hope you are getting the point! Yes, there will be unity among God's true and faithful, and at the same time division because of those who will not come into line."

In the October 2005 issue if Land Marks, Kenny writes, "I often hear it said, "The church is moving on." To what church does this refer? The true church of God will be moving on. It will go on through. But this does not mean the true church is a certain denomination. There are many who believe the Seventh-day Adventist denomination is God's true church. If it is God's church, it will speak as does God. If it does not speak as God speaks, it is not His church—regardless of its name or where it is located. God does not speak with a forked tongue"

On his website, www.beholdthelambministries.com , Kenny Shelton is featuring John Grosboll, and Dennis Crystal. Both of them are former Adventists who are outspoken critics of the Seventh-day Adventist Church.

John Grosboll claims that the Seventh-day Adventist Church has split into two groups: the "little group" and the "big group." In the June 2002 issue of Land Marks, he indicates that the "big group" is the organized Church structure. He says, "The larger of these groups, sometimes referred to as the "Professed Church," is destined to go to ruin and destruction—to fall. They profess to be the "True Church."

"The other group is destined to appear to fall, because it will seem that they are going to be annihilated. Since it appears that this group will be destroyed, we must face the reality that the majority of this smaller group could be martyred. (See Maranatha, 199.) But instead of falling, it will remain. This smaller group is referred to by Ellen White, in other places, as the "True Church.""

"Dear Friend, if that still, small voice is telling you that you are in the large group of professed Adventists who are not really true Adventists, it is not yet too late for you to change sides, to change leaders."

In an article on his website, www.steps2life.com ,entitled, "Issues: No New Organization," John Gosboll writes, "Those who do not uphold God's law are joining the new organization that was started by Satan."

"The awful possibility of the Seventh-day Adventist church organization starting a new organization independent from God is a matter of prophecy. Ellen White prophesied that what we are seeing today could happen. We will look at the 12 main points of the prophecy having to do with the new organization in Adventism. It was a conditional prophecy in her day. It is coming to pass in our day.

- 1. Principles of truth that God...has given to the remnant church would be discarded—our religion would be changed.
- 2. The fundamental principles that have sustained the work in the 19th century would be accounted as error.
- 3. A new organization would be established.
- 4. Books of a new order would be written.
- 5. A system of intellectual philosophy would be introduced.
- 6. The founders of this system would go into the cities to do a wonderful work.
- 7. The Sabbath would be lightly regarded (as the God who created it).
- 8. Nothing would be allowed to stand in the way of the new movement.
- 9. The leaders would teach that virtue is better than vice, but God being removed,
- 10. They would place their dependence on human power, which, without God, is worthless.
- 11. Their foundation would be built on the sand.
- Storm and tempest would sweep away the structure."

Following this he states that only number 12 has not been fulfilled. He goes on to say: "Around the world there is a giant tidal wave taking place that many professed Adventist ministers are trying to stop. People are searching and finding historical Adventism—the same doctrines of the Bible that electrified our pioneers and made the Seventh-day Adventist church what it has been. These people are finding out that the present Seventh-day Adventist churches in their localities no longer believe and practice historic Adventism so they are assembling in home churches which are not recognized by "the conference."

It is then claimed that they are not united with the church. But the question needs again to be asked, Who and what is the church? Since the remnant of the woman's seed consists of those who love God and keep His commandments and have the spirit of prophecy, if you are united with an organized body of historic Seventh-day Adventist believers, you are united with the church. (To have a church, you need to have two historic Seventh-day Adventists who are agreed and unified—see Matthew 18.)"

Kenny Shelton travels with Dr. Ralph Larson, and they collude on speaking engagements at the various dissident former-Seventh-day Adventist events. In the November 2000 edition of Land Marks, Dr. Larson says, "...we believe the General Conference has launched an Inquisition, which may result in the separation from the church of several thousand believers,"

"They must simply accept the judgment of the Inquisitors as infallible—all of which reminds us of the Catholic Inquisition in Spain."

"Inquisitions work with falsehoods and misrepresentations. This is their stock in trade. Unfortunately, the General Conference Inquisition is no exception to this rule."

"Many of the historic Adventists recognize these false doctrines as the very ones they left behind when they came out of Babylonish churches to join the Adventist church."

"...we are confronted today with the appalling spectacle of a large group of high ranking church leaders sitting down together to concoct a list of totally false accusations against church members, whose only crime is that they will not accept the apostasy that is sweeping through the church. Thus the leaders align themselves with the apostasy.
