Hello Black SDA Friends:

I am new to the web site and became a member in order to comment on the Danny Shelton mess. I live in Berrien Springs, Michigan and am a member of the Village SDA Church. I am, however, considering making a change of membership to the new, Full Gospel Adventist Fellowship/Greater Works Ministry. This is a group being led by a wonderful black ministerial staff in the young ages of 21-30 years old. (I must confess that as a 'old white lady' I have a bit of trouble with their music but don't be too hard on me, okay?) These young people have become acquainted with the teachings of the 'heretical' charismatics who teach a living, breathing working faith which I have never seen in the SDA Church in the whole of my life. God began introducing me to these teachings several years ago by a book called "The Tongue, A Creative Force." I called my 'spiritual advisor' who is a staunch SDA teacher (adjunct professor at Seminary). He just chuckled and said, "Well now, you have run onto one of my sources!" That let me know that I was not being led down the wrong path and I have been examining this teaching since then. I had come to the conclusion that there needs to be a Full Gospel SDA Church which keeps our core doctrines and adds the living faith element of the charismatics. Do they teach the Sabbath, right state of the dead and

correct prophetic understanding? No, but they do have a real handle on how to communicate with God in issues of healing, Godly prosperity, who we are in Christ, for a start. They need to understand our doctrines of absolute biblical facts and add to them the heart of Christ as we also need to understand exactly what Christ did for us at the Cross. We think we have the 'truth' but we fall far short of complete gospel truth as Jesus lived it while He was here on earth. ---When I saw the listing in the phone book for the Full Gospel Adventist Fellowship I immediately got in touch with them and am very happy with the direction they are going.

Now to the 3ABN Saga: Question? Does anyone know exactly whether there could have been any other place on the earth for 3ABN to be located? According to Danny there was not. If that is true, then I believe God used what He had in His Hand--And who of us knows but that for a period of time, Danny was listening to God, at least enough that God was able to set up 3ABN through him. It occurs to me that God is now waiting for Danny to 'fill his cup of iniquity' and that perhaps our own efforts to make a change in this situation is only muddying the the waters, keeping God on the sidelines. Perhaps, if we just spend our time in prayer asking God to clean up His work, in His way, it would free Him up to do what He wants to do. History of 3ABN

"As progress on the project continued, Shelton discovered three-phase power would be required to operate the station. Larson indicated that the cost to run lines from the nearest main road was prohibitive. But upon investigation he discovered three-phase power lines a few hundred feet (about a hundred meters) away from the property, simply following a country road. When Shelton contacted the power company, he asked why those lines ran through open fields away from any factories or heavy machinery. The power company responded, "We honestly have no idea."

I believe that Clarence Larson became one of Danny's employees. It's possible this may be a doctored story to impress the gullible. The 3ABN followers seem to like the "miracle stories." There is a three-phase power line at the N-NE side of the original piece of property.

Clarence and Danny never say they inspected the entire length of the power line to see if there were any other facilities using three-phase power. Notice (below) how the first three-phase alternating current line in the year 1891 was 175 kilometres long. **175 kilometres** is **108.74 miles**.
