Synopsis: In part 3 of "The Tree in the midst of the Garden" Mollie and Hal Steenson were introduced as "the collaborators in suggesting and sustaining the "first miracle" of 3ABN. All of this prompts an unavoidable question: What is it in ET's religious belief system that allows her to see Danny Shelton as a latter day prophet, yet have no interest in the religion he claims to represent?

Like Adam was lead to that certain tree in the middle of the garden by Eve. Two women have been responsible for leading Danny Shelton to the perception that his voice is as the voice of God and all his thoughts and impressions concerning anything come from God. Like Eve they may have brought him to the tree, but like Adam before him, Danny choose to eat of it. Could Danny have walked away from the whisperings that have continued to lead him into greater delusion, bringing him to the point where he no longer perceived himself as constrained by the Ten Commandments of God? But as in the days before the Judges, when each man was a law unto himself, has Danny forged his own realm within which he is answerable neither to the laws of God or Man?

Seated upon his mount, Danny lifts himself up in the saddle. Raising up his hand he shadows he eyes from the glare of the afternoon sun. A smile spreads across his face as he observes a small portion of his realm. One day they all will truly acknowledge who he is and place him in the position where he belongs... Realizing where his thoughts are taking him, his smile broadens to that of the Cheshire Cat from Alice in Wonderland. Knowing there is no need to question the source from which these impressions spring, he rest in the assurance that all his thoughts and impressions come from God...





Yes, this is the principle that I think we are all standing on. And as Clay commented, you will find those "two or more witnesses" who have stepped forward on BSDA to confirm each other's testimony.

And before going further, I apologize for being somewhat snippy in my previous posts to you. Facing a thread of this length is indeed a daunting task. But working your way through it carefully will yield much information. The real problem comes, not with the mere time that it takes to read it all the way through, but how to hold in mind what one reads in order to compare it with what is said later. Let me suggest a method which, while it involves some investment of time on the front end, I have found most helpful in tackling a task of this kind and size.

In suggesting this method I am assuming that the posts can be printed out, one page of posts at a time, the same as they were on the CA forum. It does take time, and it generates a large stack of paper. But if you do that then you can sit down with the tools of research (hi-lighter, black marker, pen for taking notes in the margins, etc) in your hand and be able to mark or hi-light important points, and cross out frivolous or distracting posts, and even cross reference various points.

You will also be able to figure out (not the identity of those who choose to not use their real names, but) who are primary sources (by which I mean ones who were actually witnesses or even a part of the actions they are describing), who are secondary sources (those who have personally talked with or had extensive personal contact with the primary sources), who are researchers and have examined primary source documents, both public and legal as well as personal mail exchanged between those who were "part of the action". In some cases these individuals give their actual identities early on, but still use a pseudonym and are always referred to by their pseudonym so as to protect their identity from all but the serious researcher. Please respect their desire for privacy.

Your stated desire to find the truth of the matter will stand you in good stead if you add to that the patience to examine the evidence carefully and methodically.

I want to add one other note, however. No where, not on BSDA nor on CA nor in any of the voluminous emails, public announcements, or lengthy explanations/accusasions that have been created and exchanged during the last two years will you find the answer to your questions as to what certain people really know or knew; and why, in view of what they knew or didn't know, did they do what they did (or are doing). It is quite obvious when there are as many contradictions and outright accusations of lying going on, that someone is lying. The task of those who search for truth is to make a basic decision as to whom they will believe.

But even then we will not have all the information necessary to answer all of our questions, nor can that decision be made strictly on the basis of how many voices there are on each side who are giving their "testimonies." We cannot even know how many voices there are speaking in harmony with the first person witnesses who are speaking out on BSDA. As Sister has said, what you see here is only the "tip of the iceberg". Now she has used that phrase primarily to mean the amount of wrongs that have been revealed. I will use it also to refer to the number of persons who have spoken out. And there are more reasons for this than what may be accounted for in the comments on BSDA. Yes, privacy and fear play a big part in the smallness of this number. But those are not the only reasons. And I am not at liberty to name these other reasons. In due time they will be revealed, but that time

is not now. So please be sensitive as to how much you probe beyond what is being revealed here.


