"The Televangelist", Part 8...

"After his first wife died, the televangelist married a recently divorced young lady with two children: a girl and a boy. Reading the above extraction from "The Televangelist" I thought of the accusation of martial misconduct that has been charged against Linda Shelton — "Spiritual Adultery". Turning to the word of God, I sought the Biblical definition of wrongdoing pertaining to divorce and remarriage. If Shelton has many of the church's leaders in his pocket, has serious influence in the church's decision making processes, has in effect compromised the church because of their partnership with him, and some even suggesting he is the face of adventism, then it's time to leave the building.

Clay, I think it may be time to leave the 3ABN building, but let's not equate 3ABN with the whole church!

Yes, Dan has some church leaders more or less "in his pocket," particularly in the NAD. Someone who owes his position to lots of exposure on 3ABN & Dan's pressuring is likely to support 3ABN, don't you think? However, this doesn't mean that such an individual or individuals know much about all the other misdeeds of the Shelton tribe (resisted using the word "gang").

Yes, Dan has "serious influence," largely because of his perceived influence on the Adventist membership through 3ABN & the exposure he can give through his network. However, I suspect that some of that "serious influence" has been slipping away rather dramatically since his remarriage a few days after his divorce from Linda was declared legal. It doesn't take an advanced degree to figure out that Dan wasn't exactly trying to hold his marriage together -- with Linda contesting the legality of the divorce & his lawyers fighting to have it declared legal.

While 3ABN may be "the face of Adventism" for many, that can change. The fact is that 3ABN is **not really** the face of Adventism; it is just perceived to be so by some. And Dan thinks that he represents Adventism. But I don't put much stock in Dan's thinking.

Ellen White once had a vision in which she saw the church as a ship heading towards an iceberg. The iceberg was symbolic of apostasy in her time, and the captain of the ship said to hit it dead on. It did, and the ship survived. She also foresaw that in the end time, the church would look like it would "go down," but it would stand in spite of appearances.

Looking at the relatively high profile of 3ABN and the sordid stories behind the scenes, I began to wonder if it might not be this 3ABN scandal that would make the church look like it was about to go down. But then that Washington Post article demonstrated how very easy it would be for God to deflect the scandal in such a way that the church would not suffer any more than necessary to sort out the bad apples. (While I don't think it's time to leave the building, I do think it's time for a house cleaning!)

I think that comparison to the Jews and their rituals fits the 3ABN situation quite well. I don't think it fits the church as a whole just now. Remember that the NAD is a relatively **small** portion of the church right now.

Things will happen in God's own timing. Things that were done in secret will be proclaimed for all the world to see/hear. It has happened before. It will happen again. Each individual involved will have to pray to be submissive to God's leading. Sometimes that means telling the truth, even though it is ugly. Other times it means being silent, even when silence is hard.

May God grant wisdom and strength to all who have had the misfortune to be under Dan's control

Now if you had used your metaphor to say that it is time to abandon the notion that the Shelton empire either represents God or is the "face of adventism", then we'd be in synch. Danny and Pope John Paul II ...

Arrayed in all his pontifical glory, Pope John Paul II, with skill and craftiness, personified the Catholic Gospel for twenty-seven years. He became the face of Catholicism to the world in the latter part of the twentieth century until his death in 2005. Did this "Vicar of Christ" have infallibility in all matters concerning the Church as he, by Catholic profession, ruled in the stead of the Son of God on earth? Were his pronouncements accepted as the voice of God within the independent state of Vatican City and to his followers around the world? Was his seat of power holy ground? It is to the adherents of the Catholic Church. And finally, what do Pope John Paul II and Danny Shelton share in common? In what paradigm of reality do these two men stand adjacent, imbued with substitutable power?

The first law of the real estate business is location, location, location. For John Paul II the location was Vatican City. In this tiny sovereign state, only about 100.8 acres, he ruled supreme. And Danny Shelton? Again location, but unlike Vatican City State which is encapsulated within the city of Rome, Italy; the compound of 3ABN is located adjacent to the rural hamlet of Thompsonville in the backwoods of Southern Illinois. But it's land holdings are nearly double that of Vatican City. And the power that Danny wields within his independent ministry is equal in it's scope and self-professed infallibility as his Catholic counterpart the Pope: he depends on his word being above reproach and his actions unquestioned. Like the Protestants who questioned the authority of the Catholic Church in the middle ages, the employees that dare to question the propriety of Danny's actions are swiftly dealt with—not by burning at the stake, even southern Illinois is not that backward—but by other forms of disciplinary action. Actions that may continue long after they have permanently left the confines of 3ABN.

When Danny installed Mollie in the position of his personal secretary, she immediately undertook the task of expanding upon the pronouncement she and Hal had made during an employee week of prayer a number of years before. She declared to both Danny and her fellow employees that God speaks to Danny and speaks through Danny to 3ABN. When ET Everett arrived on the scene, she enlarged upon Mollie's pronouncement, encouraging Danny in his belief that whatever thoughts and impressions he received regarding **anything** was the voice of God. Danny believed that God was showing him things in dreams and visions, and if you disagreed with him, in fact you were disagreeing with God himself, for Danny **is** the voice of God at 3ABN. Newcomer to the fold Shelly Quinn has perpetuated Mollie and ET's worship of Danny.

It is interesting to note the following: the tradition of 3ABN takes the infallibility of Danny a step beyond Papal infallibility, which does not signify that the Pope is specially exempt from accountability to sin, whereas Danny has laid claim to being relieved from answerability for certain sins "since God has given him such a great task to perform".

Danny's followers? It is opening night at the Spring 2006 3ABN Campmeeting... The floor director counts down the seconds 5...4...3...2...1...cue Danny and let the games begin. Poised and oozing with self-confidence Danny is truly in his element: from the well groomed hair implants on the top of his head to the fresh shine on his dress cowboy boots and a smile calculated to open the pocketbooks of the assembled followers, he picks up his microphone. Approaching center stage, Danny calls forth the faithful to testify of his greatness. Thrilled with being in the actual presence of this holy man of God— who has been called forth, a lowly carpenter himself just like Jesus, "to bring the three angels message to a lost and dying world"— the faithful line up to shake the hand of the man who stands on Holy Ground.

Like the faith healer in his traveling tent show, Danny parades a selected few of his target market, the elderly who have arrived in their Winnebagos prepared for a great show at the hands of their spiritual leader, up to the stage. After receiving the adoration of a wrinkled, white haired old soul, smiling sweetly at her he says, "Can I give you a hug?" As a blush creeps up upon her ancient countenance, microphone in one hand Danny's other arm encircles her shoulders. As he draws her close to his chest he gives her a slightly flirtatious smile and looking toward the audience he addresses his wife, "Brandy, is it alright if I hug this lady?" Giving Brandy's response, to the gentle laughter of the assembled crowd, he replies with a Cheshire Cat smile on his face, "Brandy says it's okay, go right ahead."

Just as the Pope stood high above the square in Vatican city, Danny now stands upon center stage in the Worship Center at the 3ABN compound. Thousands of the faithful, densely crowded in front of St. Peters Basilica, their gaze turned upon the balcony high above them, raise their voices in adoration as John Paul II waves to them. This well illustrates the affinity that the Pentecostals and certain "branches" of Adventism has for each other. And it is one that is not often really understood. either in the historical sense of it always being present, or in its various manifestations in the present. Mainline and Conservative Adventist spokespersons in general are very critical of Pentecostalism, though their criticisms are generally focused on a very narrow segment of doctrine, and most often on their forms of worship and music. But when it comes to the entire scope of doctrines, there are probably more that are presently infiltrating our church with encouragement from conservative sectors than there are those that are being effectively countered.

But, especially when it comes to areas which touch on Ellen White and a prophetic voice within the church, it is intriguing to realize that those who have rejected Ellen White are very often even more in league with Pentecostal teaching and practices in this area than are those who accept her as someone through whom God did indeed give direct messages to the Adventist church. I don't pretend to understand this, but I know from experiences that it is true. As one example of this, I'll note briefly the correspondence that I had with a woman, an ex-Adventist, still a Sabbath keeper, btw, who was very vocal on her opposition to both Ellen White and to the Adventist Church for their continued respect for her and her role in the church. Yet she was thoroughly enamored of the prophetic gift as it was manifested in various self-styled prophets, and frequently filled my mailbox with the latest of an assortment of their messages.

There are, no doubt, a number of explanations for this connection. But probably the most cogent one is that people who are serious about their religion (and there are such people all across the span from liberal to radical right wing conservatism) are also serious about getting a "word from the Lord". And they want it now, and direct, not filtered through any dead prophets, whether their writings be found in scripture or the writings of Ellen White. This not only represents a yearning for a truly contemporary "word from the Lord", but it also represents a "hunger for the supernatural" which in turn causes them to be both envious of and susceptible to those who claim either direct connection with God or miracles of God attesting their "special status" with God.

For those who lightly regard the Sabbath and/or their Adventist church connections, leaving our church and moving to a Charismatic one can be seen as a very attractive alternative. But for those more devoted to either the Sabbath or the Adventist church, it is much more preferable to import what they think they want from Pentecostalism, even if that means hiring "real" Pentecostal

preachers, baptising those that are willing to accept an Adventist facade, but not making this a condition of their continued employment.

In regards to whether 3ABN is Danny Shelton or not, I understand both points of view. This brings up the greatest concern about this whole situation. Sin and false doctrine always go hand in hand. For instance, John Lomacang's series on Revelation (of which I saw only a part) presented a futurist interpretation of the 7 trumpets (Rev. 8,9). Both the Sanitarium and the Review and Herald building (which was going to publish Kellogg's book) were burned to the ground. This crisis was the "iceberg" that Ellen White saw in her dream in which God told her to "meet it." The Adventist church survived, but Kellogg and many Adventists (including leaders) left the church. Lewis Walton's book Omega II is an excellent account of that period in Adventist history with application to today.

I'm grateful to people like sister, beartrap, watchbird, et al., who are doing what they can to resolve the leadership crisis at 3ABN before it develops into a situation in which souls may be deceived and lost.



hough I agree with most things you post, "beartrap," I do disagree most thoroughly with this. It is rue that 3ABN seems to feature some evangelists who base their campaigns on denigrating other lenominations. I shudder every time a certain popular evangelist speaks because I am uncomfortable with his manner, and once, when I accidentally saw a portion of his presentation he left me open-nouthed at the audacity and un-Christlike spirit demonstrated.

Not all evangelists preach that way. When *Amazing Facts* first got started with Joe Crews, I emember being uncomfortable with his approach -- hard-bitten and confrontational. We were at Andrews University at the time, and there was a campaign to hand out the "This may startle you, but ..." tracts, based on "amazing facts." I remember thinking that anyone converted by that approach vould not be converted to Christ, but I hoped that the people following up with Bible studies would supply the missing ingredients.

That was a **long** time ago, and I've grown in my understanding since then. I am pleased to note that while Doug Batchelor still demonstrates some of the "amazing facts" heritage, he strives to make his presentations Christ-centered, as they should be.

Ellen White specifically warned against the kind of religion/approach which you characterize as being "Adventist." She counseled ministers to "get close" to ministers of other denominations. Among other things, that would nowadays mean joining the local ministerial associations and cooperating in community outreach whenever possible. I know many ministers do exactly that.

Ellen White also wrote that "The last rays of merciful light, the last message of mercy to be given to the world, is a revelation of His character of love. The children of God are to manifest His glory. In their own life and character they are to reveal what the grace of God has done for them." (Christ's Object Lessons, p. 415)

That is our mission today -- to reveal to the world what the grace of God has done for us. **That** is the "message" that will precipitate the "final events" because it will bring down the wrath of Satan on the body of Christ, God's last-day people, just as it brought down the wrath of Satan on the physical body of Christ.

Iknow that from the General Conference level, this kind of Adventism is being promoted. Through the **Review** this kind of Adventism is being promoted. 

For although, as Sister (I think it was) pointed out, it is true that Danny has now added others of his family to the ownership list, history has adequately shown that it doesn't make any difference who is on the ownership list, Danny is the one who calls the shots and removes whomever he wills, whenever he wills it.

And unlike other companies where the board chairman is the truly powerful person, and "ownership" resides in the board itself, with the president "serving at the board's pleasure", the 3ABN company is owned directly only by Danny. And the board members, like his employees, serve only so long as he desires that they do so. So while the board has certain powers over him, those have only to do with money and support. At the present they are strongly supporting him not only directly from their deep pockets, but also with the power base of the whole ASI organization, and with their influence and power over Conference administrators. Until or unless they as a whole group turn on Danny themselves and demand that he step aside "for the good of the ministry" or some other esoteric phrase that means little other than that they want to keep control of the power that 3ABN gives them but have come to see Danny himself as a liability, there is little likelihood that there will be any change in "day to day management" effected. And even if that does happen there is very little chance that any such change would be any more than cosmetic, with Danny still somehow pulling the strings on what ever puppet they set up (as Sister so graphically described).

One alternative scenario that is seldom mentioned would be for Danny to fully cast his lot with the anti-SDA and Pentecostal crowds, figuring that he can gain more support from those who love to condemn the church than he can from the supporters of the church, and that the welcome he would get in Pentecostal circles were he to cast off from the Adventist church would more than make up for

the loss of both revenue and support he currently gets from SDA church administrators.

It is a very complex problem and one for which (even with my sometimes overactive imagination) I have never been able to come up with any scenario that would sort things out all neatly and leave 3ABN with fully clean management and board and developing into a true "face of Adventism" to the world. I take comfort in what I believe to be a fact--that the Lord has a thousand ways to work things out that we have not even dreamed about. I think the bottom line is that we have to be patient, each doing "whatever our hand finds to do", while we wait on the Lord to accomplish what needs to be accomplished.

This is not to say merely "leave it to God" while we ignore or downplay the seriousness of the situation. It is to recognize that God nearly always uses humans as His agents in accomplishing His purposes, and to also recognize that even though we cannot individually play what seems to us to be a significant part in His work, we should still do all we can. For most of us here on BSDA that is probably no more than thinking things through, asking questions, probing, giving information whenever we have some that is appropriate to be shared, and "watching for indications of His Providence." I think we see some definite indications of that in the removal of 3ABN from two different satellites in two far apart sectors of the globe. This is not anything that any one here could have accomplished had we set out to do so.

Every day that we wait someone new hears the truth about Danny and/or others at 3ABN. Every day that we wait someone else learns through personal experience the truth of how Danny treats those who disagree with him. Eventually all of these things will come together and God will be ready to act. In the meantime, let us keep on sharing--both here on the forum and as we have opportunity in our personal contacts.

3ABN company is owned directly only by Danny. And the board members, like his employees, serve only so long as he desires that they do so. So while the board has certain powers over him, those have only to do with money and support. At the present they are strongly supporting him not only directly from their deep pockets, but also with the power base of the whole ASI organization, and with their influence and power over Conference administrators. Until or unless they as a whole group turn on Danny themselves and demand that he step aside "for the good of the ministry" or some other esoteric phrase that means little other than that they want to keep control of the power that 3ABN gives them but have come to see Danny himself as a liability, there is little likelihood that there will be any change in "day to day management" effected. And even if that does happen there is very little chance that any such change would be any more than cosmetic, with Danny still somehow pulling the strings on what ever puppet they set up (as Sister so graphically described).

One alternative scenario that is seldom mentioned would be for Danny to fully cast his lot with the anti-SDA and Pentecostal crowds, figuring that he can gain more support from those who love to condemn the church than he can from the supporters of the church, and that the welcome he would get in Pentecostal circles were he to cast off from the Adventist church would more than make up for the loss of both revenue and support he currently gets from SDA church administrators.

It is a very complex problem and one for which (even with my sometimes overactive imagination) I have never been able to come up with any scenario that would sort things out all neatly and leave 3ABN with fully clean management and board and developing into a true "face of Adventism" to the world. I take comfort in what I believe to be a fact--that the Lord has a thousand ways to work things out that we have not even dreamed about. I think the bottom line is that we have to be patient, each doing "whatever our hand finds to do", while we wait on the Lord to accompash what needs to be accomplished.

This is not to say merely "leave it to God" while we ignore or downplay the seriousness of the situation. It is to recognize that God nearly always uses humans as His agents in accomplishing His purposes, and to also recognize that even though we cannot individually play what seems to us to be a significant part in His work, we should still do all we can. For most of us here on BSDA that is probably no more than thinking things through, asking questions, probing, giving information whenever we have some that is appropriate to be shared, and "watching for indications of His Providence." I think we see some definite indications of that in the removal of 3ABN from the different satellites in two far apart sectors of the globe. This is not anything that any one increased have accomplished had we set out to do so.

Every day that we wait someone new hears the truth about Danny and/or others at 3ADA. Every day that we wait someone else learns through personal experience the truth of how Danny weats those who disagree with him. Eventually all of these things will come together and God will be ready to act. In the meantime, let us keep on sharing--both here on the forum and as we have opportunity in our personal contacts.

We are born sinners (however much our understanding of that him a may differ), of the lineage of Adam, under the "life sentence" of knowing both good and evil. However, we are not born evil. We become evil only through long years of choosing evil rather than good (ie. choosing the

Evil One rather than the GOOD ONE).

And how do we tell the difference between evil and sin? I think your parable holds the key.

Sin is alwys self-centered and seeks its own good above that of others around them. One who sins does so from some benefit they get as the result of that sin. But evil is destructive for no other reason than that of destroying--even when its destructive acts destroys itself. We all have enough sin in us so we can understand the attraction of lust and money and power. But I trust that all of us have been "delivered from evil" at least to the extent that we find it incomprehensible and repulsive when we see acts of destruction of others' lives, marriages, characters, and reputations even then such acts bring no benefit to the one who is doing them.

Back to your parable with some questions:

In the parable the end happens. But in reality, is the end fixed? Or is there time yet to rescue the frog who was exhibiting his own inner good "nature" by his willingness to help the scorpion even in the face of known danger? At present the rushing waters swirl.
