I have sent a number of denominational leaders, and others involved in this Amazing Facts/3-ABN merger A series of questions. All received the same 12 questions. One received 13 questions. All were given an e-mail address to which they could respond to me. Slight changes in wording were made based upon the person to whom I was sending the e-mail. e.g. In the one to Danny Shelton, I asked if Doug Batchelor was going to be President. I worded it slightly different in the one to Elder Batchelor.

Here is the what I sent Elder Batchelor. I will shortly post his response:

To: Elder Doug Batchelor

The April 19 announcement of a merger of Amazing Facts, and 3-ABN has been described as the most important SDA media announcement ever made. It has aroused intense interest among the supporters of both ministries. In some aspects, that announcement has confused people.

In the interest of clarifying this situation I would appreciate it if you could respond to the questions that follow. Be aware, however, these questions, and your response to them, will be published on the Internet as that is where the most immediate interest has been generated. In the interest of accuracy, I will post your response exactly as written by you. I believe that it is important that people have accurate information which comes from informed people, who can speak with authority. In this issue, you are certainly such.

Please place your responses following the questions.

- 1) In the corporate world, the word "merger" has specific connotations which involve changes in corporate structure and governmental registration. Typically, it will involve one or more independent corporate entities uniting into one corporate organization. Will this merger between 3-ABN and Amazing Facts result in one combined corporate organization so registered with the appropriate governmental agencies, or will 3-ABN and Amazing Facts continue as independently registered corporate bodies?
- 2) It is understood that 3-ABN and Amazing Facts are going to be governed by one united Board. Is this understanding accurate? If it is so, how are the members of that Board going to be selected?
- 3) Both Amazing Facts and 3-ABN have attempted to establish some a relationship with the Seventh-day Adventist Church, while remaining some degree of independence. It is thought by many that Amazing Facts has a closer relationship with the denomination than does 3-ABN, and that 3-ABN is more independent than is Amazing Facts. With this merger, how are those relationships to the SDA church expected to change?
- 4) Many understand 3-ABN as claiming to proclaim the "undiluted SDA gospel" in a manner that has not been done by any other SDA media. Is this merger going to effect any changes in the message proclaimed by Amazing Facts and 3-ABN? In other words, can we expect that either Amazing Facts will now begin to proclaim an undiluted SDA gospel, or that 3-ABN will now begin to proclaim a diluted gospel? While my question may seem trite, it is being asked by sincere people.

- 5) Informed sources close to this merger have told me that it is expected that you will become the President of this new organization, while other informed sources have told me that a decision on this has not been made. Do you expect to become the President of this organization?
- 6) I have also been given conflicting information in regard to the role that Danny Shelton will play in this new organization. What do you expect that his role will be in this new organization?
- 7) Do you expect that any major personnel changes will be made in either Amazing Facts or 3-ABN as a result of this merger? Will current employees, who are not members of the Seventh-day Adventist Church, continue to be employed in their present role?
- 8) Is it expected that all employees of both organizations will transfer to a denominational pay and benefits schedule?
- 9) Can we expect that both organizations will be regularly audited according to the standards of the denomination?
- 10) Not-for-profit organizations have ethical and legal responsibilities in regard to the release of financial information to the public. Can we expect that this information will be made freely available to the public?
- 11) Corporate mergers always involve the assumption of responsibility by each organization for the actions of the other organization. What risks does Amazing Facts assume for past and future actions of 3-ABN? Conversely, what risks does 3-ABN assume for past and future actions of Amazing Facts?
- 12) Some believe that a benefit to Amazing Facts will be access to a fully equipped production studio, and a benefit to 3-ABN will be increased respectability due to a relationship with Amazing Facts. No benefit is seen to be in a reduced work-force. Others believe that Amazing Facts has much to gain due to an increased audience. What do you believe to be the benefits to each organization?

I appreciate the time that you will expend in responding to my questions. This merger is of great interest to Seventh-day Adventists. The responses made to these questions will be very helpful and informative.

If you do not believe that you can respond to these questions, or if you need some extended time to do so, I would appreciate a response to that effect.

Unfortunately, the responses to the questions that are being raised only raise more questions, and further confund the situation. In fact, they often present the planners as having embarked on a voyage of some undefined sort, without full prior planning, and without giving thought to the ramifications of what is being said.

It may very well be true that full prior planning and thought was given to this. But, if that is so, and if the word "merger" is used in its common meaning, then there are answers to the specific questions that are being raised. It occurs to me that my email is even more applicable now, with the proposed merger, than it was when I wrote it.

Now that I look at it again, Bonnie Ensminger really didn't say much. What I found offensive was her reference to "investigator, judge and jury" and her reference to my "bitterness," which was not called for. It essentially skewed what I wrote into a very different sort of emotional climate.
