MEDIA RELEASE

West Frankfort, IL – April 19, 2007 – Three Angels Broadcasting Network (3ABN) and Amazing Facts Ministries today announced upcoming plans for uniting the two international Christian media ministries. Lauding the global platform for evangelism this union will create, the Boards of Directors of both ministries unanimously approved moving toward joining the ministries under a new board and constituency.

Founded in 1984, 3ABN began broadcasting on November 23, 1986 and now transmits its signal to nine satellites that carry it to every inhabited continent with a potential viewing audience of hundreds of millions. In addition to its English-speaking television network, 3ABN operates 3ABN Books, 3ABN Radio and 3ABN Latino Television networks, along with a 3ABN television and radio production center in Nizhny Novgorod, Russia. The ministry has also announced plans to launch the 3ABN International Network before the year's end. The second largest Christian network in North America (in numbers of owned and operated UHF stations), 3ABN also has full-power stations in Papua New Guinea, Uganda, and the Philippines.

Beginning with a fifteen-minute radio broadcast in 1966, Amazing Facts has grown into a successful soul-winning dynamo. For over forty years Amazing Facts has provided strong evangelistic, ministry through an array of services that include evangelistic training through the Amazing Facts Center of Evangelism (AFCOE), a team of live itinerant evangelists, publishing, radio and television broadcasts, Bible school and a popular internet ministry.

While there are still a number of organizational details to be worked out, with good council both ministries are confident these things can be accomplished rapidly. For the immediate future we anticipate most of the normal operations at both ministries will remain the same. Our goal will be to optimize greater evangelistic impact to the world, more efficient service to the body of Christ and better stewardship of resources through this dynamic partnership.

In making the announcement, 3ABN's Founder Danny Shelton stated, "We're excited about uniting our ministries, which will accelerate our array of evangelistic services to reach the multitudes. The Spirit-filled speakers of Amazing Facts will share the undiluted truth of God's Word on 3ABN's global platform. The ministries will mobilize an army of Christians to conduct Bible studies in cities worldwide. Time is short—we need to maximize our efforts to reach lost souls."

Doug Batchelor, Amazing Facts President/Speaker, commented, "This uniting of ministries will expand our operations and forge an impressive team of Christian managers who bring their unique talents and reputation for visionary leadership to the new organization. Our union will surely lead to greater effectiveness and economy in spreading the gospel to the world. We're really excited about this comprehensive opportunity to communicate the good news of Jesus Christ."

Danny Shelton comments, "Through God's miraculous blessing He has allowed me to witness 23 years of the unfolding of the vision for 3ABN. I truly believe that this historic partnership with Amazing Facts is a continuation of the vision and can only say with calm assurance, God is leading."





News Release: 4/25/2007 Frequently Asked Questions #1

Since announcing the intention to unite the ministries of Amazing Facts and 3ABN, we have received numerous good questions from ministry friends. Unfortunately, it is not practical to answer every e-mail in detail, but in the interest of transparency and keeping you informed, we have done our best below to provide some answers to the most common questions. Please keep checking our website regularly for updates as news develops.

Q. What is the estimated timeline for the proposed union?

A. All operations at both ministries will continue as normal for the next few months while subcommittees consider legal, organizational, and transitional issues. With God's blessing, we hope to have the details finalized as soon as possible.

Q. Does this mean Amazing Facts will move to Illinois or 3ABN will move to California?

A. No. There are beneficial reasons for both ministries to maintain a campus in their present locations; thus, there are currently no plans to transplant either ministry. However, some aspects of the ministries could be combined in the future for better efficiency and stewardship of God's resources.

O. Does the proposed union mean control of 3ABN will be assumed by the SDA denomination?

A. No. Both Amazing Facts and 3ABN will fall under a new board to be led by laity. Although Amazing Facts and 3ABN are self-funded entities, both organizations are supportive of the denomination and encourage people to be active at their local church. This policy will continue under the new union. New bylaws are being prepared to preserve that grassroots principle of lay leadership.

Q. Is Doug Batchelor the new president of 3ABN?

A. No. Danny Shelton is still the president of 3ABN. Mr. Shelton is recommending Pastor Doug for the position of president of the new united organization, but this is a decision that must ultimately be confirmed by the new constituency and board.

Q.Will Doug Batchelor move to Illinois?

A. This is unlikely. Pastor Doug recognizes that should he accept this position, it will involve additional travel. He has spoken with his church and family about the added commitment this union would require on his part. His congregation understands this will reduce some percentage of his time at Sacramento Central, where he has served for nearly 14 years. However, Pastor Doug believes he can do more in serving the interests of global evangelism and church revival by maintaining his connection with church members while still employed as an active pastor.

Q. Will Amazing Facts or 3ABN change their name?

A. Both entities have strong name recognition. There are no plans at this time for either ministry to lose its unique identity or branding through this partnership.

Q. Will the union of these two ministries cause a change in 3ABN programming?

A. The programming at 3ABN is continually being evaluated and improved as the network strives for the highest production quality and content. New programs are introduced every month. This policy will continue in the new partnership.

Q. Will 3ABN continue to be open to and supportive of the many other ministries of the Seventh-day Adventist Church?

A. Absolutely! 3ABN will continue to welcome, uphold, and broadcast the many SDA ministries who are proclaiming the end-time truths God has entrusted to our Church.

Q. Why unite/partner if so many things will remain the same?

A. These two ministries complement each other highly in many areas. Uniting the evangelistic message and mission of Amazing Facts with the worldwide platform of 3ABN is an exciting opportunity that will surely impact the world for God's kingdom. In the past, Amazing Facts has actively explored the possibility of a 24-hour television network, while 3ABN has recently considered launching an evangelism training center. Each organization will now be able to share in the strengths of its partner. A united board will mean common goals and objectives, resources will be used more effectively, and combined ventures will have greater success. (We are currently preparing a more detailed explanation of the benefits for this union.)

Q. I typically receive a monthly letter from both Amazing Facts and 3ABN. Now that these two ministries are moving toward uniting, how should I respond with my monthly support?

A. Please remember that Amazing Facts and 3ABN are each sustained financially entirely by friends like

you. Neither ministry receives any denominational or corporate support. At this time, the finances of both ministries will continue to be run separately. However, both will now need your generous support. Especially during this time of transition, and as we make bold evangelistic plans for the future, we will urgently need your continued help for both ministries. I think it is one of the illusions that many of us have had, that, since Doug Batchelor is an employed Adventist minister, that the ministry, Amazing Facts, must be a denominational entity. That is simply not the case. And the merger with 3abn shows very clearly that it is not the case.

For background in how the relationship between 3abn and the denomination has developed during the years, it would be instructive.... for those who have not done so yet.... to look up the documents on this site that were created in 1997. Briefly, in the spring of 97, Folkenberg tried to get 3abn to sign a contract with the church organization. 3abn refused, with Bill Hulsey writing a letter of explanation as to why an independent ministry would not consider having any kind of contract with the church organization. That letter also is on this site. We do not, however, have any of the correspondence that we are told continued on through the following months... culminating in an agreement between the two entities. We do, however, have the final document, which was signed by Folkenberg and the next two highest men in the church. It seems apparent that 3abn itself authored this, for essentially it was a very one-sided document... giving the church no lines of control over 3abn, but giving 3abn a blank check promise to promote them in all Divisions of the world.... which 3abn has used as their entry permit into churches around the world.

Interestingly enough.... this agreement was seemingly never questioned after Folkenberg was forced out of office just a few months later due to some shady negotiations with which he had been involved.


And all of this negotiation in 1997 needs to be set in the context of certain earlier private letters which I have personally seen, in which Folkenberg was expressing great displeasure because 3abn had refused a request for 3abn to include Al McClure, in his position as NAD President, to be included as a board member of 3abn!

The official questions and answers which are posted above which indicate that the new merged entities will remain as "supporting ministries" and will NOT become denominational entities... and also the statement about having a board that is composed of lay members... strongly suggests that 3abn is once more determined to not allow the church org to have any official voice in the direction they intend to go... and certainly no ability to control anything that they might do in the future.

Thus once more, the church is giving away its rights and obligations to retain responsibility for how it is represented to the world. The question arises, is this because they are already powerless to have any say in

this matter? or.....

Again... more questions are raised than are answered with each new set of "answers" we get.

For background in how the relationship between 3abn and the denomination has developed during the years, it would be instructive.... for those who have not done so yet.... to look up the documents on this site that were created in 1997. Briefly, in the spring of 97, Folkenberg tried to get 3abn to sign a contract with the church organization. 3abn refused, with Bill Hulsey writing a letter of explanation as to why an independent ministry would not consider having any kind of contract with the church organization. That letter also is on this site. We do not, however, have any of the correspondence that we are told continued on through the following months... culminating in an agreement between the two entities. We do, however, have the final document, which was signed by Folkenberg and the next two highest men in the church. It seems apparent that 3abn itself authored this, for essentially it was a very one-sided

Amazing Facts. Is it, or is it not a Seventh-day Adventist institution? My take on it:

AF is clearly listed in the YEARBOOK as an institution of the Northern California Conference of Seventh-

day Adventists.. Yet it is though to have a some sort of independent status. So, what is the truth.

It should be noted that the YEARBOOK lists Moriah Media, also as an institution of the Northern California Conference, and lists it address as the same as the address for Amazing Facts.

Amazing Facts was registered with the State of California as a church in April 1947. Moriah Media was also registered with the State of California that same month, and it is listed as a religious organization, and apparently is a holding company for Amazing Facts television.

In the YEARBOOK the address for Amazing Facts is listed at the "title holding company" for Amazing facts.

My take on this is that this establishes Amazing Facts as a Seventh-day Adventist institution. However, it appears to be governed by a Board which is organizationally independent of the SDA Church. I acknowledge that it has SDA denominational leaders on that Board. So, some might challenge my statement as to its independence.

The reality is, as I see it, that the separate status of the Board releases the Northern California Conference from funding it. It allows AF to maintain its own control, and independence. Yet, the SDAs on the Board give the organized church a voice in its affairs.

Could it separate from the denomination? In theory yes, it could. However, it could probably be argued that such would not happen easily.

Let me illustrate how I believe that this relationship exists in practical terms. I live in a Conference where a group of SDAs established a congregation with the intent to do "cutting edge" ministry. They called themselves Grace Place. They established a formal relationship with the Rocky Mountain Conference. But they held title to the property that they owned, and they were independently controlled by a Board of their selection. The RM Conference acknowledged them as a SDA Church, and their minister was credentialed by the RM Conference, and on its payroll. It its development as a congregation, it later moved outside of the SDA Church, and became totally independent. The RM Conference withdrew recognition. It's minister went off of the payroll, and was no longer credentialed by the SDA Church. But, for several years, it was an organized SDA church in the Rocky Mountain Conference.

I do not intend to imply that Amazing Facts will ever do what Grace Place did. My point it that the SDA Church does allow certain independent organizations to be knows as SDA institutions, who do have some degree of independence.

This is not true for all organizations.

Weimer College and Health Center is not so listed as an institution of the Northern California Conference.

3-ABN is not so listed under the Illinois Conference.

So, it can be fairly said that Amazing Facts is more closely related to the denomination than is 3-ABN.

Because of that close relationship AF follows denominational policy in ways that other organizations may not.

AF hires SDAs. It follows a denominational pay scale. Policies are in effect that allow people to transfer between it and employment in the NAD. This does not happen withe other organizations. One cannot easily transfer in employment between 3-ABN and employent in the NAD in regard to service credit.
