Bob, I believe this would be a reasonably accurate statement as to what inventory is. The website shows they sell books, cds, dvds, tapes and a shirt. I can't imagine they keep the 36" satellite dishes and receivers in inventory but at 199.00 each that would be a lot of them. I suppose they might have gotten stuck with the old skyangel dishes and receivers but i would not think that could be listed at full value.
And since we know that no profit is being made by anyone on the TC-TR (TIC) and the publisher/printer is practically giving them away per Aletheia, I can't imagine 3abn would/should have a large inventory of them either.

Jsing 2000 as a baseline figure, you can see the dollar amount of each year's inventory increase plus the percentage of the increase over the previous year increase.

To obtain a fair, a better picture, it would be nice to see the Sales and Cost of Goods Sold for these same periods of time.

I would suggest that 3ABN does not have software of this kind

2000

- 1. The amount of inventory for 2000 could be said to be a reasonable inventory. This would have included Satellites and Receivers.
- 2. 2000 figures are used as the baseline for the increases from year to year.

2001

- 1. This is the year the auditors that left 3ABN with sore bottom for sure. The report had to have a devastating effect on Danny and the board.
- 2. Did these reports go to all board members?
- 3. Or did the reports get whisked away to the lawyers and no one else got to see them?
- 4. The increase in Inventory could be from past shipments that had not been processed at the time of their receipt.
- 5. This increase actually shows that there was an effort to book the entire received inventory.

Here is where I want to stop with some questions and comments.

- 1. First and foremost, is 3ABN a Business, or a Not for Profit entity?
- 2. Does Danny own it or do the viewers in the pews own it? (Since the donor's money was used to create it and fund its activities)
- 3. The Danny Lees Shelton Printing/Publications Co. does much of the printing of 3ABN items. Do they also reproduce the CD/DVDs, or is this done within 3ABN?

a. Who does DLS Printing have as customers?
b. Are 51% or more of the items printed/reproduced for 3ABN?
c. Shouldn't the Printing Company belong to 3ABN if this is the case?
d. Since Danny owns the printing company, is he receiving profits at 3ABN's expense?
e. Where is the printing facility located?
i. Is it on 3ABN property?
1. If so, does Danny pay a lease or rent to 3ABN?
2. If so, where is that income listed as Income for 3ABN?
ii. If the printing company located on Danny Shelton's 18 acres?
1. If so, who built it?
2. Did the board approve it, or was it just done?
3. Who owns all the assets?
4. Were these assets purchased from 3ABN?
5. If so, what was the selling price?
f. Did the board approve the establishment of the Danny Lee Shelton Printing Co.?

Bob, see what you do to me? Sorry for all the questions and such. I have a whole lot more questions about this and other areas of the IL vs. 3ABM Property Tax Lawsuit and 990's.

......g. How does this stand up against the policy that none are to receive gain at 3ABN's expense?

I have no clue as to the paper weight of the book in question, but I understand the importance.

Who published the book? Or is that a given?

All of the figures are used from the Inventory figures provided by Bob. Statements are my opinion.

In my opinion, and nothing else, I can see where this reflects some padding of the 3ABN inventory. It looks as if orders were placed to give the printer a profit, but pad the inventory of 3ABN. These are just my opinions mind you.

The increase in 2005 may have been because they had to get more large dishes to replace all the Dish, dishes. However, the largest dollar increase is in 2004. Is this how money was raised to take care of Linda? Is this where the money came to purchases 1/2 of a drastically under valued home?

IMO the dollar increases and percentages for all of these years should be explained.

Save3ABN now has the 990's from 2001-2005. That's right. The 2002 990 is there too, something unavailable to me when I started this thread. http://www.save3abn.com/3abn-form-990s.htm

On page 1 you have lines representing inventory sold and non-inventory sold, as well as the cost of goods sold or basis of the items sold.

Attached to the 990 is a series of statements in the back. Statement 4 tends to be the one about assets, and statement 7 and 8 tends to be the one that lists cost of goods sold.

The cost of goods figure in the statement matches the one from page 1, but it is labeled "Cost of Goods - Satellites." Thus, according to the way the 990 reads, the books, CDs, etc. all cost nothing. It is only the "satellites" that cost anything. That doesn't make any sense to me.

Secondly, there was an increase of \$4.5 million in cost of assets labeled as "Machinery & Equipment" in 2003 in statement 4. Why such a huge jump? Is that where the license is for WDQN? Of course, it wouldn't make sense to call a radio license "machinery" or "equipment." And even if that is where it is, WDQN only cost \$600,000 cash. What was all the other \$4 million spent for in 2003?

I've asked a few people and they don't have a clue.

I'm certainly not an expert in this field, but that does nothing to prevent me having some questions about the data on those 990s. Would someone be so kind as to contribute to my understanding on a few points?

1) Why are the salaries bouncing around so much? What are the variables?

Example: Moses Primo is listed as receiving: \$50,359; \$63,630; \$69,732.14; \$50,818; and UNLISTED for years 2001 through 2005 respectively. You see him increasing until 2004, and then he gets a serious cut in pay of \$19,000. Then, apparently he gets a promotion to a directorship which removes the necessity of listing his salary on the form in 2005. Interesting how he gets "demoted" before he gets "promoted," or am I misunderstanding something here?

Example: Linda Shelton gets: \$117,110 in 2004 as a non-officer, non-director, yet bearing the title of "vice president." In 2005 she gets \$82,922 as a "former" officer/director. Is it just me, or do those figures seem to be inflated above what the separation agreement allowed for? And, how do those numbers relate to her divorce? I remember how the economy took a nosedive after 2001, which likely hit the pocket books of most people the hardest about a year or two later, and has been on the mend since. Public discussion can be healthy for both sides. It ain't going away...like some would wish. So, best to face what's left -- head on. I've found it very helpful.
