It has also come to our attention that you have inappropriately copied and posted a lengthy excerpt from a 3ABN broadcast on the website referred to above. This action constitutes a violation of 3ABN's exclusive copyright on all audio and video productions created by the Network and on all television transmissions of the same, and is a blatant violation of federal law. Moreover, the presence of this excerpted broadcast serves to heighten the likelihood that the public will be confused into believing that your website is somehow sponsored by or affiliated with 3ABN, which only furthers 3ABN's claim of trademark dilution.

Finally, we have been informed that you have maliciously published outrageous, highly damaging and defamatory statements about both Danny Shelton and 3ABN on this same website. These despicable statements include, but are not limited to:

- 3ABN, through its board chairman has "admitted in writing that Danny [Shelton] had been involved in a cover up" of criminal conduct
- Danny Shelton knowingly lied regarding a feud between Tommy Shelton and Glenn Dryden
- 3ABN directed an attorney to use "intimidation tactics to cover up allegations of child molestation"
- Danny Shelton attempted to cover up and silence child molestation allegations
- Danny Shelton "abuses his power" and "steam roll[s] over alleged victims of his brother Tommy's sexual misconduct."

(hereinafter the "Statements").

The obvious meaning of these horrendous falsehoods is that Danny Shelton and 3ABN participated in an orchestrated effort to cover up alleged criminal conduct. The actions you falsely attribute to

our clients would be a crime and, as I am sure you are aware, false accusations of criminal conduct constitute defamation per se by you.

Therefore, on behalf of Three Angels Broadcasting Network and Mr. Danny Shelton, we hereby demand that you immediately cease and desist from the use of the domain name "save3ABN.com" and that you voluntarily surrender and transfer registration of the domain to 3ABN. You are also informed and hereby notified that you are not authorized to use and are, in fact, expressly prohibited from using, Three Angel [sic.] Broadcasting Network's name, or its trademarked nominer "3ABN" in any future website domain name or URL.

We hereby also demand that you immediately remove, from any and all websites to which you have author access, including "www.save3abn.com," any recorded excerpts of any 3ABN broadcasts.

We also hereby demand that you immediately cease and desist from the publication of false statements concerning Danny Shelton and 3ABN and that you immediately remove such statements from the "www.save3abn.com" website. In the event that you receive any inquiries from any person or entity about the Statements, we demand you notify the inquiring party that you have been put on notice by Danny Shelton and 3ABN that the statements are false and defamatory.

While 3ABN is in no manner whatsoever beholden to explain itself to you, we proudly withstand the ongoing judgment of God and the continuing examination by our supporters and viewers. More than ever, we stand behind the legal propriety, moral correctness, intellectual honesty, financial soundness, and operational appropriateness of each and every business decision 3ABN has ever made.

GM: The above appears to me to be "boiler-plate." Of course, U.S. statute law confers copyright status upon this letter. However, the so-called "free-use" provisions of U.S. copyright law govern. Under those provisions I believe that I may reproduce it along with my comments and critique as I am doing here.

Gailon Arthur Joy:

This law firm represents Mr. Danny Shelton and the Three Angels Broadcasting Network, Inc. ("3ABN"), which has informed us that you are involved in the use and exploitation of 3ABN's trademarked, copyrighted name in your website, "www.save3abn.com." Use of 3ABN's name without our client's license or other authorization to do so constitutes an illegal misappropriation of the same, in violation of state and federal copyright and trademark laws. Additionally, use of the phrase "3ABN" in your domain name is likely to cause confusion among the public as to the source,

sponsorship or affiliation of your website, resulting in dilution of 3ABN's trademark, which is a separate and additional violation of federal law.

GM: There are two issues of interest in the above. The first is that this attorney is representing both Danny Shelton and 3-ABN. In so far as Danny Shelton is the President of 3-ABN, there is nothing ethically wrong with this dual representation. Danny has in private communications made statements to the effect that any legal expenses would be picked up by another person with so-called deep pockets [my words]. Again, that is neither illegal, nor unethical. If that person were to have paid for Danny's private legal expenses, those payments might be taxable income to Danny. However, my belief is that such is not currently the case. As President, 3-ABN has the obligation to defend Danny in any action that involves his duties as President.

GM: The second issues relates to the fact that 3ABN is a registered trademark, and has been copyrighted. The comment that such prevents Mr. Joy from using "3abn" in his domain name is subject to challenge. The comment may be correct. If so the court will enjoin future use. However, only litigation will settle that issue. The decision may not be that clear-cut. I will remind everyone that "SDA Kinship" has been allowed by the courts to keep "SDA" in its name contrary to the wish of the General Conference. In any case, if this issue is litigated, I suspect that other "Friend of the Court" briefs will be filed, if allowed.

It has also come to our attention that you have inappropriately copied and posted a lengthy excerpt from a 3ABN broadcast on the website referred to above. This action constitutes a violation of 3ABN's exclusive copyright on all audio and video productions created by the Network and on all television transmissions of the same, and is a blatant violation of federal law. Moreover, the presence of this excerpted broadcast serves to heighten the likelihood that the public will be confused into believing that your website is somehow sponsored by or affiliated with 3ABN, which only furthers 3ABN's claim of trademark dilution.

GM: U. S. copyright law governs here. This is not as clear-cut as it may seem. Under "fair use" one is generally allowed to copy a copyright product for the purpose of commenting and critiquing it. Should the court decide that was the intent, it just might be that 3-ABN would not be able to enjoin such use. It is the same principle that allows me to place "3-ABN" and "3ABN" in my posts.

Finally, we have been informed that you have maliciously published outrageous, highly damaging and defamatory statements about both Danny Shelton and 3ABN on this same website. These despicable statements include, but are not limited to:

It should be noted that truth is not an absolute defense against such claims. The potential exists for the court to find the charges true, and still find in favor of the plaintiffs. However, that can only be determined by litigation. The question now becomes: Does any plaintiff want to be subject to the discovery that would take place in such litigation. And, if proven true, that might bar recovery of damages. The results of such litigation are simply not predictable.

Therefore, on behalf of Three Angels Broadcasting Network and Mr. Danny Shelton, we hereby demand that you immediately cease and desist from the use of the domain name "save3ABN.com" and that you voluntarily surrender and transfer registration of the domain to 3ABN. You are also informed and hereby notified that you are not authorized to use and are, in fact, expressly prohibited from using, Three Angel [sic.] Broadcasting Network's name, or its trademarked nominer "3ABN" in any future website domain name or URL.

GM: We now enter a field of law that is developing in regard to domain names. I believe that case law might be cited on both sides of this question. It may be that the plaintiff will be willing to litigate in the hope of further establishing a body of case law? Again, the result of litigation uncertain.

Let me give you-all an illlustration of "fair use" right out of real life:

Several years ago I became aware of a writer who published weekly on the Internet, and in print media. His mission in life was to post Christian art, and then make fun of it, the person who prioduced it, and those who beleived in Christ. It was more narrowly focused in Christ himself. Regularly he posted art from SDA publications, such as books by A.S. Maxwell, and other. Yes, he did this after Maxwell's death. He would have a field day in making fun of Maxwell and the item of art that he had published that week. Again, he would focus on the Christ figure in the art.

I took the evidence to the General Conference for violation of copywight. They infomed me that his use of copyrighted SDA art was included in the "fair use" doctrine and they could do nothing about it. He had the legal right to reporduce, in full, that SDA art.

The same principles apply to my use of that letter, and my posting it.

Alethia, there are other legal reasons why I will suggest that I was free to do so. But, if you want the full story, I will advise you to consult an attorney who specialized in copyright issues. I am not here to instruct you in the law.

Danny has in private communications made statements to the effect that any legal expenses would be picked up by another person with so-called deep pockets [my words]. Moreover, the presence of this excerpted broadcast serves to heighten the likelihood that the public will be confused into believing that your website is somehow sponsored by or affiliated with 3ABN, which only furthers 3ABN's claim of trademark dilution.

GM: U. S. copyright law governs here. This is not as clear-cut as it may seem. Under "fair use" one is generally allowed to copy a copyright product for the purpose of commenting and critiquing it. Should the court decide that was the intent, it just might be that 3-ABN would not be able to enjoin such use. It is the same principle that allows me to place "3-ABN" and "3ABN" in my posts.

Finally, we have been informed that you have maliciously published outrageous, highly damaging

and defamatory statements about both Danny Shelton and 3ABN on this same website. These despicable statements include, but are not limited to:

- 3ABN, through its board chairman has "admitted in writing that Danny [Shelton] had been involved in a cover up" of criminal conduct


