Barbara asked me to post this letter from Norway:

Dear Friends,

A lot has happened in the last several months and I need to write a quick letter and let you know what's happening with me.

The past three years have been fairly stressful for me, but this past year has been the worst. We had two people living in our house, and there was the 3abn mess that was heating up (and is still going strong), and I was still in the middle of it. There were other things that just happened. You know, just life.

Well, this past summer I didn't feel right. I knew I was sick again and that my body was out of whack. I just felt really bad. Not crohn's per se, but just not right. I started juicing again, walking everyday, etcetera, etcetera. Nothing really helped completely. I knew my pH was extremely acidic when I bit into a cherry tomato and my mouth broke out into blisters. I began monitoring my pH everyday, only to find that is was continuously between 5.0 and 6.0. A normal range for a healthy person is around 6.6 to 7.0 (urine & saliva).

I was so stressed over what was happening at 3ABN, and the lies that they were continuing to tell. I would try to read the dialog on BSDA and keep up with what was happening, only I continued to feel worse each time I would read some sickening account of discovery in the Shelton household. I wanted to participate in your conversations, but I just had to quit reading after a while. I had to protect myself, and I knew the added stress was making me worse. I hope you will understand.

In September, I flew to Washington State where Linda Shelton and I attended the same conference. It was the first time we had seen each other in a year and a half. We shared a room for a couple of days and got all caught up on our 'girl talk'. We had a great time laughing and reminiscing about 'the good old days'.

So many of you have asked me to pass along your love and good wishes, and that is exactly what I did! She thanks each of you from the bottom of her heart for all of your prayers, your love and your support! She misses you and she misses working in ministry more than I can ever express in words. Her heart is broken over what has been taken away from her. We cried together and we prayed together.

I encourage her every week on the phone that God still has a purpose for our lives. That He can bring something beautiful our of this mess, . . . and most of all, that He hasn't forgotten His girls. We love Him so much. I tell her over and over again, that God did not give her 20 years of experience, running a Christian Network, just to let that training go unused. I can't help but cry now, just thinking about the despair that she feels. Please, please, join me in praying that God will set the oppressed free, and reveal every secret thing!

While we were in Washington, Linda's house was broken into. The only things stolen were emails and papers concerning 3ABN. One document was left behind. A legal paper that had to do with her demise at 3ABN. Her signature was forged. Darrell Mundalls car was broken into the same week. He had two computers in the back seat, both were left there, but papers and things were scattered throughout the car.

I told her the stakes seemed higher now. They were acting more desperate for evidence to prove they were right. We don't know who broke into the house and car, but it seemed fishy to us. In October I started having female problems which drove me to the Gyn. From there, I saw other specialists and a surgeon, all of which only promised me disfiguring surgery. By the end of October I began feeling nauseated from the time I got up until I went to bed at night. I saw a gastroenterologist and had an endoscopy.

My Gyn kept pushing me to have surgery, he was sure I had cancer in my labia and wanted to remove it immediately. I was also diagnosed with a blood vessel disorder.

Linda Shelton encouraged me to see the Norwegian doctor (Arild Abrahamsen) that had treated her son. They call him the Miracle Doctor here in Norway. He also treats many famous European athletes from every sport imaginable. Just Wednesday I was sitting next to two young men from Sweden that were Olympic cross country skiers. One was named Peter Larson and the other Mat (something). I asked them all kinds of questions about what it's really like to train for the Olympics everyday. I also asked them why they come here. They smiled and said that no matter what their problem, virus or broken bone, the healing time with this treatment was less than half and they couldn't afford downtime.

The Swedish Olympic trainer came to see Dr. Abrahamsen a few days ago and asked him if he would treat and monitor his entire team during training. Dr. Abrahamsen is so swamped with patients, he has a one-year waiting list to be seen as a new patient. He's not even sure he will take on the Olympic cross-country ski team.

Getting back to the original story. I told my Gyn I wanted to try something natural since they had ONLY promised disfiguring surgery, and he pushed back in his chair and said, 'I get all kinds of strange patients, with all kinds of strange ideas!' He was pretty mad. I just looked at him and asked him nicely, 'if I was the doctor and I told him all I could promise him was to cut off his testicles, but he knew of a possible other way, wouldn't he try it?' He just looked at me disgusted and walked out. Some people are very narrow minded when it comes to complementary medicine. I'm NOT stupid either, and I have a right to alternative treatment. I hadn't told him I wouldn't have the surgery, . . . I just wasn't going to have it as my first option.

Just so you know, I have cancer in 4 places. Three female and in my stomach. I decided at Linda's prompting to go to Norway before undergoing the knife. There are several reasons why I came to this doctor to be treated, but honestly, at the end of the day the entire thing was one great, big, divine appointment.

Dr. Abrahamsen (a general practice doc for 30+ years) got tired of treating sickness and wanted to be a wellness doc. About 15 years ago he was trained with new technology. He was also a friend of a friend. I had never met him before and was actually a bit leery of him.

At the exact same time I was really feeling sick and starting to go see specialists (oct/nov), Abrahamsen came across a newspaper article written by researchers stating that they had found an enzyme that was present in every cancer cell, no matter the type of cancer. The enzyme is called `CASPASE - 3`. Anyways, the scientists speculated that if they could find a way to activate this de-activated enzyme, they thought the body would rid itself of cancer.

Doctor Abrahamsen completely agreed. He immediately set to work, and within a short period of time, he found a combination of remedies that would activate the enzyme.

This doctor's brother has had Hogkins or non-hogkins for 3 or 4 years now. He was one of the first people treated in November. After one week of treatment he was cancer free. I know of one more patient, a lady who came to him with bloody discharge from her breast and breast cancer. She was cancer free after 6 treatments.

I was re-tested Sunday afternoon (January 28th, 2007) and I am happy to report that I, too, am now cancer-free! I asked him why it has taken me so much longer (I've received 21 treatments now) than his brother and the other woman, and he told me that my cancer was much worse than theirs.

Now that the cancer level is at zero, he will begin treating my candida, fungus and thyroid problem. I'm not coming home until I'm well, but hopefully that will be at the end of Feb. I flew here Jan.4th.

All I can tell you about what the treatments are, is that they are all natural, and they are always given I.V. Treatment days are Monday, Tuesday and Wednesday. I receive two I.V.'s per day. I feel soooooooo much better now than when I arrived in early January. I feel like I did before I got sick this summer.

The treatments are a little bit pricey. The initial test, which takes about 2 - 3 hours, costs \$750. After that, the I.V. treatments are \$150 each. It's around \$900 per week, but oh how sweet it is to be CANCER FREE!

Last week I asked the doc if he was excited about this discovery and what it could mean to the world? He said it was much too early to be excited about it, because it would require a lot more testing on patients with different kinds of cancer to see how it would work. He also didn't think it would work well on patients with brain tumors, due to the blood-brain-barrier, but he hasn't treated anyone with a brain tumor yet to see how they respond to it. He won't be making any claims anytime soon. (Although I feel a Nobel Prize coming on - for him, not for me) LOL- laugh out loud

I personally think this discovery is exciting. I just want to burst with the news. To be honest though, I wasn't going to share this story with the public, because it was, once again, so personal. Then two days ago God really dealt with me harshly, and kept bringing me to Esther chapter 4, verse 14. ``For if you remain completely silent at this time, relief and deliverance will arise for the Jews from another place, but you and your father's house will perish. Yet who knows whether you have come to the kingdom for such a time as this?''

I would rather listen and obey, then cower with embarrassment. There are too many people hurting in this world to keep this information to myself. I wasn't sure what to think of Arild Abrahamsen before I met him. There was so much controversy around him and accusations from Danny Shelton. But after meeting this man, I had to chuckle inside about what a poor choice Danny had made, picking on this doctor. You only need to meet him to see it. He is filled with integrity, honesty and compassion for his patients. I would liken Abrahamsen in character, to that of Mark Finley or Doug Bachelor! I'm not afraid of him anymore, or leery, . . . I'm proud to call him a friend, and consider him one of the greatest doctors I have had the privilege of meeting.

God is blessing Abrahamsen with the gift of healing. True, it's not the science we grew up with in school, biology class, or nursing school, and it DOES require a shift in your paradigm to understand his technology, but God is blessing Abrahamsen's work, none-the-less!

It is kind of strange though. Here I am receiving treatments to save my life and all I can think

about is how blessed I am. I'm not the sickest person in the U.S., and yet Gods' timing with this cure is so incredible! I have moments of feeling guilty. I feel the Lord's hand over me, under me, and around me, everywhere I go.

There is a purpose for me here in this foreign land and I continue to pray that God will use my life in a mighty and powerful way to help others receive life.

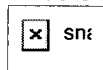

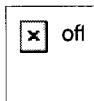

Normal procedures would state that a Purchase Order be prepared for everything. This would even mean for traveling. There is a need travel, lodging, transportation and per diem (food) can be processed in several ways.

1. The person needing to travel, at 3ABN's expense, produces a Purchase Order (PO) stating where they are going and the times they need to travel and turns it in. Management approves/disapproves the travel. The purchasing department then books the arrangements/reservations and puts the quoted price on to the PO. This is the approved amount that will be paid/reimbursed; no less, and no more.
2. Many corporations have turned to corporate credit cards. If 3ABN pays the approved amounts to the vendor, there will never be any black holes. The traveler will be responsible for any upgrades desired right then and there.
3. Remember this, if a door is left open, someone WILL walk through it. It happens every time!



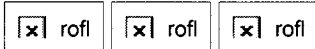

Is there a way to post a picture inside one of these messages? If so, I would be happy to share a picture or two of my adventures here in Norway.



I almost laughed when I realized the water inside had already formed ice crystals. I can honestly say this has never happened to me in South Carolina!

I made my way to the clinic at 3p.m. to be tested. Peter Larson, the Swedish Olympic Cross-Country Skier was also there receiving a treatment. We visited for about 30 minutes while our I.V.'s ran, and this time I was smart enough to ask him for his autograph. He gave me four signed picture cards. What a joy it was to read all of your lovely comments tonight when I got back to my apartment! Thank you for all of your great ideas. Panama Pete, I will try to go online tomorrow and check out some of those websites you recommended.

I actually drew up plans to build a studio on our property in August of 2005. That was when we started the paperwork to become non-profit. Everything just costs sooooo much money, though. To build, equip, and run a studio will cost approximately one million dollars. My husband and I have been over every possible scenario. Some have suggested that I travel by plane and tape programs in their studios.

*The problem for me trying to put together a series of cooking shows and travelling, is just how difficult it is to cart food and dishes, etcetera, to another state. The planning is simply a nightmare. Lately, I've been leaning towards the idea of expanding my own kitchen and dining room by 20 or 25 feet. I could push out one wall and totally renovate the kitchen to function as a cooking studio. I could also build a small master control room in the added space.*

By building the studio into my existing home, I save money by not having to stock a new kitchen with dishes and cooking equipment, as I already own most things needed, and I save by not having to heat and aircondition a separate building. I could rent or lease camera equipment in the beginning, and, . . . and, . . .and, . . . I just get so excited when I start thinking about producing shows again.  Please join me in making this a matter of prayer. I want to do what God wants me to do.

Two days ago, I received ANOTHER email from someone in India. They have been asking and asking, for several months now, to air my cooking programs on cable T.V. They want the health message. DO YOU KNOW HOW MUCH IT BREAKS MY HEART TO TELL THESE PEOPLE THAT I HAVE NO RIGHTS TO AIR MY OWN PROGRAMS?! THAT 3ABN REFUSES TO DONATE MY VIDEOS, AND THE

RIGHTS TO USE THEM, TO MY MINISTRY? I FEEL LIKE MOSES STANDING BEFORE PHARAOH EVERY TIME I ASK DANNY TO LET MY VIDEOS GO. He either completely ignores my question or he says 'no'.

I came to the conclusion several months back that it is not my job to persuade Danny to donate my videos, that is God's job. God is in control and if I am to have them, then it will happen. His timing is always perfect, . . . even if it is in the eleventh hour!

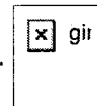

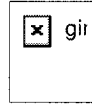

This will be short as it is extremely late here in Norway and I need to get to bed. I can maybe give a more detailed answer tomorrow.

In regards to my tapes:

1) I did have a generic written contract with 3ABN in regards to my tapes. Because *3ABN Presents* was their 'flagship' program as they called it, ONLY 3ABN could have rights to ownership with those shows. I signed one contract when I first began taping in 1997, and then refused to sign any more contracts regarding ownership, until they forced me to in 2003.

\*Every guest that goes to 3ABN is sent a packet with questions and guidelines. You are asked to fill out the paperwork, sign the contract, and return it to the office prior to taping. After my first visit, I would just show up without signing anything and taped my programs.

Finally in the Summer or Fall of 2003, they cornered me, and told me that if I didn't sign the contract, that they would no longer air any of my programs and I would not be invited back as a guest ever again. I signed the contract under protest, but I did sign it -- one more time.

2) I was NOT compensated in any way for creating recipes and taping programs for them. Twice I was given a love offering of \$150. It was either the second or third year that I taped there. Once I was given an ink pen as a Christmas gift with 3ABN's name on it.

I was asked to create and tape programs there approximately every other month, all year long. It was like a full time job. I learned a lot at 3ABN and my deadlines caused me to put my cookbooks together. (Taste Of Health, Volumes 1 & 2) I am very grateful for all of the hands-on training I received. I am especially grateful to Bobby Davis who is an outstanding producer and good friend.

I worked for free for seven years. I loved helping others, and I had promised God that that is what I would do for the rest of my life. It was a labor of love and came with its own rewards. Rewards that I tell people, *'are out of this world'!* The sale of my cookbooks has been the only means of income to my ministry. [www.tasteofhealth.net](http://www.tasteofhealth.net)

3) I have always known that 3ABN would have the rights to my programs. That's the way the cookie crumbles! But everything changed in 2004 when I asked Dan (and Linda) tough questions.

When my cooking programs were suddenly *not of any use to 3ABN or Danny*, just because Linda appeared on them, it was as if my ministry disappeared over night. In my opinion, **their divorce wasn't a good enough reason for the health message I had worked so hard to bring to the world, to suddenly be disposed of.**

I personally feel like the Shelton's divorce, and Danny's dislike of me because I refused to turn my back on my friend, IS NOT A GOOD ENOUGH REASON TO LOCK UP SEVEN YEARS WORTH OF HARD WORK! He is my master, my friend and my defender.

Linda Shelton encouraged me to see the Norwegian doctor (Arild Abrahamsen) that had treated her son. They call him the Miracle Doctor here in Norway. He also treats many famous European athletes from every sport imaginable. Just Wednesday I was sitting next to two young men from Sweden that were Olympic cross country skiers. One was named Peter Larson and the other Mat (something). I asked them all kinds of questions about what it's really like to train for the Olympics everyday. I also asked them why they come here. They smiled and said that no matter what their problem, virus or broken bone, the healing time with this treatment was less than half and they couldn't afford downtime.

The Swedish Olympic trainer came to see Dr. Abrahamsen a few days ago and asked him if he would treat and monitor his entire team during training. Dr. Abrahamsen is so swamped with patients, he has a one-year waiting list to be seen as a new patient. He's not even sure he will take on the Olympic cross-country ski team.

I decided at Linda's prompting to go to Norway before undergoing the knife. There are several reasons why I came to this doctor to be treated, but honestly, at the end of the day the entire thing was one great, big, divine appointment.

Dr. Abrahamsen (a general practice doc for 30+ years) got tired of treating sickness and wanted to be a wellness doc. About 15 years ago he was trained with new technology. He was also a friend of a friend. I had never met him before and was actually a bit leery of him.

**At the exact same time I was really feeling sick and starting to go see specialists (oct/nov), Abrahamsen came across a newspaper article written by researchers stating that they had found an enzyme that was present in every cancer cell, no matter the type of cancer. The enzyme is called `CASPASE - 3`. Anyways, the scientists speculated that if they could find a way to activate this de-activated enzyme, they thought the body would rid itself of cancer.**

Doctor Abrahamsen completely agreed. He immediately set to work, and within a short period of time, he found a combination of remedies that would activate the enzyme.

Yet who knows whether you have come to the kingdom for such a time as this?''

I wasn't sure what to think of Arild Abrahamsen before I met him. I would liken Abrahamsen in character, to that of Mark Finley or Doug Bachelor! I'm not afraid of him anymore, or leery, . . . I'm proud to call him a friend, and consider him one of the greatest doctors I have had the privilege of meeting.

I'm not the sickest person in the U.S., and yet Gods' timing with this cure is so incredible! I have moments of feeling guilty. I feel the Lord's hand over me, under me, and around me, everywhere I go.

Hi Everyone,

This will be short as it is extremely late here in Norway and I need to get to bed. I can maybe give a more detailed answer tomorrow.

In regards to my tapes:

1) I did have a generic written contract with 3ABN in regards to my tapes. Because *3ABN Presents* was their 'flagship' program as they called it, ONLY 3ABN could have rights to ownership with those shows. I signed one contract when I first began taping in 1997, and then refused to sign any more contracts regarding ownership, until they forced me to in 2003.

\*Every guest that goes to 3ABN is sent a packet with questions and guidelines. You are asked to fill out the paperwork, sign the contract, and return it to the office prior to taping. After my first visit, I would just show up without signing anything and taped my programs.

Finally in the Summer or Fall of 2003, they cornered me, and told me that if I didn't sign the contract, that they would no longer air any of my programs and I would not be invited back as a guest ever again. I signed the contract under protest, but I did sign it -- one more time.

2) I was NOT compensated in any way for creating recipes and taping programs for them. Twice I was given a love offering of \$150. It was either the second or third year that I taped there. Once I was given an ink pen as a Christmas gift with 3ABN's name on it.

I was asked to create and tape programs there approximately every other month, all year long. It was like a full time job. I learned a lot at 3ABN and my deadlines caused me to put my cookbooks together. (*Taste Of Health, Volumes 1 & 2*) I am very grateful for all of the hands-on training I received. I am especially grateful to Bobby Davis who is an outstanding producer and good friend.

I worked for free for seven years. I loved helping others, and I had promised God that that is what I would do for the rest of my life. It was a labor of love and came with its own rewards. Rewards that I tell people, '*are out of this world!*' The sale of my cookbooks has been the only means of income to my ministry. [www.tasteofhealth.net](http://www.tasteofhealth.net)

3) I have always known that 3ABN would have the rights to my programs. That's the way the cookie crumbles! But everything changed in 2004 when I asked Dan (and Linda) tough questions.

When my cooking programs were suddenly *not of any use to 3ABN or Danny*, just because Linda appeared on them, it was as if my ministry disappeared over night. In my opinion, **their divorce wasn't a good enough reason for the health message I had worked so hard to bring to the world, to suddenly be disposed of.**

I personally feel like the Shelton's divorce, and Danny's dislike of me because I refused to turn my back on my friend, IS NOT A GOOD ENOUGH REASON TO LOCK UP SEVEN YEARS WORTH OF HARD WORK! If 3ABN no longer has use for the tapes, then why not let me have the rights and use of my programs? The Lord is the one that called me to labor in this field. He is my master, my friend and my defender.

It just seems to me, that if 3ABN and I are REALLY working on the same side (to win souls to the



kingdom), and they have no more use for the programs, then they shouldn't have a problem AT ALL with allowing me the use of these shows to win souls in India and China, and wherever God leads me.

Please feel free to contact the board members, have petitions signed by church members and sent to 3ABN, start an email campaign. Just do whatever it is that God impresses you to do. Every letter, and every prayer sent up to our Father in Heaven helps!

God bless and thanks for rallying behind me.

Well, on the surface, it appears to me that 3-ABN owns the rights to Barbara's programs, and can do with them as it pleases.

However, that issues may be more complex than I understand. I believe there is a body of law that applies to programs produced for television, in regard to future useage by others. But, that is outside of my reading interests.

So, my only piece of advice is: Barbara, if you wish to learn what legal rights you have you should consult an attorney competent in this area of the law.

On the assumption that 3-ABN owns the rights, the issue now is: Does 3-ABN wish to score a major PR coup by releasing the tapes to Barbars at no charge?

I will suggest that an accomadation could be reached, if Barbara and 3-ABN wanted to do so. That accomodation might be a statement added to each tape that gave credit to 3-ABN, and thanked 3-ABN for releasing its property to Barbara.

That would be a win, win, situation for all.
