Established Facts & Timeline of Those Established Facts (Information Topic)

## The following are facts and established timelines of those established facts:

- 1. On December 27, 2003 Elder Johann Thorvaldsson and his son picked up Dr. Arild Abrahamsen at the St. Louis Airport.
- 2. On December 28 or 29, 2003 Elder Johann Thorvaldsson and his wife took Dr. Arild Abrahamsen to the cafeteria in Thompsonville where they met Danny and Linda Shelton. (Note: Linda Shelton came frequently to see Elder Johann Thorvaldson and his wife before this, and she continued her visits after Dr. Arild Abrahamsen came. Like any other good mother, Linda was always thinking of what could be done to help her son, Nathan, and Nathan liked Arild and wanted to get some treatments from him in Norway. Those meetings took place in Elder Thorvaldsson's apartment).
- 3. Around January 20, 2004 Nathan came to Norway along with his friend, Dava Vice.
- 4. The first week of February, 2004 Linda came for a 3-½ day visit to support her son, together with Brenda Walsh.
- 5. On March 7, 2004 Linda Shelton was accused of spiritual adultery with a doctor, (Dr. Arild Abrahamsen), in Norway, because she spoke with this near stranger on the phone. This was taken from Linda Shelton's website.
- 6. During the months of April 2004 and May 2004, Linda Shelton was suspended from her job at 3ABN, as stated in Linda Shelton's website.
- 7. About May 1, 2004 instructions were given to the production staff to wipe Linda Shelton's face off of the network by June 1, 2004, again with no Board action.
- 8. A few days later in reference to about May 1, 2004, Linda Shelton was sent a document specifying that she was advised to get 30 days of counseling by counselors of their" choice. If she did not agree to this in writing within 24 hours, her employment could be gone. She requested time for an attorney to look at the document. This was refused.
- 9. Either on May 23, 2004 or May 30, 2004 Linda Shelton was voted out as Vice-President, Secretary and as a Board member, as stated on Linda Shelton's own website.
- 10. On May 28, 2004 when Elder Johann Thorvaldsson was at West Frankfort, he was told by the 3ABN attorney, Nick Miller, that the labour laws did not apply in Linda Shelton's case according to the laws in Illinois. There the President had the full right to dismiss his Vice-President whenever he so desired.
- 11. On May 30, 2004 the 3ABN Board of Directors removed Linda Shelton from her role as Vice-President and as a board member, as stated in Dr. Walt Thompson's first

open letter of July 2004, which began with "Dear 3ABN Family."

- 12. Also on June 1, 2004 Danny Shelton and Linda Shelton separated, as stated on Linda Shelton's website.
- 13. Soon after June 1, 2004 Linda Shelton was discontinued as an employee of 3ABN.
- 14. On June 4, 2004 a separation agreement between 3ABN and Linda Shelton was signed.
- 15. The divorce of Danny Shelton and Linda Shelton was effective on June 21, 2004. (Note: Aletheia states in her post that the uncontested divorce was finalized on June 21, 2004).
- 16. In July, 2004 Brandy Elsworth arrived at 3ABN.
- 17. On February 8, 2005 Linda Shelton files to contest the divorce in Franklin County, Illinois seeking a larger marital settlement, as Illinois is not a community property state as Guam was.
- 18. On March 7, 2005 Walt Thompson (3ABN's Chairman wrote to Elder Johann Thorvaldson) "So far as accusing Linda of adultery, I will say here again in writing that I have never accused Linda of adultery."
- 19. On March 6, 2006 the court in West Frankfurt, Illinois declared the Guam divorce valid in Illinois.
- 20. On March 7, 2006 a marriage license was issued to Mr. Danny Shelton and Ms. Brandy Elswick, one day before the wedding.
- 21. On March 8, 2006 Danny Shelton and Brandy Elswick were married at 3ABN.
