It has come to my attention that you have been contacting other attorneys who represent 3ABN and Danny Shelton and asking them questions about this litigation which we regard as repetitive and irrelevant. This is causing unnecessary disruption and expense to my clients.

From this point forward, any communication or questions that you wish to direct to 3ABN and Danny Shelton, or any of their attorneys, should be directed to me and only me. I will be the only person who communicates with you on behalf of the Plaintiffs/Appellees. If you send any communications or inquiries to the other attorneys, they will be forwarded to me for response. We reserve the right to ignore your communications if they continue to be repetitive and irrelevant.

With respect to your questions about the MidCountry Bank records, I have stated the relevant information in my affidavit. Unless you can articulate a reason that makes a modicum of sense about why you need to know anything at all regarding the internal workings among co-counsel for the Plaintiffs/Appellees, we will not provide any additional information. I repeat, for at least the third time, that the documents are in my possession and are in the same condition as when they were retrieved from Magistrate Judge Hillman pursuant to Judge Saylor's order. They will remain in that condition at least until the appeal is concluded. This concludes our dialogue on this topic.
