<u>DEFENDANT, THREE ANGELS BROADCASTING NETWORK, INC.'S</u> MOTION TO DISMISS FOR LACK OF SUBJECT MATTER JURISDICTION

COMES NOW defendant, THREE ANGELS BROADCASTING NETWORK, INC. (hereinafter 3ABN), by and through its attorneys, JOHNSON & BELL, LTD, and as and for it's MOTION TO DISMISS PLAINTIFF'S COMPLAINT, pursuant to Federal Rules of Civil Procedure 12(b) (1) for lack of subject-matter jurisdiction, and 12(b) (6) failure to state a claim upon which relief can be granted, states as follows:

Plaintiff asserts a federal question exists based on co-defendant, Tommy

Shelton's alleged travel in interstate commerce for the purpose of engaging in illicit sexual conduct with a minor in violation of 18 U.S.C §2423. (See Plaintiff's Complaint,

Count IV). Illicit sexual conduct with a person under 18 years of age as used in §2423 is defined in section 2246. The allegations of sexual abuse contained in the complaint do not meet the definition of a sexual act set forth in § 2246. Therefore Count IV fails to state a valid cause of action and it must be dismissed. The dismissal of Count IV defeats federal court Jurisdiction and therefore the entire action must be dismissed. Moreover,

Count IV was not filed within the applicable statute of limitations for civil actions

brought pursuant to 18 U.S.C §2423 and Count IV is subject to dismissal on that alternative basis, again resulting in the dismissal of the entire Federal Court action.

A separate Memorandum in Support of this Rule 12(b) Motion to Dismiss is submitted herewith.

WHEREFORE, defendant, THREE ANGELS BROADCASTING NETWORK, INC. respectfully requests that this Honorable Court dismiss Plaintiff's Cause of Action pursuant to Federal Rule of Civil Procedure 12(b) (1), or 12 (b) (6).
