**DEFENDANTS’ MOTION FOR LEAVE TO CAUSE SUBPOENA TO BE SERVED UPON
A PORT DIRECTOR OF U.S. CUSTOMS AND BORDER PROTECTION OR OTHER
APPLICABLE OFFICER OR AGENCY OF THE UNITED STATES GOVERNMENT,
AND DEFENDANT’S MOTION FOR LEAVE TO CAUSE SUBPOENA TO BE SERVED
UPON THE KEEPER OF THE RECORDS AT DELTA AIRLINES**

Though no leave is required for the Defendants to serve subpoenas, yet because a motion is pending on the issue of serving third-party subpoenas, Defendants Gailon Arthur Joy and Robert Pickle seek leave of the Court to serve subpoenas *duces tecum* upon a Port Director of U.S. Customs and Border Protection or other applicable officer or agency of the United States government, and upon the keeper of records at Delta Airlines.

The Plaintiffs and their allies have repeatedly asserted that Linda Shelton had an affair with Dr. Arild Abrahamsen (hereafter “Abrahamsen”) of Norway, and that this affair gave Danny Lee Shelton (hereafter “Shelton”) biblical grounds for divorce and remarriage. The grounds for Shelton’s divorce and remarriage as well as Linda Shelton’s termination have been put at issue in this controversy by the Plaintiffs.

Key to these questions is the number of times Abrahamsen and Linda Shelton

rendezvoused before and after Shelton's divorce of Linda Shelton on June 25, 2004. The Plaintiffs have made very specific claims as the timing and number of these rendezvous.

Of particular interest is an alleged rendezvous in Florida in April 2004 which Brenda Walsh (hereafter "Walsh") and 3ABN Board chairman Walter Thompson (hereafter "Thompson") claimed actually took place.

Verification that Abrahamsen was in the United States at the times that Walsh, Shelton, and Walter Thompson have claimed, and that Walsh's ticket for the planned April 2004 trip to Florida was never used but Linda Shelton's ticket was used (as claimed by Walsh), speak not only to these key questions in the litigation but also to the veracity of these individuals. Such verification also speaks to the issues of whether 3ABN has paid for airfare for personal vacations, and whether the Plaintiffs come to this Court with unclean hands, having spread rumors about Linda Shelton that are defamatory *per se*.

WHEREFORE, the Defendants pray the Court to grant leave to cause subpoenas *duces tecum* to be served upon a Port Director of U.S. Customs and Border Protection or other applicable officer or agency of the United States government, and upon the keeper of records at Delta Airlines, for the purpose of determining the entry and exit dates of Abrahamsen on his trips to the United States from September 2003 through the end of 2004, for the purpose of determining the disposition of the tickets that Walsh reserved on March 4, 2004, including any tickets the original tickets were exchanged for, and for the purpose of determining any planned or actual travel by Linda Shelton on Delta Airlines from February 6, 2004, through the end of 2004.
