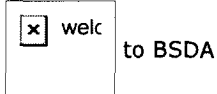

While I am a newbie to posting, I am NOT a newbie to reading.... (I've been reading BlackSDA since June/July of 2006) There is **no substitute** for reading yourself. Personally, I found that the "fictional" accounts can be helpful to pull together a picture which allows you to clearly see where some are coming from, however I do not find them as evidence of anything.

Let me give a brief summary of my journey to illustrate my position.... I hope that some of my comments will be beneficial to someone.

When I first heard that there were problems at 3abn, I didn't have any idea who or what to believe. When I saw the broadcast of 3abn campmeeting, and heard Danny plea for prayer for Linda to return, I felt truly awful for "poor" Danny.

Then I heard about the "spiritual adultery" - and found NO biblical basis for divorce based on that reason. Saying that it is acceptable to divorce someone because they are involved in behavior that can lead to adultery is like saying that when the doctor's diagnosis comes back "positive", we'll go ahead and hold the funeral and bury them... why? because there's a good chance that they're going to die anyway!

I found Linda's website via Google, and was highly suspicious when I read the contract posted there... The result of that reading, was that I was put in a position of limbo.
